Dear Ms. Daniel:

We are in receipt of your claim for damages in the amount of \$600.00 for electrical work done at your property, after a fallen branch from a tree located on City –owned property fell on the electric line at your property at 4744 North Parkway Avenue on December 16, 2021.

Our investigation revealed that on December 16, 2021, the City of Milwaukee Forestry Department was notified by the Department of City Development that a large branch from a tree located on City-owned property at 4750 North Parkway Avenue had fallen. A City of Milwaukee Forestry technician responded and found the large branch had fallen on a car parked at 4750 North Parkway Avenue, and onto your property at 4744 North Parkway Avenue. There were no visible signs of decay to the exterior of the tree, however there was internal decay at the failure point. The tree was referred to Asplundh Tree Experts, and they agreed to remove the tree the next day.

On December 17, 2021, a crew from Asplundh removed the downed limb, however they did not have the right equipment with them to remove the rest of the tree that day, and the rest of the tree was scheduled for removal at a later date.
