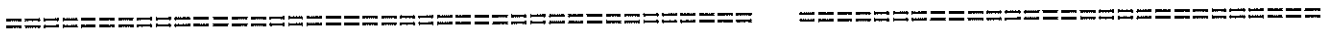



This license premise report was written by P.O. Brian LaROQUE, assigned to District Seven, Late Power Shift. On Thursday, November 5, 2015 at 9:00pm I was working as Desk Officer when an American United Cab (#149) being operated by driver Leon Q WILLIAMS III (B/M, 12/18/80) pulled up in front of the District (3626 W Fond Du Lac Av) where WILLIAMS III did engage in a verbal altercation with his passenger, Karissa AP BRADLEY (B/F, 11/1/90) who was in the vehicle with her 1-year-old child.

WILLIAMS III and BRADLEY were separated so that we could conduct our investigation. During this time I was in full Milwaukee Police Department uniform and acting in an official capacity. I told BRADLEY I would call her a new cab to take her where she needed to go and that we would retrieve her property from WILLIAMS' III vehicle. At which time WILLIAMS III stated that he would call his dispatch from his vehicle and I informed me that would be fine and that I would come out there to remove BRADLEY'S property. Prior to me exiting the District WILLIAMS III started his vehicle and left westbound on W Fond Du Lac Av from the district disregarding my original instructions and obstructing my investigation.

I called American United Taxi and informed them to instruct WILLIAMS III to return to the location because BRADLEY had property in the trunk and back seat. WILLIAMS III did return to the District but stated that he did not have her property and opened the trunk and I observed it was empty. I did retrieve BRADLEY'S laundry soap, which was in the back seat of the vehicle. I later learned from BRADLEY that she returned to the laundry mat where an unknown citizen observed a cab driver drop off two large garbage bags of clothing outside of the building. The clothing was turned into the laundry mat attendant and later returned to BRADLEY.

WILLIAMS III was taken into custody and cited for Disorderly Conduct, Obstruction, Fail to Exhibit PPV License, and PPV Driver's License required. WILLIAMS III does not have a valid WI driver's license but does have a valid Class E license in FL.

During the investigation BRADLEY stated that she was concerned in the cab because WILLIAMS III was playing his music loudly and almost left the location with her 1-year-old child in the back seat while she was attempting to load clothing in the trunk. BRADLEY also stated that WILLIAMS III was rude to her and that he told her that he was a "Hood Nigger" which made her feel uncomfortable because she believes that is a type of threat. It should be noted that WILLIAMS III did not make any statements towards BRADLEY that he was going to harm her in any specific way. Below is the narrative used for the citations issued.

#### NARRATIVE FOR CITATIONS ISSUED:

This report was written by P.O. Brian LaROQUE, assigned to District Seven, Late Power Shift. On 11/5/2015 at 9:00pm I was working at District Seven (3626 W Fond Du Lac Av in the City and County of Milwaukee) as Desk Officer when Leon Q WILLIAMS (B/M, 12/18/80), a cab driver, came into the district after having a problem with a passenger in his vehicle. WILLIAMS engaged in a loud and verbal altercation with Karissa AP BRADLEY (B/F, 11/1/90). WILLIAMS and BRADLEY were separated and WILLIAMS then disregard uniformed officer's instructions and walked back to his vehicle and left the location with property in the vehicle belonging to BRADLEY. I called the cab company (American United Cab) and instructed them to have WILLIAMS return to the location. When WILLIAMS returned the property belonging to BRADLEY was not in the vehicle. BRADLEY would later locate the property at the laundry mat where WILLIAMS picked her up. The clerk informed her that a pedestrian brought the laundry bags back inside of the laundry mat after a cab driver dropped it off outside. WILLIAMS was operating the cab without a valid WI driver's license and did not have his public passenger vehicle license exhibited in the vehicle. WILLIAMS was taken into custody and processed at District Seven.
