

Dear Ms. Korth:

The City of Milwaukee is in receipt of the claim for damages you incurred as a result of a defect in a sidewalk or street at or near 2039 N. 37th Street and 2412 N. Finlayson Street (N. 5th Street).

The city takes every report of defective streets or sidewalks seriously. Upon notice of any defect the Department of Public Works will investigate, and/or patch, repair or barricade known hazards in its discretion. However, state law relative to roadway defects changed significantly following the adoption of 2011 Wisconsin 132. Under current state law, municipalities are only liable for known defects that the municipality has failed to timely repair. Generally, the City is not liable for damage related to roadway defects.

City records indicated that prior to October 2, 2023, and October 10, 2023, the City had no notice of these hazards in the roadway. Because of this lack of notice, and the City's discretionary immunity, the City is not liable for your damages.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
