There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

..my name is .i was passed your email by Kevin W. through the Murry Hill Neighborhood website ..in hopes of finding assistance in a noise pollution situation in my building ..I've tried doing so by anonymously contacting "Report It/Record it" for the Eastside/UWM community ..by contacting 1st District, contacting my wonderful Landlord as well as reaching out to the Murry Hill Neighborhood Organization

..this place is said to be a "Coffee/Hooka Lounge" but is operating like a nightclub in the middle of the ghetto ..the pounding in our apartment from the bass on their speakers starts after 4:20pm and goes non stop until 12am & sometimes up to 2am on weekends depending on if th weather is warmer ..we were under the assumption that it was a coffee lounge ..& we

never expected it to be a full blast 'muslim only' full blast night club ..groups of {sometimes dozens} of ALL men gather yelling the same length of time & it worsens around 8 to 11pm ..music blasting non stop & we aren't the only people complaining

..everyone else is scared to speak up because there have been several incidents since we moved here in September 2025 of people coming out of the club onto the sidewalk going down Linnwood Avenue screaming, yelling, cussing & behaving drunk ..the Landlord has stated that drinking is against their Muslim religion but no one else in the neighborhood is buying it ..because of how they behave, smoke, cuss, etc

..the music is already blasting as im writing this at 5pm ..a siren just went by and they turned it off til it passed ..and when the landlord calls, they stop for a few minutes then it starts back up again louder ..if they see the police walking up, because they have large windows in front of the shop & the building is brick so im unsure as to what the police can hear from the outside ..im 100% positive the same will happen though, they'll turn it down, unless MPD comes into my unit to hear it for themselves. When we walk , they turn it off ..but as soon as we want relax & go in to our i , it starts right back up like were slow or something ..they are being extremely patronizing & are asserting dominance by continuing to blast their music even after being asked numerous times by the Landlord to STOP landlord is elderly and they may be fooling him but they aren't fooling any of the rest of us.

..i told the Murray Hill Eastside organization they really need to investigate this "lounge" because if they aren't serving alcohol, they have to be allowing it to be consumed in their establishment some how ..we hear bottles being thrown on the ground outside and have seen & picked up liquor bottles & other trash they throw on the ground, from the side of the building all along the side to the back of th building , as we dont want to see it trashed.

..surrounding neighbors, including the older couple who owns as well as other neighbors who have all lived over here for many many years, have expressed being fed up with the Oakland Café due to continuous drama, yelling, fights, taking all the parking so students and families can't park in front of their own homes, trash & bottles being thrown & left and constant noise past the quiet hours of 9pm to 12am when the entire neighborhood is quiet

..but they all have mentioned being fearful of speaking up because of how aggressive they are in the café, which i have witnessed 1st hand ..i am not scared to 'see something/say something' because this is ridiculous. We all have the right to live in a safe peaceful environment on Oakland & Linnwood and

..we worked HARD to escape the inner city & get closer to campus ..away from the loud ghetto B.S ..& now, we have been biting our tongues for months ..gritting our teeth because it sounds like we live above a night club off of 27th & Atkinson or something ..loud Rap, Techno and Arabic Chant music blasting from 4pm til Midnight, non stop ..that gets louder as the night goes on & we can't escape it ..because everytime we speak up & say something ..they take it as a challenge to assert dominance and blast it anyways ..I am trying to give my

a fighting chance to a better life ..& now im pissn off a gang of Muslim men who smoke, cuss, yell loudly & blast trap music every single night, all night long, even Sundays ..yet im supposed to believe its "against their religion to drink alcohol" so its ist "a coffee shop" ..i dont buy it ..& i think its worth lookn in to ..The

..has also voiced how obnoxious it is ..im not sure about th other ..but i do know that we have had ENOUGH ..& we've only been here ..for all i know they're telling the landlord were lying or it isnt true because they've been there for 7 years ..but i have witnesses, they owners of the building ..everyone else is just scared to step forward in fear of volitile retaliation.

..in closing, if you have any advice or insite other than to keep calling the police ..it would be greatly valued & appreciated

& my apologies for such a lengthy letter ..i just can't hold it in any longer

The hearing before the Licenses Committee will take place on 7/17/2026 at 9:30 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
