This office is in receipt of your claim in the amount of \$2,268.00, relating to missing items and damage sustained to your vehicle on June 6, 2004 that you allege occurred at or near 5125 West Burleigh Street.

Our investigation reveals that your 2000 Chrysler van was towed to the tow lot on June 6, 2004 as Prisoner's Property, pursuant to your husband's arrest for endangering safety by the use of a dangerous weapon. The police officer on scene that night indicated you were there, but the vehicle was not released to you because you did not have any identification on your person and the tow was already called in. The officer also noted the vehicle was thoroughly searched because they were searching for the gun involved in the above-noted incident. The officers had no information or recollection of the wedding ring, earrings, or knife you alleged were in the vehicle. They also denied causing any of the damage you alleged to your seat or tapes and cd's. The City is tendering the part of your claim regarding the misalignment of your vehicle to C.H.I. Towing, the towing contractor for the City. You will receive a copy of this letter under separate cover. Since the police department followed normal and customary procedures in this matter and you failed to provide any specific evidence to support your damage and theft claim, the City cannot accept liability or refund the towing fees associated with this incident. Accordingly, we are denying your claim.
