## 5. DESCRIPTION OF PROJECT:

Project A Part I (WHS Project WI 220530): See attached approved Historic Homeowner's Income Tax Credit Application, which is enclosed. This project involves reparis to the exterior of a masonry chimney; foundation repair/rebuild and potential waterproofing (depending on what is found after removing plaster wall in basement); Masonry tuckpointing and repair to stone architectural details and brick exterior; and repairs and maintenance to brick and stone front stoop and side porch steps.

Project A Part II (WHS Project WI 220531): See attached approved Historic Homeowner's Income Tax Credit Application, which is enclosed. This project involves replacing certain storm windows with new removable storm/screen wood windows to match existing, utilizing Acker Millwork custom wood storm windows. These storm windows have been approved in the past by the HPC for this home. Photos show existing storm window to be replaced as an example, with photos of replacement storm windows previously installed, detailing how new storm windows match existing, with storm and screen inserts removable from the inside of the home.

Project B (WHS Project WI 220528): See attached approved Historic Homeowner's Income Tax Credit Application, which is enclosed. This project involves the replacement of a 33 year old steam boiler, a 32 year old cast iron boiler and installation of a full house dehumidifier. The boiler(s) require a new exhaust vent to the outside. This will vent to the rear of the house and is not visible from the street. We do not believe this project requires HPC approval, but is being submitted for verification of that fact, or for approval if such is required.

Project C (WHS Project WI 220529): See attached approved Historic Homeowner's Income Tax Credit Application, which is enclosed. This project involves the painting of the exterior of the house, with paint color to match existing, and the repair of several windows that havev rotting wood. If those cannot be repaired and need to be replaced, they will be replaced with custom wood by a professional carpenter to match existing and then painted to match existing.

Correspondence from the Wisconsin Historical Society dated December 9, 2022 is enclosed, setting forth the conditions of its approval of the above projects.
