This document is written to make the following corrections to pages 2 and 3 of Certified Survey Map No. 7749 as recorded April 28, 2006, as Document No. 09225724.

**Page 2:** The Surveyor's Certificate reads That I have made such survey, land division and map by the direction of the Housing authority of the City of Milwaukee, owner of said land. It should read That I have made such survey, land division and map by the direction of the City of Milwaukee and the Housing Authority of the City of Milwaukee, owners of said land.

**Page 3:** The Corporate Owners Certificate (Continued) reads the Housing Authority of Milwaukee. It should have a second owner in addition to the Housing Authority of the City of Milwaukee and therefore include:

The City of Milwaukee, a corporation duly organized and existing under and by virtue of the laws of the State of Wisconsin as owner, does hereby certify that said corporation caused the land described on this map to be surveyed, divided and mapped as represented on this map in accordance with the requirements of Chapter 119 of the Milwaukee Code of Ordinances.

In consideration of the approval of this map by the Common Council, and in accordance with Chapter 119 of the Milwaukee Code of Ordinances, the undersigned agrees:

- a. That all utility lines to provide electric power and telephone services and cable television or communications systems lines or cables to all parcels in the certified survey map shall be installed underground in easements provided therefore, where feasible.

This agreement shall be binding on the undersigned and assigns.
