
This office is in receipt of your claim in the amount of \$750.00, relating to damage sustained to your property on April 27, 2004 where you allege that your garage was struck by a skid-loader owned by the City while making a special garbage pickup at 8579 North 106<sup>th</sup> Street.

Our investigation reveals that the Fleet Accident Report completed as a result of this alleged incident notes that the driver of the skid-loader and the garbage truck deny striking your garage. Therefore, in the absence of proof to the contrary, we must take credence in their testimony and not accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
