Re: Report of the Renewal Application of Ahmed Abdul Azmi for a Public Passenger Vehicle Driver License.

FINDINGS OF FACT

- 1. Ahmed Abdul Azmi (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, October 31, 2013.
- 2. An application to renew said license was filed with the Office of the City Clerk on October 29, 2013.
- 3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed a police report dated October 31, 2013. That report could form the basis of non-renewal or suspension of this license.
- 4. On November 1, 2013, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on November 7, 2013 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A.. On July 23, 2011 at 6:48 p.m., officers observed the applicant operating a taxicab at North 4th and West Wisconsin Street and stopped him for a traffic violation. Several other violations were found, including not having complaint forms within reach of passengers, no daily safety checklist for that day, and having an open 12 ounce bottle of beer in the back seat. The applicant begged the officers to



disregard the violations and was repeatedly hesitant to produce his public passenger vehicle license, proof of insurance, and driver's license, the applicant was transporting a family of four so the officers had the passengers flag down another taxi. While preparing the citations, the applicant was given repeated commands to stay in his vehicle. The applicant exited the vehicle and refused to get back in stating he wanted to smoke a cigarette. The applicant had to be detained in handcuffs due to his outbursts, erratic and immature behavior. The officers, cab company, and the applicant himself agreed to take the taxi out of service for the remainder of the day for the safety of the public. The applicant was cited as follows:

Charge 1: Violate Red Traffic Signal

2: Failure to Yield the Right of Way to Pedestrian/Bicyclist

3: Open Intoxicant in Vehicle

4: Daily Safety Checklist Required

5: Complaint Forms Required

6: Resisting or Obstructing an Officer

Finding 1: Guilty, Municipal Court

2, 3, 6: Dismissed without prejudice

4 & 5: No record of citations

Sentence: \$8,880 fine

Date: 10/20/11

B. On August 26, 2011 at 10:26 p.m., an officer, while conducting speed enforcement, observed the applicant operating a taxicab at 100 North 6th Street. User laser, the applicant's speed was captured at 45mph in a 30 mph zone. The applicant had two passengers in the vehicle. The applicant stated he knew the speed limit was 30 mph and estimated his speed at 35-40 mph.

Charge: Exceeding Speed Zones

Finding: Guilty, Circuit Court-to amended charge defective speedometer

Sentence: \$88.80 fine Date: 10/17/11

- C. On October 24, 2011 the Wisconsin Department of Transportation suspended the applicant's driver's license for 6 months for driving record.
- D. On April 23, 2012 at 11:48a.m., the applicant was operating a taxicab and was involved in an accident with another vehicle at 1323 South Cesar E. Chavez Drive. A check of the applicant's driver's license revealed his license was suspended.

Guilty, Municipal Court

Dismissed without prejudice

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Ahmed Abdul, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a thirty (30) day suspension based the police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Ahmed Abdul Azmi with a thirty (30) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends that the Public Passenger Vehicle Driver license of Ahmed Abdul Azmi be renewed with a thirty (30) day suspension based upon the police report.

Said suspension is to be in effect from November 26, 2013 through midnight December 25th, 2013.
