Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/04/23 at 4:43pm, Milwaukee Police were dispatched to 7130 N. 76th St, for a fight complaint. Officers spoke with employee who stated that a customer was at the drive through, asked to park, and informed a worker would give her, her drink. The customer came in the business yelling walked behind the register grabbed a cup, and then threw the drink tray behind the registers. The employee stated that no one was injured and was cooperative with the police during the investigation.
- 2. On 02/06/23 at 8:36pm, Milwaukee Police were dispatched to 7130 N. 76th St, for a subject with a gun complaint. Offers spoke with the manager who stated that a customer brandished a firearm and made a threating remarks to an employee. The suspect was observed in a silver vehicle. The suspect stated to the employee that he would be back at 10, while displaying the hand gun. The manager provided video to the officers which showed the suspect vehicle description.
- 3. On 05/19/23, Milwaukee Police were dispatched to 7130 N. 76th St, for a subject with a gun complaint. Officers spoke with the employee who stated that a customer became upset over a mobile kiosk order. The subject appeared to be armed with a hand gun in his pocket. The subject then went behind the employee counter during the argument. The subject was removed from the business by a friend of the subject, and left in a suv. The business was

cooperative with officers but the employee did not have access to the surveillance system. The employee stated that the morning manger could access the video of the incident.

- 4. On 06/02/23 at 1:21am, Milwaukee Police were dispatched to 7130 N. 76th St, for a suspicious, other complaint. The caller stated that the business appeared to be closed but the drive through window was left opened. Officers checked observed that the business was locked and no employees were at the location. Officers checked inside the business and observed phone numbers and contacted the agent. Officers secured the business and the agent remotely armed the security system to the business.
- 5. On 08/27/23 at 8:42am, Milwaukee Police were dispatched to 7130 N. 76th St, for a trouble with subject complaint. Officer spoke to the employee and manger who stated that a drive through customer became angry while trying to a get a food order. The customer made threats to slap the manger regarding the incident. The employee feared for her safety regarding the altercation. The manger reviewed the video surveillance with the officers. The officers obtained the vehicle description from the video footage.
- 6. On 09/05/23 at 2:22am, Milwaukee Police were dispatched to 7130 N. 76th St, for a battery complaint. Officers spoke with caller, who stated that she was at the drive through window of the business, and was not being provided service. The caller explained that an unruly customer a head of her vehicle threw a drink at the drive through window prior to her receiving her food. The drink splashed inside of the window striking the employees. The employees then threw soda back but struck her and her vehicle. The unruly customer then drove away from the location, and the business refused service or communication with her. The caller told officers she either wants her food or a refund, and stated that she had nothing to do with the prior customer. Officers observed the caller's pants were wet and liquid was on her vehicle. Officers attempted to get into the business but employees refused to come to the door for the uniform officers. Officers tried knocking at different doors, as well as the drive through intercom. Officers observed two males inside visually shaking their heads no, as they move to the back of the business, out of sight. During officers time at the location there was no cooperation from within the business to resolve the incident.
- 7. On 09/09/23 at 1:52pm, Milwaukee Police were dispatched to 7130 N. 76th St for a battery complaint. Officers arrived at the location and observed a disturbance from10 subjects outside the business. Most of the subjects left the without further incident. Officers spoke with the caller/employee who stated a customer became disruptive because of a delayed wait time. Officers reviewed the video of the incident and observed the customer shouting being belligerent in the lobby. The customer was cited for disorderly conduct.
- 8. On 12/06/23 at 6:43am, Milwaukee Police were dispatched to 7130 N. 76th Street for a battery compliant. Investigation revealed that there was an argument between two employees and one threw a cup of juice at the other employee. One employee left before police arrival and the other was conveyed home by police. The manager was very cooperative and provided all the information that was needed.
- 9. On 04/30/24 at 12:00am, Milwaukee Police were dispatched to 7130 N. 76th Street for a trouble with subject compliant. The upset customers left the drive thru before police arrival and the business was cooperative with the investigation. The license posted inside the establishment was not up to date, having expired in November of 2023.

- 10. On 06/06/24 at 11:11pm, Milwaukee Police were dispatched to 7130 N. 76th Street for a shots fired complaint. Investigation revealed that three vehicles were in the parking lot and exchanged gunfire with each other. 12 spent 45 caliber casings were found inside the parking lot and no victims were found in the surrounding area. The manager of the establishment did not have access to the security camera footage.
- 11. On 10/04/24 at 4:47pm, Milwaukee Police were dispatched to 7130 N. 76th Street for a trouble with subject compliant. Investigation revealed that an employee was fired and refused to leave the location. She used loud and excessive language with staff causing a disturbance in the restaurant. There is video surveillance of the incident and the ex-employee was issued a citation. The license posted inside the establishment was not up to date, having expired in November of 2023.

On Wednesday, December 6, 2023, at approximately 06:43 AM, my partner (P.O. Demetrius HARRINGTON) and I were dispatched to a Battery Complaint at the address of 7130 N. 76th St. Which is in the City and County of Milwaukee, WI.

Upon arrival at approximately 06:52 AM, we were met by the caller, identified as Elijah C. MATTHEWS (B/M, 11-01-2001), who stated that he was in a verbal argument with one of his co-workers that he only knows her by Emary. MATTHEWS stated that Emary threw a cup of juice and landed on him, and he was very upset about it. MATTHEWS stated that Emary had already left the location before police arrival.

While on scene, I spoke with the Night shift manager, identified as Alexis L. BOYNTON (B/F, 07-08-1996) who stated that MATTHEWS was supposed to leave his shift at 6:00 AM and would not leave and would try to work extra shifts, thinking that he will get pay for what he works for. BOYNTON stated that MATTHEWS refused to leave and was calling the girl coworkers names such as "hoes", triggering her as if she is not a good manager. BOYNTON stated that she only wanted MATTHEWS to leave the place of business and come back during his rightful time of his shift.

MATTHEWS was conveyed back home. The managers of the place of business were very cooperative and provided all the information that was needed. The only thing that Officers was not able to gain access to is the cameras. BOYNTON stated that she does not have access and that only the general manager can enter and gain access.

Upon arrival I observed there were no cars present in the drive through, there were several unoccupied cars in the parking lot, belonging to employees. There was one subject in the lobby waiting for a curbside food order, unrelated to the incident.

I spoke to the caller, Trina HOOKER, who was working in the drive thru. HOOKER stated that about 30 minutes ago there were two subjects in a silver sedan that were not happy with the order they received and were refusing to leave the drive thru. HOOKER stated that she was only concerned because she has lived and worked at McDonald's in another part of town where customers can get aggressive, so she called just in case the situation escalated. HOOKER stated the subject's ended up leaving prior to arrival and there was no need for police.

I spoke to licensed premise, Malasia STEELE. She did not make any statements regarding the situation. The business was cooperative with the investigation. The business had 0 security officers on scene.

While on scene, I observed the licenses posted and they were not up to date, the most recent business license expired in November of 2023. The occupancy license expires in June of 2038.

There were no police actions taken regarding the situation.

This report is written by PO O'Neal STAMPS III, assigned to District 4, Late Power Shift. On this day, my partner Khalid MAJEED and I were dressed in full duty uniform with our last name and badges affixed to the outermost garment. We were also equipped with an Axon Body worn camera which was activated during this investigation.

NATURE OF CALL/ JUSTIFICATION

On Thursday, June 6, 2024 at approximately 11:11 pm, PO MAJEED and I were dispatched to the address of 7130 N 76th St (McDonald's) for a SHOTS FIRED complaint. This address is located in both the City and Count of Milwaukee, WI. The caller of this complaint stated that subjects were shooting at each other and that they heard approximately 10 gunshots. The caller also stated that the subjects were no longer on scene. The caller added that they believe that someone may have been dropped off at the entrance of a nearby carwash after the shots were fired.

INVESTIGATION

Upon arrival at the mentioned address, PO MAJEED and I checked the nearby carwash close to the dispatched address which is the Mister Carwash located at 7338 W Good Hope Rd for anyone in need of medical or police help in which we did not locate anyone. PO MAJEED and I then proceeded to the McDonald's parking lot which is the scene of this incident. Upon arrival at the dispatched address, PO MAJEED and I located 12 spent silver 45 caliber casings in the north parking lot of the business. I did not observe any vehicles in the parking lot upon our arrival.

I observed that the doors of the business were locked and the employees were all in the rear of the building. As I knocked on the front door of the business, the caller later identified as Daria L MORSE (B/F 10/02/1961), came to the door and allowed me access inside the restaurant. MORSE stated that while on duty, she heard

approximately 10 gunshots coming from the parking lot on the northside of the building. MORSE stated that she observed three vehicles in which she believed was involved in a shootout in the parking lot. MORSE stated that she observed a red Chevrolet Colbalt with front bumper damage, a silver sedan with drivers door damage and another silver Chevrolet Malibu who were exchanging gunfire with each other. MORSE stated that she observed the silver sedans leave the premise heading in a easterly direction and the red sedan exited the parking lot and proceeded north on 76th St. MORSE stated that no employees were hurt during this incident.

MORSE stated that she is the manager that was on duty but she does not have access to the security camera footage. MORSE stated that the security camera footage can be viewed during daytime hours as the head manager will be on duty and will have the required access.

PO MAJEED conducted CST duties by taking 58 photographs that captured the overall scene, location and evidence. PO MAJEED and I then collected the spent casings and conveyed them to District 4 where they were placed on inventory.

FOLLOW UP

PO MAJEED and I then conducted a sweep of the area in search of any vehicles or building that may have been struck by gunfire in which we found none.

ON FRIDAY OCTOBER 4, 2024 AT APPROXIMATELY 4:47 PM SQUAD 3241 (PO ROBIN STOIBER AND I WERE DISPATCHED TO THE MCDONALDS RESTAURANT LOCATED AT 7130 N 76TH STREET FOR AN EMPLOYEE (ANYA COLE) THAT WAS TERMINATED AND WAS CAUSING A SCENE AND REFUSING TO LEAVE.

ACCORDING TO KAMESHA S JACKSON (B/F, 12-27-92) WHO IS THE SECOND SHIFT MANAGER, ON 10-04-24 AT 4:24 PM SHE OBSERVED CASHIER ANYA COLE (B/F, DOB 06-09-2006) BEING RUDE TO A CUSTOMER. ACCORDING TO JACKSON, SHE INFORMED COLE THAT SHE WAS NOT TO BE RUDE TO THE CUSTOMERS. JACKSON INFORMED COLE THAT SHE NEEDED TO CLOCK OUT AND LEAVE. JACKSON OBSERVED THAT COLE HAD NOT CLOCKED OUT AND CONFRONTED HER. COLE BEGAN YELLING LOUDLY AND USING HAND GESTURES CAUSING A DISTURBANCE IN THE RESTAURANT. COLE REFUSED TO LEAVE. JACKSON STATED THAT COLE'S MOTHER SHOWED UP AND COLE CONTINUED TO REFUSE TO LEAVE. JACKSON STATED THAT COLE INTENTIONALLY USED LOUD AND EXCESSIVE LANGUAGE WITH STAFF CAUSING A DISTURBANCE IN THE RESTAURANT.

ACCORDING TO THE GENERAL MANAGER SHARON TILLIS (B/F, DOB 02-04-1975), SHE WAS CALLED TO THE STORE BECAUSE JACKSON BELIEVED THAT THERE WAS GOING TO BE A FIGHT IN THE STORE BECAUSE COLE'S FAMILY WAS ARRIVING AFTER COLE HAD BEEN TERMINATED AND REFUSED TO LEAVE.

THERE IS VIDEO SURVEILLANCE OF THIS INCIDENT. AN EVIDENCE.COM LINK WAS SENT TO TILLIS TO UPLOAD THE VIDEO OF THIS INCIDENT.

STORE OWNER ERIK SHROEDER (DOB 6-07-77) REQUESTED THAT A CITATION BE ISSUED TO COLE.

COLE HAS BEEN ADVISED THAT SHE IS TERMINATED AND IS NO LONGER ALLOWED AT THIS LOCATION.

PO STOIBER requested video footage of this incident from store manager.

While on scene, I observed the licenses posted; however, it was expired in 2023. Manager was advised to post the current report.



- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
