Upon my arrival, I observed a b/m wearing a red jacket and green pants as stated in the CAD lying in the middle of the floor inside of the gas station. I made contact with the black male stating, "Sir, I'm Officer MAJEED of the Milwaukee Police Department. Are you ok?" **Satwinder SINGH (I/M 05-07-1999)** stated this person suffers from mental illness and always comes inside the store because he has nowhere to go.

Victor L. WEST (b/in, 01-20-74) woke up and stated he needed medical due to him having pain in his body all over. I radioed for medical to respond to our location for a b/m, 49 years old, conscious and breathing, not in custody at this time for body pain. WEST picked himself up off of the floor and asked to wait for medical inside our squad car.

While awaiting medical, WEST requested to decline medical and wanted to be conveyed to a family member home located at 2115 W. Hampton Av. I requested permission from District 4 Lieutenant to make the citizen conveyance and conveyed him to his family's home without further incident.

SINGH was helpful and cooperative and assisted in my investigation.

On *Thursday, May 25, 2023, at 1:35AM, Squad 4340 (P.O. Misael VASQUEZ/P.O. MARKERT)* were dispatched to investigate a "Trouble with subject" call for service at **2908 W Villard Av (BP gas station)**, which is located in the city and county of Milwaukee, in the State of Wisconsin.

During this initial investigation, P.O. VASQUEZ was operating car #032, a marked Milwaukee Police vehicle with 360-degree red and blue lights and siren. MPD Car #032 is equipped with a dash mounted squad camera (MDVR). I was dressed in full Milwaukee Police uniform, with a badge patch affixed to my outer ballistic vest carrier. I was equipped with an Axon body worn camera, which recorded audio/video during my investigation.

The below report is a summary based on recollection and is not a verbatim retelling of the events captured on the body worn cameras.

Upon arrival, I spoke with the caller / gas station employee identified as Jasmanpreet SINGH (M/W, 02-20-1993) who stated at approximately 12:00AM, a black female wearing a pink colored t-shirt, white blue jeans and tennis shoes came inside the gas station and was smoking a cigarette in the rear of the store.

While on scene, the above listed subject was observed throwing items around in the store and then subsequently, throwing herself down onto the ground kicking and screaming with other customers present in the store.

The female was identified as Temacie L THREATT (F/B, 03-26-1990) and was conveyed to MHEC.

Upon my arrival on 6/30/23 at approximately 1:27 pm., I spoke to Amninder, Amninder M/B, 08/05/92), who identified himself as an employee at the listed location. The listed location is a BP Gas Station. AMNINDER stated 2 unknown black females arrived to the listed location. One female approached the counter and paid for her items with cash. The 2nd female approached the counter with one roll of tissue and attempted to purchase a "blunt cigar". The cashier requested to see the unknown female government issued ID and the female became agitated. The unknown female then walked out of the listed business passed the point of sale without paying for the roll of tissue.

The caller advised police the two unknown females fled the location in a Silver sedan bearing Wisconsin license plate #AGJ9520. An NCIC check revealed the listed vehicle belong to Debra A. BOHANNON (F/B, 09/07/59) and Mahogany M. BAKER (F/B, 02/28/00). My partner and I changed locations to 5228 N 62nd St., to speak with the listed owners. As we continued to search the area for any casings or victims, we located several spent brass casings on the south side of the building. We were unable to locate any shooting victims at the time. The scene is a BP gas station connected to a Boost Mobile phone store. There is an entrance to the parking lot on W Villard Av and an entrance on N Teutonia Av as well. There are approximately twelve gas pumps in the middle of the parking lot. Squad 4312, Sergeant Paul GRACZYK, and squad 4431, PO Shane BISHOP and PO Ashley PASHKEWITZ, responded to the scene as well to help with traffic and scene security.

The callers stated that there was a possible shooting and that two vehicles has crashed and he did not see anyone exit the vehicle therefore he thought that they were shot and dead.

I spoke to licensed premise *employee / manager, Balwinder SINGH, W/M, 2/13/89, who was working at the time of the incident*. They stated that he was one of the callers and stated that three to four subjects were shooting into a vehicle. The business was *cooperative* with the investigation and gave me access to the video cameras to see the video.

I reviewed video surveillance footage. The footage showed that a grey in color Chevrolet Equinox, pulled into the parking lot about half way and then backed out of the parking lot and parked on W Villard Av near N 29th St. The video then showed a b/m, wearing a red shirt, blue jeans, black shoes and a tan backpack, came walking through the parking lot from Teutonia towards N 29th St. *The video shows that the subject gets to the south west corner of the building and begins shooting towards the grey Chevrolet that parked on the street. A short time later, you see a b/m, wearing all black enter the parking lot off of W Villard Av walking northbound also shooting in the direction of the vehicle as well.*

The below report is a summary based on recollection and is not a verbatim retelling of the events captured on the body worn cameras.

On scene, I spoke with the gas station employee identified as **Jasmanpreet SINGH (M/W, 02-20-1993)**. SINGH stated that at approximately 2:30AM, a black male subject and black female subject came into the store. SINGH stated that the male subject retrieved a 1L bottle of water and a cranberry juice and attempted to exit the store without paying when another gas station employee, identified as **Sigh ARSHBRECT (M/W, 08-23-2004)** stopped him prior to exiting.

While reviewing the surveillance video, I observed ARSHBRECT able to get the merchandise back. The male subject is observed leaving the gas station lobby and goes to his vehicle which is parked at the pump. SINGH states that both the male and female subject then get into a Silver 2005 Buick Rendezvous bearing WI auto plates AJC-9131.
