AMENDMENT TO & EXTENSION OF LEASE AGREEMENT

Amendment to & Extension of Lease Agreement made as of the _____ day of _____, 2006, by the United State of America (and hereinafter referred to as the "Tenant"), and the CITY OF MILWAUKEE, a Wisconsin municipal corporation, by and through its Board of Harbor Commissioners (hereinafter collectively referred to as the "City").

W I T N E S S E T H :

WHEREAS the City and the Tenant have entered into a Lease Agreement dated November 1, 2005 (herein referred to as the "Lease Agreement"), for the lease of approximately 5.97 acres of real property located at 2372 S. Logan Avenue in the City of Milwaukee (hereinafter referred to as the 'Property'); and

WHEREAS the City and the Tenant have agreed to extend the term of the Lease Agreement and to amend certain of its terms and conditions, as further specified in this Amendment to & Extension of Lease Agreement;

NOW THEREFORE, in consideration of the mutual covenants and conditions set forth herein, the City and the Tenant agree to amend and extend the Lease Agreement dated November 1, 2005 as follows:

This lease is entered into by the parties under the following terms and conditions:

1. **Term.** The term of the Lease Agreement shall be restructured to include the following:
 - A) A new term of one (1) year commencing at 12:00 a.m. on October 1, 2006 and ending at 11:59 p.m. on September 30, 2007 (the "Extension Period").
 2. **Rent.** During the Extension Period, the rental shall be a sum of \$71,585 (Seventy One Thousand Five Hundred and Eighty Five Dollars).
 3. Except as otherwise provided for in the Amendment to & Extension of Lease Agreement, all other terms and conditions of the Lease Agreement dated November 1, 2005 shall remain unchanged and continue in full force and effect.
