This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/01/2019 officers were dispatched to an Overdose at 5505 W. Lisbon Av. The officers located a subject who had overdosed on Heroin. The subject was medically cleared and arrested for Possession of Controlled substance.
2. On 07/14/2020 at 1:25am a subject walked into District 3 station to report a battery that just occurred at the Clark gas station at 5505 W. Lisbon Av. The victim stated he was intentionally struck in the face with an unknown object. The victim suffered multiple facial fractures. Officers went to the location and located where in the building the incident occurred. The officers were informed the video system does not work.
3. On 09/14/2020 at 8:44pm officers were dispatched to Clark Gas Station, 5505 W. Lisbon Av, for an Armed Robbery call. The victim stated he was inside the store when an armed subject approached his wife, who was sitting in their vehicle which was parked by the gas pumps. The suspect took the victims auto and fled the scene. The applicant was on scene and provided video of the incident.

4. On 12/25/2021 at 4:14pm officers were dispatched to a Shots Fired at 5505 W. Lisbon Av. The officers spoke with the clerk, who stated several people were arguing in the parking lot. He stated many of the subjects were armed with firearms. He heard several shots fired and all

the people fled the area. He went outside and observed casing on the ground, which he pointed out to police. While investigating the officers were advised of a shooting victim, which was determined to be related to their call. The officers were able to recover video of the incident.

5. On 06/17/2022 at 9:51pm officers were dispatched to an Armed Robbery at 5505 W. Lisbon Av. The officers interviewed the victim, who stated she was robbed while pumping gas. The business was cooperative and provided video of the incident.

6. On 10/30/23 at 1:05a.m., Milwaukee Police were dispatched to a Battery at 5505 W Lisbon. Officers were advised by a citizen a subject asked them to call the police and the citizen observed the subject being battered by another subject. The subjects were no longer on scene and both the citizen and business were cooperative.

The following items pertain to the business at 5505 W Lisbon

7. On 04/11/24 at 12:05a.m., Milwaukee Police took a walk-in shooting at a local hospital. The victim stated as they were exiting the gas station, they heard shots fired and were struck in the leg three times. The business did not call the police, however, stated they did hear the gunshots and recovered a cell phone in the parking lot. The business did allow officers to view video surveillance of the incident.
8. On 06/09/24 at 1:09a.m., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed a patron was robbed at gunpoint inside the store, while paying for their purchases. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
9. On 08/07/24 at 8:44p.m., Milwaukee Police were dispatched to a Battery DV. Investigation revealed this was a Domestic Abuse incident. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, which depicts the incident as the victim stated.
10. On 09/01/24, Milwaukee Police were dispatched to a local hospital for a Shooting that occurred on 08/31/24 at 1:02a.m. Investigation revealed the victim was seated in a car in the parking lot, when passengers of the vehicle exit the gas station arguing with the suspect, who fires shots at the vehicle, striking the victim. 12 spent casings were recovered. The employee stated they heard the gunshots, however, did not see anything. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
11. On 12/28/24 at 8:24p.m., Milwaukee Police were dispatched to an Overdose. MFD advised the officers they observed the subject lying unconscious near the sidewalk in front of the business. Narcan was administered and the subject was transported to a hospital, where they stated they were given the drugs as a sample by a subject near the business.
12. On 06/21/25, Milwaukee Police were assigned to work Wisconsin WINS, which checks area vendors for age compliant tobacco sales. At approximately 9:15a.m., a youth, not of legal age to purchase tobacco, was able to purchase a tobacco product from the cashier, who did not check ID. A citation was issued to the Agent for Sale of Tobacco to Minor, with a future court date of 10/29/25. Case #25019514

13. On 10/04/25 at 1:12a.m., Milwaukee Police were dispatched to a Theft. Investigation revealed the business was the victim of a retail theft.

This report is written by P.O. Joseph MACK, assigned to DISTRICT 3, LATE SHIFT, SQUAD NUMBER, 3321, along with P.O. Aaron FROH. P.O. FROH and I were in full duty uniform equipped with an Axon body worn camera activated and in a marked squad vehicle.

On Thursday, April 11, 2024, at approximately 12:05 am P.O. FROH and I were dispatched to a walk in shooting complaint that arrived at St Joseph's Hospital 5000 W Chambers Ave.'

VICTIM STATEMENT:

Victim stated that he and his friend went to the gas station located at 5505 W Lisbon AV, in the City and County of Milwaukee.

Victim stated he entered the gas station, bought some blunts, exited and heard multiple gun shots. Victim did not know who or where the shots came from. Victim was struck by gunfire 3 times to his right thigh, 2 times in the left thigh. Victim reentered his friend's SUV and was taken to St. Joseph's Hospital.

P.O. FROH and I were tasked with locating a scene at the Clark Gas Station 5505 W Lisbon Ave., located in the City and County of Milwaukee. For this complaint call, a total of 4 squads responded to complete the investigation along with 1 supervisor. 7 casings recovered in the lot of the gas station.

Upon arrival, I went inside of the gas station and spoke with two licensed premise employees, identified as Kashmir SING (A/M, 11-9-88) and Lovepreet SINGH (A/M, 9-24-97). K. SINGH stated he was inside one of the aisles inside of the gas station when he heard multiple gun shots from the parking lot. K. SINGH said he looked outside and observed a black SUV driving away westbound on Lisbon Ave. and found a cellphone outside on the ground by gas pump #5. K. SINGH stated he brought the cellphone inside of the gas station. L. SINGH stated he was checking out a customer inside of the gas station when he heard multiple gun shots outside in the parking lot but did not go outside. Both witnesses stated at no time did they call the police. I awaited with these witnesses until CIB arrived.

The business was cooperative with the investigation.

While on scene, Squad 3331 (P.O. Thomas WRIGHT and P.O. Tyler PROPP) was able to review surveillance video of the incident that occurred in the parking lot regarding the shooting and also showed CIB Detectives when they arrived. Per video footage, incident occurred at approximately 11:13 PM on April 10, 2024.

Suspect info: b/m, 5'11, skinny build, wearing all black, with light colored gloves, white left shoe, one right black shoe armed with 2 handguns, discharges both firearm towards V and flees southbound on N 55th ST.

The business did not have any security officers on scene.

On Sunday June 9th, 2024, at approximately 1:09AM, I was dispatched to 5505 W Lisbon Ave for an Armed Robbery.

Upon my arrival I observed Crossley A CORDELL B/M 12-02-97 standing inside the gas station waiting for police to arrive. CORDELL seem to be very nervous explaining the incident not remembering exactly what happened. I observed the employee standing behind the glass register continuing to check out customers. I observed the store not being vandalized. I spoke with the employee who stated he was not on duty at the time of the incident, but Lorepreet SINGH was on shift at the time.

I spoke to the caller, Crossley A CORDELL B/M 12-02-97 414 736-7541. CROSSLEY stated he was robbed at gunpoint by two unknown black males. CROSSLEY stated he purchase snacks and walked to the cash register. CROSSLEY stated he pulled out his quest card to pay for his items. CROSSLEY stated suspect #1 was a black male slim build, grey sweatshirt, black shirt underneath, brown pants, black ski mask, rubber gloves, and handgun with a drum on it. Suspect #2 was a black male brown skin, 6'0ft, slim build, wearing all dark clothing. CROSSLEY stated suspect #1 approached him from behind and stated " Give me that shit" pointing a silver handgun with a drum on it at him. CROSSLEY stated he put both hands in the air. CROSSLEY stated suspect #2 then approached him going thru his pockets taking \$900 dollars and car keys. CROSSLY stated his vehicle was not taken but still at the pump where he parked it. CROSSLY then stood by waiting for a tow.

I observed one witness in the video footage at the time the incident happened but did not observe the witness still on scene once officers arrived.

I reviewed video surveillance footage. I observed two unknown black males enter the store behind CROSSLEY. I observed CROSSLEY walking towards the back of the store grabbing items from the freezer while suspect #2 following behind him back to the front of the store. I then observed CROSSLEY standing at the register purchasing items. I observed CROSSLEY going into his front pockets getting money to pay for his items. I then observed suspect #1 was a black male slim build, grey sweatshirt, black shirt underneath, brown pants, black ski mask, rubber gloves, and a handgun with an extended clip hanging from it pointing and aiming it at CROSSLEY chest. I observed suspect# 2 was a black male brown skin, approximately 6ft, slim build, wearing all black clothing. I also observed two witnesses inside the store when the incident happened, but they left the store afterwards. Officer was able to obtain video footage of the incident right away. Officers then reached out to Community Officer Angleine WHITE to retrieve a copy of the footage to upload the footage on Axon. WHITE attempted to access a copy of the footage but was unsuccessful due to issues with the employer video footage. WHITE stated she attempted twice to retrieve footage during normal business hours.

I spoke with the current clerk who stated he was not on shift at the time when the incident happened, he just arrived to work for his shift. I received the clerk information to contact him at a later date in which he stated he does not remember the incident and full detail.

This report is written by PO Devin WHITFIELD, assigned to District Three, Late Power Shift.

On Wednesday, August 7, 2024, at 8:44 PM, I (squad 3420) responded to the Clark Gas Station, located at 5505 W Lisbon Ave in the City and County of Milwaukee, Wisconsin for a Battery DV call for service. PO Craig WILSON (squad 3292), PO Taylor ZUBE and PO Brandon BUELOW (squad 3450) also responded to assist with the investigation.

Upon arrival, I interviewed Dierra D MCNEALEY (b/f, 10-31-95) who stated that her child's father, verbally identified as Donovan T CARTER (b/f, 02-19-90), intentionally and without consent punched and slapped her in the face, causing her pain to her face and visible injury to her lip. CARTER also intentionally kicked her and MCNEALEY's two year old son, causing him to fall to the ground. This incident occurred on 8-7-24 at 8:30 PM at the gas station at 5505 W Lisbon Ave. MCNEALEY and her son were both on scene upon arrival. I did not observe any visible injuries to the son but did observe dried blood on MCNEALEY's lips.

CAD DETAILS:

8-7-24 20:33 - CLLR STATES A MALE ASSAULTED A FEMALE, SNATCHED CHILD FROM HER AND PUT CHILD IN BACK SEAT

20:35 - MALE IS PHYSICALLY ASSAULTING A FEMALE AND PICKED A BABY OUT OF THE CAR AND THREW BABY ON THE GROUND

20:37 - MALE SUBJ WAS HITTING FEMALE IN FACE

Victim Interview: Dierra D MCNEALEY (b/f, 10-31-95)

I interviewed MCNEALEY outside in the parking lot of the gas station. MCNEALEY stated that on 8-7-24, she, CARTER, her son, and CARTER's uncle were leaving a family member's residence and were going to the gas station at 5505 W Lisbon Ave to get snacks for her son. MCNEALEY stated that CARTER's uncle was driving, CARTER was seated in the front passenger seat, she was seated in the rear passenger seat, and her son was seated in the rear driver seat.

MCNEALEY stated that she and CARTER started arguing because CARTER was angry that she had used his

food stamp card to buy groceries. MCNEALEY stated that they arrived at the gas station and parked at pump #1. MCNEALEY stated that CARTER began calling her derogatory names, including a "b*tch" and "fat h*e." MCNEALEY stated that CARTER then exited the front passenger seat of the vehicle and punched her one time in the mouth through the open rear passenger window. MCNEALEY stated that this caused her pain and caused her lip to bleed. MCNEALEY stated that she then exited the vehicle and began to walk away but came back for her son. MCNEALEY stated that CARTER then slapped her in the face, causing her pain to her face.

MCNEALEY stated that the arguing continued, and that during the argument she told CARTER that her son is not his child. MCNEALEY stated that CARTER then grabbed her son from the vehicle, stood him up on the ground, and then kicked him in the back causing her son to fall to the ground. MCNEALEY stated that bystanders intervened and attempted to get CARTER to stop, and CARTER began arguing with the bystanders. MCNEALEY stated that CARTER's uncle was eventually able to get CARTER back into the car and then drove him away from the location.

Witness Interview: Joshua E YOUNG (b/m, 08-09-80)

PO WILSON interviewed a citizen, identified as Joshua E YOUNG (b/m, 08-09-80), who witnessed the incident. According to PO WILSON's supplemental report, YOUNG stated to him that "her baby daddy was beating the sh*t out of her (MCNEALEY) and he kicked the child". Young further stated, "When I first pulled up, they were arguing, and he shoved her. She was trying to get the baby out and they were arguing back and forth. He wouldn't let her back in the car. They started arguing and tussling again. He struck her. After he snatched the baby, he put the baby back in the car. Her mouth was already bleeding when I first noticed what was going on. He shoved her several times. They argued some more. She said something to him. He went and grabbed the baby out of the car, shoved the baby out of the car and kicked the baby."

Employee Interview: Lovepreet SINGH (w/m, 09-24-97)

I spoke to a cashier at the location, identified as Lovepreet SINGH (w/m, 09-24-97). SINGH was cooperative and allowed me to view video of the incident. I observed the listed addressed taped off with no vehicle at the BP gas station. I observed many squads blocking off each entrance to the BP gas station with their squads and yellow tape. I observed up to 12 casing spent listed with numbers beside them. I observed nobody inside the clerk gas station.

I spoke to the clerk at the register who was later identified as Gurjant S MUNDI W/M 12-04-03 414-745-0284. MUNDI stated at the time of the shooting the gas station was very busy and he had a long line of customers. MUNDI stated he heard around 4-5 loud gun shots but did hear movement outside. MUNDI stated that the witnesses that were in the store at the time of the shooting left the gas station.

I spoke to no witness at the scene due to them all leave immediately after the shooting

I was not able to speak with the owner associated to the licensed premise. But was able to review and retain all footage from MUNDI.MUNDI was very cooperative with officers the investigation

I reviewed video surveillance footage. Video Review: Victim arrives to gas station in an older model red Acura. Victim stays inside the vehicle while 2 subjects from the vehicle go into the gas station. As the 2 subjects exit the gas station, and an argument breaks out with Suspect. 2 subjects with the Victim pick up a backpack that the suspect dropped. Suspect fires off handgun in the direction of the Acura. Acura then takes off driving away from the gas station in an unknown direction.

Upon arrival, we spoke with Milwaukee Fire Department (MFD) Engine 34, LT. SCHULTZ, blue shift and MED 13 who stated they observed a white male later identified as Aaron J. BOSSHART (W/M 6/11/1983) laying near bushes near the sidewalk in front of the Clark gas station unconscious when they arrived. MFD administered one dose 0.5mg of Narcan.

BOSSHART was transported by MED 13 to St. Joseph Hospital at 8:49PM and treated by Dr. Rebecca WALSH.

I spoke with BOSSHART who stated he took what he believes was heroin by needle. BOSSHART stated there was a measurement on the tube/needle and it was at "3" and he received the heroin from an unknown male that was giving out "samples" near the gas station. BOSSHART stated he was not trying to kill himself and it was the first time he took any drugs in about a month after being sober for the past month.

BOSSHART was provided a community contact card.
