There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with warrants or unpaid fines:**

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/25/2004 at 2:05 AM officers responded to the licensed premises at 3250 N 2<sup>nd</sup> St regarding a shooting. Investigation revealed that a fatal shooting occurred outside the tavern at about 2:00 AM and that the victim had been a patron of the tavern. No further information. Incident Report Filed.
2. On Wednesday 08/17/2004 at 2:50 AM officers observed patrons exiting the licensed premises at 3250 N 2<sup>nd</sup> St, the Glass Slipper. Officers then made a lawful inspection of the licensed premises at found 22 patrons still in the tavern. The bartender on duty stated that the patrons were from a birthday party. The applicant was not on the scene and was cited.

3. On 02/06/10, Milwaukee police were dispatched to 3250 N 2<sup>nd</sup> Street for a Drug Dealing complaint. Officers spoke with the bartender Nicole Spillers who stated earlier in the evening a female entered the tavern and wanted her boyfriend to leave the tavern. The female was asked to leave and when she did, broke the glass on the front door. Spillers believed that the female was the one who made the call regarding the drug dealing complaint. A check of the tavern found no evidence of drug dealing. No tavern violations were observed.
4. On 03/12/10 at 12:18 am, Milwaukee police were dispatched to 2<sup>nd</sup> and Concordia for a Shots Fired complaint. Investigation found two subjects were arguing in front of the tavern when one actor pulled out a gun and started firing shots at the other subject. Officers were able to view video surveillance that was provided by the tavern owner Jimmy Jordan, which showed the incident. The tape however was in black and white and was blurry. The time on the video also didn't correspond with the actual time of the incident taking place. Casings were found in front of the tavern and were placed on police inventory. Area hospitals were checked for a shooting victim but none were found. Officers also spoke with the bartender Nicole Spillers who stated she heard shots but did not know who was shooting outside. Officers also spoke with the doorman John Wright who stated he heard about 16 shots being fired and when he looked outside, did not observe who was shooting the gun.

5. On 05/26/13, Milwaukee police were dispatched to a Shooting at 3250 N 2<sup>nd</sup> Street. Investigation revealed that two victims of the shooting had been previously inside the bar. One victim was the DJ who had been performing at the bar, with the second victim being a friend of the DJ, who was a patron. Both subjects had exited the bar to have a cigarette and while outside, were approached by 2-3 males who were armed with guns. The suspects ordered the victims, as well as several other patrons who were outside smoking, to the ground and began going through their pockets. Prior to leaving and possibly before the searching of the pockets, the suspects shot each of the victims once to their right leg. The suspects fled after obtaining money and property from the victims. It is possible that the suspects may have been in the bar previous to the robbery/shooting. The bar's surveillance video depicts not only the lead up to the incident, but what the owner said was the possible two suspects.

6. On 02/15/2015 Milwaukee police conducted a licensed premise check at 3250 North 2<sup>nd</sup> Street. Officers discovered patrons inside the business who had not yet attained the legal drinking age of 21 as well as a subject who was armed with a handgun. Milwaukee police incident report #150460010 filed.

7. On 01/04/2020 officers were dispatched to a fight at Glass Slipper bar, 3250 N. 2<sup>nd</sup> St. The investigation revealed a female was at the bar with friends. A male subject observed the female taking with other men. The male became upset and struck the female several times. The male was located and arrested. The applicant called the police and reported the incident.
8. On 01/01/2021 at 1:33am officers conducted a license premise check at Glass Slipper, 3250 N. 2<sup>nd</sup> St. The officers spoke with the applicant, who stated the night was slow. The officer asked to see the licenses and the applicant showed them to the officers. The licenses showed an expiration date of 12/20/2020. The officers checked LIRA and found the business did not

have a valid license to operate. The applicant provided an email dated 12/04/2020 that showed he had applied for a renewal.

9. On 10/11/22 at 1:49am., officers were dispatched to a Shooting complaint at 3250 N. 2<sup>nd</sup> St. Officers were flagged down by an employee stating there were shooting victims in side the bar. Officers located two victims inside the bar, both with multiple, non-fatal gun shot wounds. Officers observed a large pool of blood beneath the seat of one of the victims. Officers located a scene outside the tavern, where numerous casings were recovered as well as a blood trail, which led to the rear of the tavern, where more casings were recovered. Numerous small bottles of liquor were observed with a price tag on them and the employees were advised regarding liquor sales past 9pm, and allowing patrons to leave the location with the purchases. The agent and an employee were interviewed and were cooperative with the investigation.

## Narrative (1)

### LICENSE PREMISE REPORT

Terrell, James L 029828

10/12/2022

This report is written by PO James TERRELL, assigned to District Five Late Power Shift, Squad 5468 with PO Nora BURLO.

On Tuesday, October 11, 2022, at approximately 1:49AM, PO BURLO and I responded to 3250 N 2nd St (Glass Slipper) regarding a shooting in order to conduct a license premise check.

At 12:43AM Squad 5320 (P.O. Juan MEDEL) came over talk group 5 stating that citizens came up to him at his scene stating that subjects were shooting at each other on N. 2nd Street and W. Ring Street. Squad 5460 (P.O. Daniel SCHAEFER & P.O. Tyler SEELOW) were then dispatched to the shots fired complaint. Squad 5372 (Chad BOYACK and P.O. Ryan CLEMENTZ) responded as well. Upon arrival squad 5372 were waved over into the bar located at 3250 N. 2nd Street (Glass Slipper) by a worker stating there were two subjects shot inside of the bar. Inside, Squad 5372 located two gunshot victims. One subject (Steven U. KIRK, B/M, 01-20-1975) stated he was shot in thigh but that he wanted to remain standing. Later when fire department personnel cut KIRK'S pants off it appeared that KIRK had two entry and two exit holes from gunshot wounds to his right thigh area. The second subject (Carlos RANDALL, B/M, 05-22-1983) that stated he was shot in his foot. Later when fire department personnel inspected RANDALL'S injuries it appeared that RANDALL was shot once to the left lower leg area and one gunshot wound to the left hand. Squad 5372 observed a large amount of pooled blood beneath the area where RANDALL was seated as I immediately called for medical attention for the two gunshot victims.

A scene was located directly outside of the tavern on the northeast sidewalk area of N. 2nd Street and W. Ring Street, where spent / fired casings were located. There was also a blood trail that led east on the north sidewalk to the back (eastern side) of the tavern where other spent / fired casings were located. Both shooting victims were conveyed to Froedtert Hospital by members of the Milwaukee Fire Department.

There were no "Shotspotters" in the area as the system does not branch out this far east.

CIB Responded.

PO BURLO spoke with the owner of the location who was identified as Jimmy D. JORDAN (M/B, DOB 12/24/1946) and his son who works at the location who was identified as Judell D. WALKER (M/B, DOB 03/29/1989). JORDAN and WALKER live above the location. JORDAN and WALKER were cooperative in this investigation.

Upon conducting a walk through the location, I observed numerous small bottles of liquor with a

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**


