If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/26/22 at 9:06p.m., officers were dispatched to a large fight at 2635 W. Fond du Lac Ave. Investigation revealed an employee had been fired and the large group had been called by the employee, who were threatening to beat up the manager. The employee stated the manager pointed a gun at her and dragged her out of the building. The manager who did have a firearm in their front pocket, was interviewed and confirmed the employee had been fired, however, denied pointing a firearm or dragging her out of the building. The agent was contacted and agreed to an appointment for officers to view video surveillance, however, did not honor the appointment. A citation was issued to the manager.

2. On 04/08/22 at 7:52p.m., officers were dispatched to 2635 W. Fond du Lac Ave. for a Reckless Use of a Weapon. Officers interviewed the caller/employee who stated another employee pulled out a long black gun, pointed it at him, then followed him inside the restaurant and continued arguing with him. Officers requested to see video surveillance, however, management stated they did not have access to it. Management further stated they did not know the employee's identity and only knew the first name of the employee. Management did allow officers into the back room where the firearm was located, and it was determined it was a BB Gun. The employee was advised a citation would be issued once the other employee was identified.

3. On 08/01/22 at 12:30a.m., officers were flagged down for a Subject with Gun at 2635 W. Fond du Lac Av. Officers were advised a customer displayed a small handgun, and in turn the manager displayed his firearm. The manager stated this incident occurred at approximately 11:50p.m. and was cooperative and forwarded the video to the officer for further investigation.

4. On 02/10/23, officers were dispatched to a Subject with a Gun at 2635 W. Fond du Lac. Investigation revealed a customer had trouble with their order, however, was no longer on scene upon officer's arrival. Management denied any one displaying a firearm. The officer contacted the caller via the phone, however the patron appeared to be intoxicated and the description of the employee did not match any one on scene.

I spoke with the manager, identified as Jerlina M. MACKLIN (B/F, 03/19/1987) who stated that an argument ensued over a wrong order. MACKLIN stated that a refund was issued and that no one displayed a firearm.

P.O. GALVAN spoke to the caller over the phone who was intoxicated and not making sense over the phone. The caller's description of the subject did not match anyone that was on scene.

INITIAL INVESTIGATION

This report was typed by P.O Jordon KUNYA, District 3, Early Shift. On Saturday, March 26, 2022, at 9:06pm, while assigned to Squad 3220, P.O Luis MADRIGAL and I responded to a fight at 2635 W. Fond Du Lac Ave., also known as Fryerz, which is located in the City and County of Milwaukee. Squad 3490 (P.O Nathaniel PETERSEN & P.O Robert DAVIS) and Squad 3431 (P.O Jesus MERCED & P.O Samuel KEHOSS) responded to assist.

We were informed by dispatch that a large group was attempting to fight an employee on scene. Because of the large crowd on scene, it was difficult to speak to the parties involved in the incident.

On scene, I was able to locate one of the callers, Maya L. GARRETT (F/B, 01-05-00). I explained to GARRETT who I was and asked her to explain the situation to me. GARRETT stated that on today's date, at approximately 12:13am, she was working as a driver for Fryerz, and was in the back area of the building, grabbing bags for deliveries, when her manager, identified as Haitham M. MUSTAFA (M/A, 08-22-98) got into an argument, where GARRETT stated she began to curse at MUSTAFA. GARRETT stated she was told she was fired, and MUSTAFA pointed a gun at her. GARRETT stated that before she left she wanted to use the bathroom, and while in the bathroom, MUSTAFA came in and dragged her out of the building. GARRETT stated she wasn't sure if she wanted to press charges, then later stated she did. GARRETT stated she was the one who called the subjects to the scene. Some subjects on scene claimed to be affiliated with a religious organization that wanted to talk to MUSTAFA regarding. Other/A majority of subjects on scene stated they wanted MUSTAFA to come out so they could "beat his ass." GARRETT and the subjects left/fled the scene before a report could be filed.

On scene, I spoke with MUSTAFA. I explained to MUSTAFA who I was and asked him to explain the situation. It should be noted that MUSTAFA was armed with a handgun in his pants pocket while on scene. MUSTAFA stated that on today's date, at approximately 12:00am, MUSTAFA caught GARRETT in the back room of the building, which is strictly off limits to drivers. MUSTAFA stated GARRETT knew this, and if she wanted equipment/bags, she has to request them. MUSTAFA stated that he told GARRETT this, and she began to curse at MUSTAFA, so MUSTAFA fired her and told her to leave. MUSTAFA stated he allowed GARRETT to use the restroom before being fired. MUSTAFA denied pointing a gun or attacking GARRETT. MUSTAFA stated he had to escort her out of the building because she was being belligerent. MUSTAFA stated the owner, Bassam "Sam" D. AL-RAMAHI (M/W, 04-29-84) has access to the footage.

On Sunday, April 3, 2022, I made contact with AL-RAMAHI and explained to him the situation. AL-RAMAHI stated he or another person with access to the cameras would be at Fryerz on Monday, April 4, 2022, to allow officers to view footage. AL-RAMAHI confirmed the appointment with me via text on Monday, April 4, 2022. Squad 3270 (P.O Randall PEREZ) made contact with AL-RAMAHI over two days to attempt to view footage, but AL-RAMAHI never honored the meeting times.

With this information, a license premise report was filed and a citation (J981JSX4GJ) was issued to MUSTAFA. Both GARRETT and AL-RAMAHI were notified of the outcome of this incident.

This report is written by PO Devin WHITFIELD, assigned to District Three, Late Power Shift.

On Friday, April 8, 2022 at 7:52 PM, PO Jeremie GAINER and I (Squad 3420) responded to Fryerz Restaurant, located at 2635 W Fond Du Lac Ave in the City and County of Milwaukee, Wisconsin for a Reckless Use of Weapon call for service. Upon arrival, I interviewed Daron D ROGERS (b/m, 05-24-97), who is a delivery driver for Fryerz, and who stated that another employee from Fryerz pointed a firearm at him during an argument.

Interview of Daron D ROGERS (b/m, 05-24-97)

I interviewed ROGERS outside in the parking lot of Fryerz. ROGERS stated that he arrived at Fryerz after finishing the rest of the deliveries for his shift. ROGERS stated that when he arrived, another employee who he could only identify as "OMAR" exited the restaurant and retrieved a long black gun from a vehicle in the parking lot. ROGERS stated that OMAR then pointed the gun at him. ROGERS stated that he then went inside the restaurant and reported the incident to other staff members. ROGERS stated that OMAR then followed him into the restaurant and the two of them started arguing. ROGERS stated that he then left the location and called for police.

ROGERS stated that he has been having ongoing issues with other staff at the location, including an incident two weeks prior where another staff member pointed a gun at him.

Interview of Witness: Melinda L SLICK (w/f, 04-06-85)

I interviewed a witness to the incident, identified as Melinda L SLICK (w/f, 04-06-85); in the back of the restaurant. SLICK is a cashier at Fryerz. SLICK stated that when ROGERS arrived back at Fryerz after making deliveries, OMAR exited the restaurant with a gun and approached ROGERS. SLICK stated that she went outside to see what would happen, and she observed OMAR pointing the gun at ROGERS. SLICK stated that ROGERS and OMAR argued, and then ROGERS went inside of the restaurant to tell staff members what happened. SLICK stated that OMAR followed ROGERS into the restaurant, and that he became angry and continued to be argumentative to the point that he had to be restrained by other staff. SLICK stated that she believed the gun that OMAR pointed at ROGERS was a BB gun, and that she heard OMAR tell ROGERS, "It's a BB gun."

Interview of Manager: Haitham M MUSTAFA (w/m, 08-22-98)

I interviewed the night shift manager of Fryerz, identified as Haitham M MUSTAFA (w/m, 08-22-98), in the back of the restaurant. MUSTAFA stated that the incident occurred prior to his arrival for his shift and that he did not witness the incident. MUSTAFA showed us where the gun that OMAR pointed at ROGERS was hidden. PO GAINER retrieved the gun from an upper storage area in the kitchen of the restaurant and confirmed that the gun was a BB gun. The gun was a black Sig Sauer MC .177 cal CO2 powered air rifle.

MUSTAFA stated that he did not have any further information regarding Omar's identity, other than a phone number of 414-400-8213. MUSTAFA also stated that he did not have any access to the restaurant's video surveillance system and that we would have to follow-up during the morning hours to obtain video from management.

Forms Issued

ROGERS was issued a form PF-6 (Milwaukee Community Contact Card) and was advised that OMAR would be issued a citation for Disorderly Conduct once he is identified.

This report is written by Police Officer Joseph BINTER, assigned to District Three, Late Power Shift.

On Tuesday, August 2, 2022 at approximately 12:30 am, while working on Squad 3441 with PO ALVAREZ we were flagged down by the manager of Fryerz (Food Vender, located at 2635 W Fond Du Lac Ave).

Haitham M MUSTAFA (w/m 08/22/98) showed Officer ALVAREZ and I a video of a customer who displayed a small handgun and made threats to harm MUSTAFA. It should be noted that MUSTAFA felt his life, patrons, and other employers were in danger, as a shopkeeper of FRYERZ MUSTAFA was armed with a handgun and also displayed his weapon deterring any violence from the suspect. The suspect left the store. MUSTAFA is a victim of D/C while armed. See attached Incident report for further detail.

This incident was captured on store video. MUSTAFA sent the video to Officer ALVAREZ'S evidence.com account.
