Thank you for your attention to this matter. I look forward to the opportunity to present my case and seek a favorable resolution.

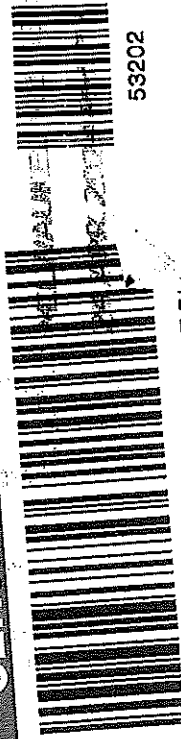

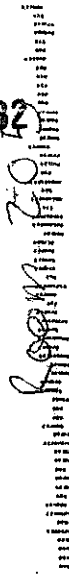

Dear Mr. Denson:

We are in receipt of your claim for damages sustained to your vehicle, on December 10, 2023, allegedly by an active fire hydrant that sprayed water onto your 2013 Lexus ES350, while it was parked at or near 2872 N. 19th Street.

Our investigation reveals that the vehicle in the video you submitted appeared as a dark SUV and was parked less than 10 feet from the fire hydrant. Per Wis. Stat. 346.53(3) "Parking prohibited in certain specified places, no person shall stop or leave any vehicle standing in any of the following places except temporarily for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator so that it may promptly be moved in case of an emergency or to avoid obstruction of traffic:

(3) within 10 feet of a fire hydrant, unless a greater distance is indicated by an official traffic sign."

Because your vehicle was parked nearer than 10 feet away from the hydrant, the City is not liable for any damages. As such, we are denying your claim.

Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

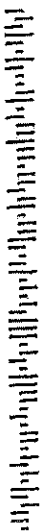
