There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. **Notice for applicants with warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

Ms. Hart –

Good afternoon and thank you for contacting me on this. I did speak with [redacted] who circulated the petition on Gene's Super Club that you mentioned and he gave it to me. I have added that petition to the establishment's file so that when they come up for licensing renewal, the committee will have it to consider. You're not the only person who is raising your voice on this issue – and I'm glad that you're doing it. I've copied the City of Milwaukee License Division on this email. Whenever you see or experience any disturbance caused by Gene's please email and report it there so that we can continue to gather evidence about what's happening in the neighborhood.

Also, I'm sending you the owner's phone number so that you (and neighbors) and reach out [redacted]. His name is James Robinson. If you call, leave a message otherwise you can text him at that number as well.

I know that these problems are difficult and have only been exacerbated by the fact that we are working to reconstruct North 60<sup>th</sup> Street which diverts some of that traffic farther into the neighborhood from the busy street. That being said, you and your neighbors should not have to deal with the consistent problems that you're facing and I'm certainly going to work with you to remedy them.

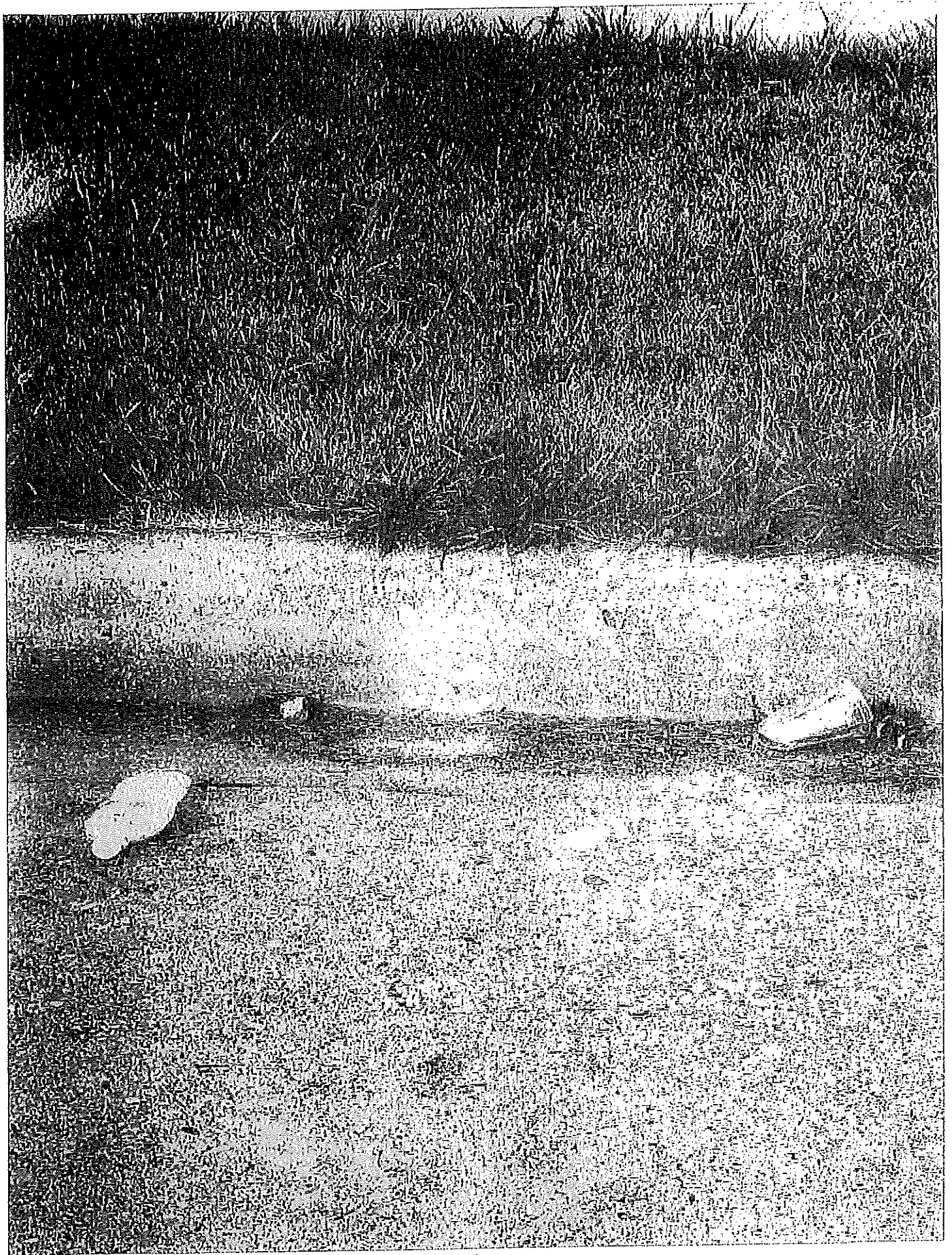
Good Morning,

What can be done about this???? Can the neighbors sit in on the next court review for their liquor license?

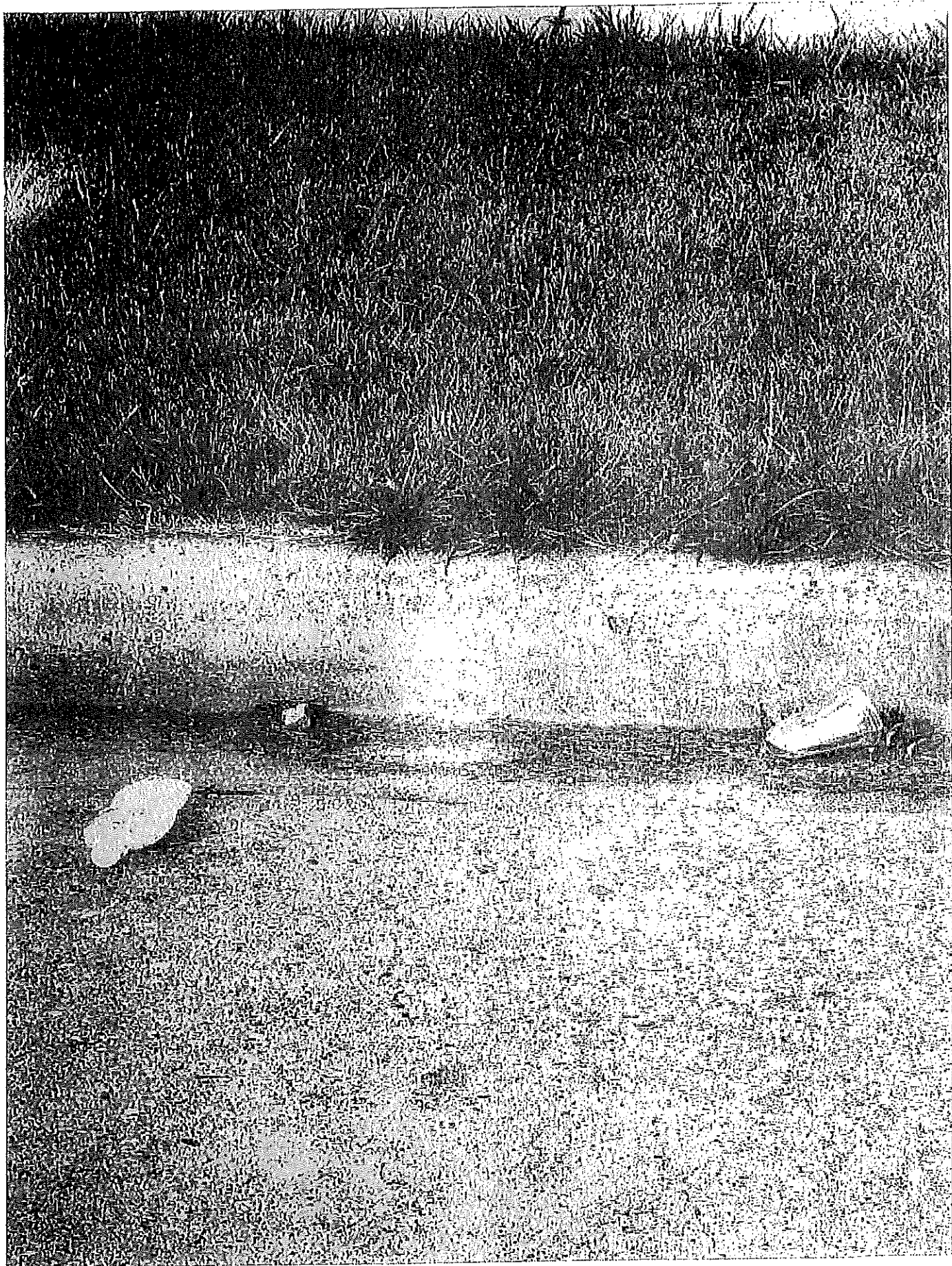


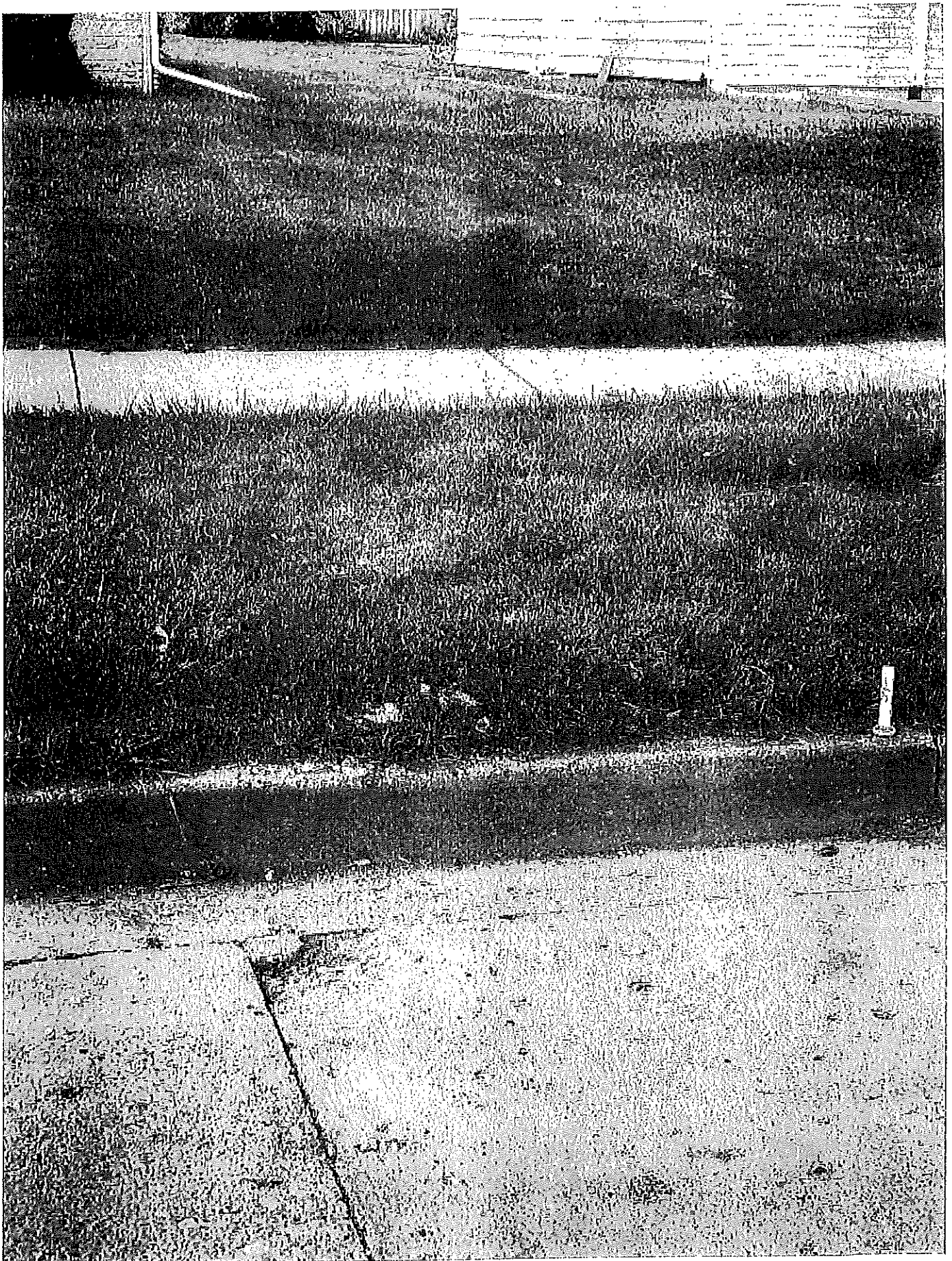






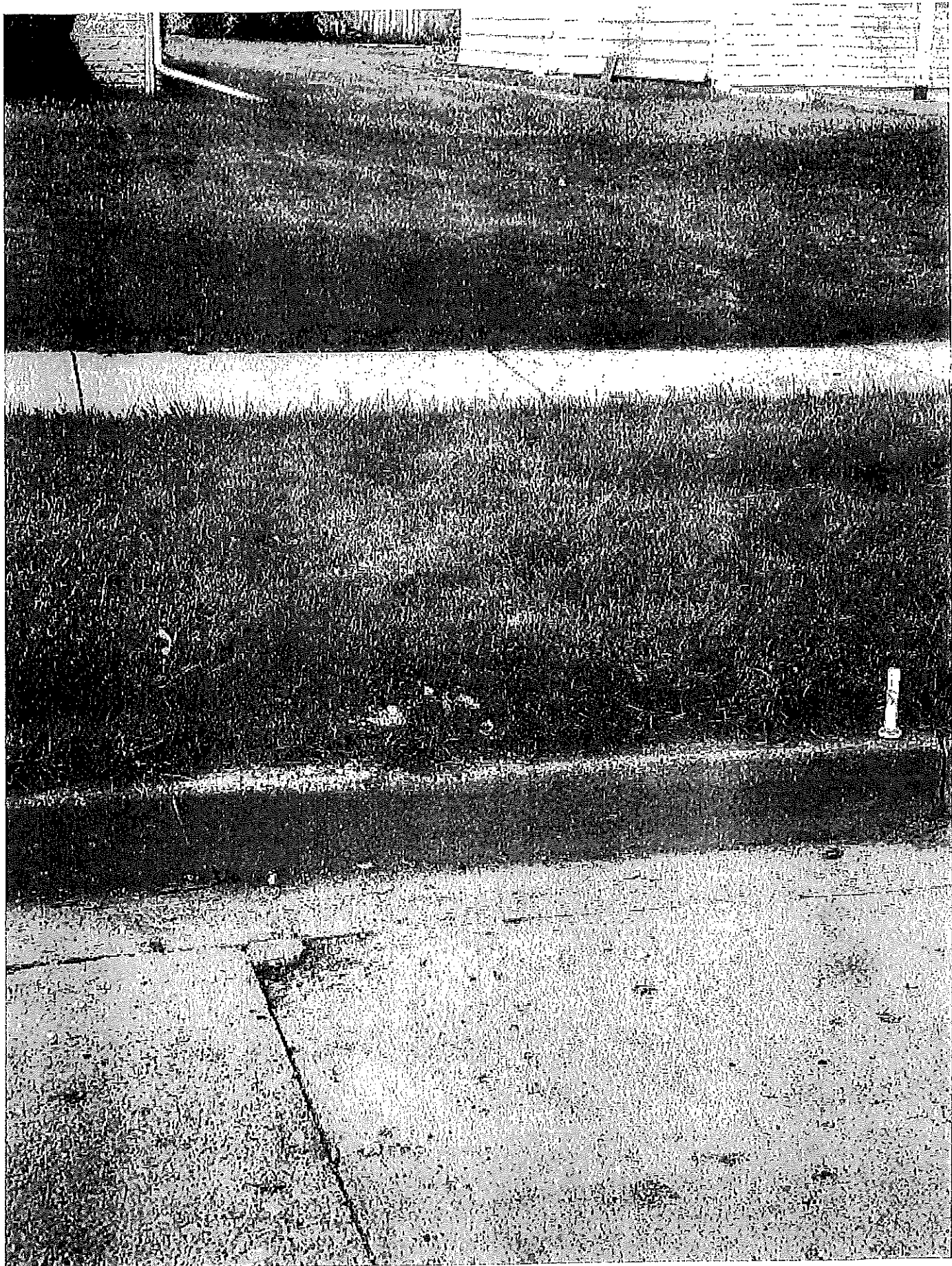












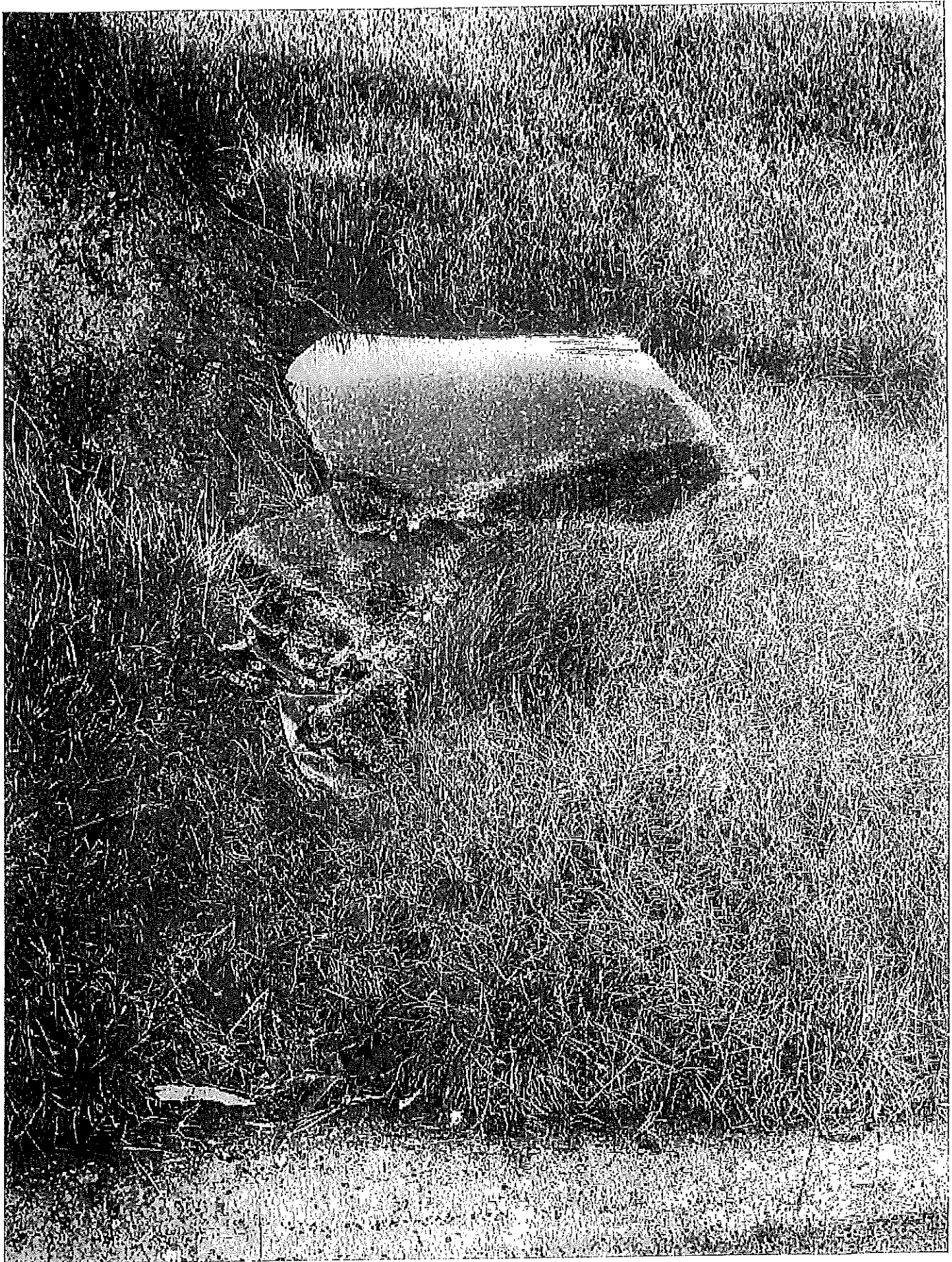

This is \_\_\_\_\_ at \_\_\_\_\_ There were three separate shootings in the month of September and the police were called each time. The third time, there were five or six men and one woman involved in a fight. Someone was cut and blood was left on the ground in the back of our alley. A bloody t-shirt was found in the morning. Almost every night it's chicken wing or tacos or something and the patrons litter over the neighborhood. There have already been three more shootings during the first week of October. October 3,

there were five shots fired. October 4, there were six shots fired. Finally, the early morning hours of October 5, there were two shots fired. Myself and my neighbor \_\_\_\_\_ and \_\_\_\_\_ has observed patrons using her steps as an after hour hangout when the bar closes. They also fill her garbage with bottles and cans of liquor.

Myself and other neighbors can't sleep until after the bars closes or longer if the patrons stand around and loiter. The bar is beginning to be a nuisance. Do not forget about the shooting that left a child without a mother. The second shooting got someone in the stomach

Re: Notice of Nuisance Premises

Dear James Robinson Jr:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at Address ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") 80-10, Chronic Nuisance Premises. As an individual or entity that is licensed or subject to a license in the operation of a business upon the premises, you are a responsible party for abating the nuisance activities occurring at the premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

1. On February 01, 2020 at approximately 2:34A.M., Squads were dispatched to Gene's Supper Club located at 4323 N 60<sup>th</sup> St regarding a shooting complaint. Upon investigation, officers discovered one person was shot and that the scene was in the parking lot of the premise. This is a violation of MCO 80-10-2-c-1-k and MCO 80-10-2-c-1-L
2. On August 14, 2020 at approximately 1:06.M., Squads were dispatched to Gene's Supper Club located at 4323 N 60th St regarding a shooting complaint. Upon investigation, officers discovered one person was shot and that the scene was at the premise. This is a violation of MCO 80-10-2-c-1-k and MCO 80-10-2-c-1-L
3. On October 25, 2020 at approximately 2:27P.M., Squads were dispatched to Gene's Supper Club located at 4323 N 60th St regarding a shooting complaint. Upon investigation, officers discovered one person was shot and that the scene was at the premise. This is a violation of MCO 80-10-2-c-1-k and MCO 80-10-2-c-1-L

As a consequence, you may be subject to a collections action for the cost of future enforcement for any of the nuisance activities listed in MCO 80-10-2-c that occur at the premises.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will be charged. Please contact the Office of the City Clerk at (414) 286-2231 for additional information.

If you timely provide a written course of action, I shall evaluate it to determine if it is a reasonable attempt at abating the nuisance activity. You will receive a written response whether your proposed course of action is accepted or rejected. If accepted, you will have 45 days from the date of that notice of acceptance to implement the course of action.

If you propose a course of action that is rejected by me or you fail to timely respond to this request and a subsequent nuisance activity occurs on or after 13 days after receipt of this notice, or if you timely appeal this notice of nuisance premises and this nuisance premises determination is affirmed, the premises will be subject to a collections action for the cost of any police services and enforcement.

It is highly recommended that you obtain records relating to police responses regarding the premises. You may obtain these records from the Computer Aided Dispatch System (CADS) at the Open Records Section of the Milwaukee Police Department (District Three Station, 2333 North 49<sup>th</sup> Street, Second Floor) between 8:00 AM and 3:45 PM. There is a cost of 25 cents per page for these records.

Please review the following examples of nuisance abatement measures that you may include in your written course of action to abate the nuisance activity. These suggestions are not exclusive, may not apply to the particular premises, and you may propose other nuisance abatement measures that would be appropriate under your particular circumstances.

- Exchange names and telephone numbers with the owners and operators of neighboring premises.
- Participate in a local block watch, neighborhood association, and business association.
- Attend the monthly crime prevention meetings conducted by the local Milwaukee Police District Community Liaison Officer who can be contacted at CLO Phone Number.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cuts of baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, empty cigar wrappers, burned hollow tubes, etc.
- Install "No Loitering" signs in the front and rear of the exterior of the premises. This signage permits police to cite loitering individuals in the yard and sidewalk area.
- Install "No Trespassing" signs in the front and rear of the exterior of the premises. This signage permits police to cite trespassers in commercial properties.


- Participate in the E-Notify system for email updates regarding the premises.
- Regularly file open records requests for Milwaukee Police Department Computer Aided Dispatch System (CADS) reports regarding the property.
- Institute a standing complaint with the local Milwaukee Police district station that will allow the police department to remove any individuals loitering on the property.
- Draft and serve a no trespassing order against identified nuisance persons and provide the local police district station a copy of the served order.
- Install and maintain a digital security surveillance system.
- ~~Employ security personnel.~~
- Enroll in Respect 21 or MARTS program (contact CLO for more information)
- Make repairs to windows, doors and lights and improve landscaping.
- Participate in the City Clerk's Office Pivot Program workshop for businesses. Information on this training program may be obtained by emailing [pivot@milwaukee.gov](mailto:pivot@milwaukee.gov).

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has received, reviewed, and accepted your proposed course of action for abatement of nuisance activities occurring at the premises located at 4323 N 60<sup>th</sup> St ("the premises"), pursuant to Milwaukee Code of Ordinances ("MCO") 80-10, Chronic Nuisance Premises.



8. On 03/25/12 at 2:34 am, Milwaukee police were dispatched to 4323 N 60<sup>th</sup> Street for a Shots Fired Complaint. Investigation revealed two patrons of Gene's Supper Club were exiting the bar and began arguing with each in a parking lot, when an unidentified male that was standing near the two patrons, fired a shot in the air. The females ran the parking lot when another unidentified male walked up behind the shooter and was shot. The suspect then ran in between two yards dropping the magazine and a holster in a yard. The suspect then ran back to Gene's Supper Club where he threw his gun to a security guard, identified as Michael Miller with the suspect entering the bar. Officers located the suspect in the bar and place him into custody. The gun was recovered from Miller who provided a statement to police as well as other witnesses. No part of this incident occurred inside the bar.
9. On 04/03/12 at 1:00 pm, District Seven personnel and James Robinson Jr met to discuss several dangerous incidents that occurred at his bar and to provide helpful tips to reduce future occurrences. Robinson was advised that he is responsible for the safety of his patrons while they walk to and from their vehicles whether they are parked in the parking lot or across the street from the bar. Police also advised Robinson that he is responsible for his patrons littering in the neighborhood. Robinson stated to police that every year, he goes door to door in the neighborhood to listen to citizen complaints that are directly related to his business. Robinson stated he enforces a dress code and that he only allows people thirty and older to enter the bar. Robinson stated he has unarmed security guards who are from Extreme Security. Robinson stated he trusts his security staff and that they have worked for him for approximately two years. Robinson further stated he has one guard at the door checking ID's of patrons as they enter and that his staff also uses a wand to check for weapons. Robinson stated he has twelve cameras at his establishment, but only one is on the outside. Police were going to provide a security survey for Robinson. Meeting concluded.
10. On 08/08/12, the agent for Gene's Supper Club, James Robinson, received a nuisance letter from an officer at District Four in regards to two violent crimes that occurred at 4323 N. 60<sup>th</sup> Street within one year. On 08/18/12, Robinson sent an email stating that he did not feel that 80-10 was warranted and said that there were false accusations made regarding incidents at Gene's Supper Club. On 08/27/12, the Administrative Appeals Board received an appeal from Robinson regarding 80-10. A meeting was arranged with Robinson to discuss issues that were occurring at his club. The meeting took place on 09/11/12 at 10:00 am. Present were officers from District Four, ACA Nicholas DeSiato, and Safe and Sound partner Michael Totoritis. An employee of James Robinson who works as security for the club was also present. At this meeting, discussion was made of dropping the outstanding 80-10 nuisances if Robinson agreed to better security measures at his club. Also discussed were several issues that police had had with club in the past which included the following:
  - Raise age limit to 30+ to enter the club
  - Barred 10 patrons completely from entering the club
  - Capacity is 160
  - Use of cones to guide people out of the parking lot
  - Women would always go through a weapon wand, men would be patted down but not through a scanner
  - Security would have a ID scanner and a dress code
  - Prohibit troublemakers from re-entering the club; however, the bouncers do not have a formal process regarding "banned people"

According to Robinson, there have been more issues with women fighting and throwing drinks  
Downloading issues of DVDs off from the video system

Robinson agreed to the age limit of 30+, banning people for good if they commit a felony on his premise, scanning drivers license and everyone with a wand.

Robinson was to submit this written plan by October 1, 2012. On Wednesday, September 26, 2012 Robinson submitted a new written course of action stating the above policy changes.

11. On 01/20/13 at 1:52 am, Milwaukee police were dispatched to 4323 N 60<sup>th</sup> Street for a Shots Fired complaint. Upon arrival, police observed two bullet holes in front of the location and patrons exiting tavern. No shooting victims were found. Officers recovered two casings from the parking lot of the tavern. Officers spoke with James Robinson who stated there was a fight inside the club that involved several patrons with security escorting several of those patrons outside to the parking lot. Robinson stated that shortly after those patrons were escorted out, there were shots fired into the tavern, from the parking lot, by an unknown subject. A security guard, Michael Miller, observed the shooting and provided police with his statement. Miller stated the shooter has been in the club on other occasions, but that he did not know the suspect's name. Police were later advised of a shooting victim at St Joseph's Hospital. The victim stated to police that a fight took place inside the Gene's Supper Club and as she was gathering up her belongings, she exited the club when she heard one gunshot and turned to walk back into the club, when she realized she had been shot to the top of her head. The victim then made contact with her aunt, who was also in the club, and had her aunt drive her to the hospital. Officers notified Robinson of the shooting and requested video surveillance of the incident. Case is pending.

12. On 02/06/13 at 9:41pm plainclothes officers conducted an investigation at Gene's Supper Club at 4323 N. 60<sup>th</sup> St. The officer and the sergeant observed two security guards standing in the parking lot in front of the entrance. One of the security guards approached the sergeant and the other walked into the building. The sergeant was patted down before he was allowed to enter the building and he was not asked for identification. The female officer was not asked for identification. The officer had identification in her very large purse. There was no age verification scanner being used at that time. The officer's ID reflected that she was 24 years old and not 30 years old which is the age restriction. The security guard did not use a wand scanner to check the female officer, her purse or the male sergeant for weapons. The security guard did not look in the purse.

13. On 02/18/13 at 4:15pm officers met with the applicant at Gene's Supper Club located at 4423 N. 60<sup>th</sup> St. regarding compliance with mandatory security measures. The applicant showed the officers the security system which was located on the second floor. The applicant had twelve cameras and added four new cameras: two for the inside of the establishment and two for the outside. The security system only recorded for one week and the footage could not be transferred onto a disc. The officer stated to the applicant she didn't think the measures he took met the ordinance requirements and she would check and get back to him.



After verifying MCO 68-4.3 and 105-91 the officer contacted the applicant to advise him his security system did not meet the criteria for the ordinances. Specifically all digital video records shall be stored on CD-R's or DVD-R's and maintained in good viewing order for 30 days after recording and made available upon request to the licensing committee and law enforcement officers. In addition he was advised that cameras installed in a Class B tavern shall be installed so as to provide a clear image of the entire premises as described on the license as well as the public right of way abutting the premises and any off street parking lot used expressly for patron parking. The applicant was advised to read the above listed city ordinances so he would not be in violation of the letter.

14. On 03/04/13 at 7:39pm officers were dispatched to Gene's Supper Club to investigate a complaint of a possible suspension violation. The officers made contact with the applicant and advised him of the complaint. The applicant showed the officers both the front and back bars and stated that he had locked up all of the liquor until the suspension is lifted. No liquor was observed by the officers. The applicant showed the officers an email from the City Attorney's office indicating that Gene's Supper Club could remain open during the suspension and serve food as long as they were closed by midnight.
15. On 04/02/13 an officer received a telephone call from the applicant regarding Gene's Supper Club and his compliance with security measures. The applicant stated he updated his security system by adding an additional camera and having the capability to record for 30 days. The officer met the applicant at the premises and he showed the officer the updated system. The officer observed that he installed an additional camera, which captures 60<sup>th</sup> St. The officer stated the applicant's security system appears to be in accordance with MCO.
16. On 04/12/13 officers were dispatched to an Entry at 4323 N. 60<sup>th</sup> St. Securitas Security was on the scene and well as the applicant. Officers checked for suspects but none were found. Security camera footage showed at 2:59am a suspect throw a landscape stone through a glass door and leave. The first suspect returned at 3:03am with another suspect acting as a lookout. Suspect #1 entered the bar through the broken window and picked up the cash register. The video further shows suspect #1 exit the bar with the cash register and he and suspect #2 flee southbound.
17. On 07/30/13 at 11:03 pm officers conducted a licensed premises check at 4323 N. 60<sup>th</sup> St. Officers identified three employees; two bartenders and a security guard. Both bartenders had Class D operator's licenses. The security guard was posted at the main entrance and conducts ID checks of patrons and pat downs of outermost clothing. The security guard is unarmed and did not have equipment like metal detector wands or an ID scanner. No violations were found and the applicant was notified via voice mail of the licensed premises check.

They advised him all patrons must be out of the tavern by the 2:00am closing. He stated they did not pour any of the drinks after 2am and drunk people are difficult to deal with. The case was ordered in to the DA's office.

31. On 08/05/2020 officers conducted a license premise check at Gene's Supper Club, 4323 N. 60<sup>th</sup> St, based on aldermanic complaints of loud music, parking violations and littering. The officers observed a vehicle exit Gene's parking lot, drive west on W. Marion Av and turn up their music to an excessive level. The officers stopped the auto and observed two open bottles of liquor on the passenger seat. The driver stated he bought one of the bottles from Gene's Supper Club. The driver was issued citations.
32. On 08/08/2020 at 2:00am officers conducted a license premise check at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The officer observed approximately 20 vehicles illegally parked in the area. The officer issued 2 citations to vehicles blocking the alley. The owners of those cars stated they were coming from Gene's. The officer was pulled from the assignment for a higher priority call but heard numerous vehicle playing loud music from the parking lot and adjacent alleys.
33. On 08/09/2020 at 2:14am officers conducted a license premise check at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The officer observed 8-10 cars illegally parked on W. Marion St and 10 vehicles parked on N. 60<sup>th</sup> St in an area that is closed for road construction. The officers heard a car parked in the parking lot playing loud music for 10 minutes. The security guards made no attempt to address the loud music. The officer spoke with the applicant, who was on scene. The officers advised him of the violations and he admitted his car was one of the ones parked on N. 60<sup>th</sup> St. He was advised to not park on the closed roadway in the future.
34. On 08/14/2020 at 1:07am officers were dispatched to Gene's Supper Club, 4323 N. 60<sup>th</sup> St, for a Shooting. The investigation revealed the victim and suspect were in the bar and had an argument. Both subjects went outside and armed themselves with firearms. The subjects fired shots at each other and the victim was shot 5 times. A total of 32 casings were recovered in the parking lot.
35. On 10/25/2020 at 2:23am officers investigated a shooting at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The victim stated he was leaving Gene's Supper Club at 2:30am and was walking to his car when he heard shots being fired. He got on the ground to take cover behind a car at 6029 W. Marion St. He did not see who was shooting or where they were coming from. The victim had wounds to his leg and hand. On 11/04/2020 an officer conducted follow with the Health Department regarding the current capacity of Gene's. The officer was advised by Rose at the Health Department that Gene's has submitted a Covid-19 plan but she was not able to say if the plan was approved. The officer stated that the tables and bar stools did not appear to be placed 6 feet apart. Rose stated they have received complaints regarding Covid violations from this location and would pass on the information to the inspector.
36. On 11/19/2020 a meeting was held at District 7 regarding recent incidents at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The applicant was present and stated the construction on N. 60<sup>th</sup> St has been causing traffic to back up when customers are leaving the tavern. He also stated he has noticed a change in his customers since the start of the pandemic. The applicant stated he has security inside and outside to help maintain order. He also has security cameras and an ID scanner. He does not allow loitering but does give people several minutes to leave once they are asked. He stated he wants to work with the Police to improve his safety plan to prevent future incidents.
37. On 12/22/2020 at 12:27am officers were dispatched to a Battery call at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The officers spoke with an employee, who stated a female was upset stating her car was stolen. She became aggressive with him stating she did not think he was doing enough to help her. The female threatened to spit on him and lunged at him, causing him to

pepper spray her. The female walked off. The officers located her and she began yelling at them and attempted to spit on them. She was arrested. The employee stated the female had never been in the bar.

38. On 01/06/2021 at 2:08am officers were dispatched to a Shooting at Gene's Supper Club, 4323 N. 60<sup>th</sup> St. The officers located a vehicle running in the parking lot that had been hit by gunfire. They also located 25 casings of different calibers. The witnesses stated an accident occurred in the lot, which led to occupants of both vehicles to shoot at each other. One victim was transported by private vehicle to the hospital, with a gunshot wound to the back. The officers located another victim at 6227 W. Medford Av, with a gunshot wound to the leg. The officers were able to confirm the victims and suspects were customers of Genes by the card reader and video provided by the business.

A shooting victim arrived at St. Joseph's Hospital (5000 W. Chambers St.) and the initial report that the victim was shot while aboard a "party bus" which had just left Gene's Supper Club. P.O. Rebecca RODRIGUEZ and I, who were assigned to Squad 7468, originally responded to St. Joseph's Hospital to assist with crowd control. Once secured, P.O. RODRIGUEZ and I responded to Gene's Supper Club and checked the area for any evidence regarding the shooting.

P.O. RODRIGUEZ was able to locate 6 .45 Auto casings on N. 60th St. in the southbound lane where W. Marion St. intersects N. 60th St. The area was secured with red police crime scene tape and the casing were marked with orange cones. I went into the tavern and spoke with the owner, James T. ROBINSON (B/M, 6/22/74), who stated that he already had the surveillance video cued up to the time just prior to the video. ROBINSON was fully cooperative in allowing police to review and recover all video.

Additionally, multiple security guards remained inside the tavern and were fully cooperative with the investigation.

Witnesses aboard the "party bus" stated that the bus arrived to Gene's Supper Club at approximately 2:00 A.M., all of the passengers aboard the "party bus" entered the tavern and left the tavern at approximately 2:30 A.M. No witnesses made an statements about any problems with any other individuals while at Gene's Supper Club.

Detective Jeffrey EMANUELSON on Squad 9323 and Detective Michael FEDEL on Squad 9324 arrived on scene and took over the investigation.

On Friday, June 26, 2020, at 3:05 A.M. Squad 7468 (P.O. Zachary CVETAN and I) was dispatched to 4568 N. 51st Bl in the City and County of Milwaukee, WI for a battery complaint.

Upon arrival, I spoke with the caller who was later identified as Trimaime M. DAWSON (b/m, 12/13/83).

DAWSON stated he was at Gene's Super club located at 4323 N. 60th St in the City and County of Milwaukee, WI partying with some friends and family. DAWSON stated around 1:15 A.M. he stepped out of the club to smoke a cigarette. DAWSON stated when he finished his cigarette he attempted to reenter the club, but one of the security guards who he knows as "Mike" refused to allow him back in. DAWSON stated he told Mike he was just inside the club and to let him back in. DAWSON stated Mike told him, he couldn't get in right now because of being over capacity. DAWSON stated he told Mike if he wasn't allowed back in then somebody should go get his credit card from the bar. DAWSON stated he got more upset when people behind him were able to get in the club before him. DAWSON stated he will admit that he was drunk and probably was talking "shit", but it doesn't give the security right to attack him. DAWSON stated while he was turned around talking to someone else Mike out of nowhere punched him four times for talking "shit." DAWSON stated he shoved Mike away from hitting him. DAWSON stated after Mike stopped him, he observed an armed security guard come from around the corner with his gun out and said, "What's going on." DAWSON stated he said to the other security officer, "Mike just jumped on me, you ain't going to call the police?" DAWSON stated the armed security officer just walked away. DAWSON stated he walked down the street from the club and attempted to call his friends. DAWSON stated when his friends eventually came out of the club, they drove him home and attempted to patch up his laceration. DAWSON stated after several fail attempts to stop the bleeding from his lip, he figured he needed stitches and called the police.

DAWSON was conveyed to St. Joseph's hospital by Paratech 125. DAWSON was admitted at 3:37 A.M. and seen by PA Paul STREIFF. Before leaving the hospital I asked PA STREIFF about DAWSON lip. PA STREIFF stated the laceration to DAWSON lip will need "lots" of stitches. DAWSON received six stitches to the inside of his upper lip.

### Observation

I observed a medium size laceration on the inside upper lip area of DAWSON lip. DAWSON's lip was still actively bleeding. DAWSON had fresh and dry blood on his hands. DAWSON was wearing a shirt that had dry blood stains on it.

After leaving the hospital, P.O. CVETAN and I drove to GENE's Super club to check for a scene. We observed blood on a ledge outside of the club near the front entrance. We were unable to make contact with anyone at the club due to it being close.

It should be noted DAWSON admitted to being drunk and I could smell the liquor coming from DAWSON. DAWSON demeanor was up and down. DAWSON didn't like it was "too many" cops in the area. DAWSON thought we were going to arrest him. DAWSON caught an attitude and no longer wanted police services.

On my next tour of duty which was Sunday, June 28, 2020 Squad 7468 (P.O. Andrew WILKIEWICZ and I) checked on DAWSON. DAWSON was sober and wanted to talk about the incident. It should be noted DAWSON story remained the same and DAWSON stated he would like to prosecute. DAWSON end up needing six stitches and has medical paperwork regarding.

Being on the tavern squad we were able to identify "Mike the Security guard" as Mike J. MILLER (b/m, 11/28/89). We did a photo array with DAWSON. DAWSON was able to successfully point out MILLER during the lineup. The lineup can be seen via body camera. A copy of the photo array was placed on inventory (# 20022510).

## Interview with Mike J. MILLER (b/m, 11/28/89)

I made a phone call to MILLER and asked if there somewhere we could meet for a statement. MILLER agreed to meet us at District Seven (3620 W Fond Du Lac AV).

MILLER stated DAWSON was told during the night if he comes out the bar for a smoke that he will have to wait back in line because of the 25% capacity Mayor's order. MILLER stated he allowed DAWSON to skip the line the first time around, but DAWSON came out for another smoke during the night. MILLER stated this time he told DAWSON that he will have to wait in the back of the line and wait to get in. MILLER stated DAWSON got upset and was cussing him out. MILLER stated DAWSON was too close for his liking and asked DAWSON to back away from him. MILLER stated DAWSON refused to back up, instead continued to be up close to him and was yelling directly in his face. MILLER stated while DAWSON was in his face, DAWSON "intentionally" spit on him. MILLER stated the spit landed on his neck. MILLER stated he admitted he got upset and punched DAWSON about four times. MILLER stated this occurred about 1:15 A.M. near the front entrance of the club. MILLER stated after the fight, DAWSON left the area and came back 20 minutes later with people and guns.

MILLER stated he didn't call the police because he didn't think he needed to. MILLER stated he been in situations like this before and people don't want police involved.

P.O. WILKIEWICZ and I called the owner of GENE's James regarding the incident. James stated MILLER informed him of the incident and that it should be captured on video. We attempted to meet with James at the bar to view the footage, but was unable to due to the number of calls.

MILLER was ordered into the DA office with the approval of 7411 (Sgt. Remero DUNKLEY).

Gene's Supper Club, 4323 N. 60th St. regarding parking issues around the tavern, loud music coming from vehicles associated with the tavern, and littering around the neighborhood stemming from the tavern.

On Sunday, August 9, 2020 at approximately 2:14 A.M., Squad 7468 (Police Officer Zachary CVETAN and I) conducted a tavern check at 4323 N. 60th St. (Gene's Supper Club).

Upon arrival, I observed approximately 8-10 cars parked illegally on W. Marion St. between N. 60th St. and N. 61st St. on both the north and south side of the street where no parking signs are displayed.

In an effort to avoid traffic jams on W. Marion St., which commonly occur on the weekends, I used my fully marked MPD squad car to block traffic on W. Marion St. at N. 60th St., which appeared to be effective.

The southbound lanes of N. 60th St. are currently under construction and are closed and blocked by barricades. I observed one of the barricades was moved and approximately 10 vehicles parked in the southbound lanes of N. 60th St., which are closed.

While waiting for the patrons to leave the tavern, I observed at least one vehicle in the parking lot of Gene's Supper Club playing excessively loud music for at least 10 minutes and did not observe any of the several security guards address the vehicle playing loud music.

I spoke to the owner, James T. ROBINSON (B/M, 6/22/74), who was inside the tavern and informed him of the aldermanic complaint. I also addressed the issues I observed that evening including the vehicles parking on N. 60th St. and ROBINSON stated that he was one of the vehicles that was parked on N. 60th St. ROBINSON was advised not to park on a closed road.

The owner of the bar is James T ROBINSON Jr (B/M, 06/22/1974) and the license is a class B Tavern License effective from 08/03/2020-03/02/2021.

Non fatal shooting in the parking lot of Genes Supper Club. A group of people were standing on the East side of the parking lot next to a group of Trikes. An argument ensued.

Victim, Ray C. TRUSS Jr (B/M 01-29-1980) and suspect, Dontae W. TRAMMELL (B/M 09-10-86) faced off. Both had handguns drawn. Suspect fired multiple shots at the victim striking the victim at least 3 times, once in the buttock, one in the lower abdomen and once in each thigh.

TRUSS fell to the ground and attempted to rack his gun several times. Another subject approached TRUSS, took his handgun away and handed it to another b/m subject. Several other subjects in the parking lot exchanged gunfire.

There were 32 casings located on scene. TRUSS was transported to Froedtert Hospital by MFD Med 16. TRUSS was admitted to Froedtert Hospital at 1:41 am and treated by Dr Lewis SOMBERG. He had 5 entry points on his person.

It should be noted, several witness statements place TRUSS and TRAMMELL in the bar when the argument ensued which led to the shooting incident in the parking lot.

*Left Inner Thigh*

On Sunday, October 25, 2020, at approximately 2:48 A.M., I, Det. Anderson was instructed by Lieutenant William Sheehan to respond to a "Shooting" at "Gene's Supper Club" located at 5323 N. 60th St.

I, Det. Anderson relocated to Froedtert Hospital to interview Jenkins. I observed Jenkins on the hospital bed while medical staff viewed his injuries and later requested ex-rays. Jenkins complained of pain to his hand and leg; Jenkins was given pain medication to relieve the pain. The nurse said although Jenkins had been given pain medication it would be "Ok" for me to speak with Jenkins and that they were waiting for ex-ray results.

Jenkins stated he was walked outside the club leaving "Gene's Supper Club" at about 2:30 A.M., and walked toward his car, a black Nissan (type and year unknown), when someone started shooting. Jenkins stated he got down on the ground he heard gunshots. Jenkins stated he didn't know who fired the gunshot at him nor did he know where the shots were coming from. Jenkins said he drove to the club alone but didn't remember the time he drove to the club. Jenkins stated he did not have a gun nor did he fire gunshots. I was informed that Jenkins' demographical information were not revealed after a wanted check. I asked Jenkins if that was his correct name and he replied, "Yes!" Jenkins said he didn't know why his information didn't come back. I stepped away from Jenkins to conduct an additional search of his name; Jenkins was taken into custody for Resisting/ Obstructing an Officer after his information could not identify him

I also contacted Rose with the City of Milwaukee Health Department to inquire about capacity allowances for Gene's Supper Club. Rose advised me that if Gene's had an excepted safety plan they would be allowed to operate at 100% capacity, which is 160 people. However, Rose stated that the people would all have to be socially distanced. Rose was able to tell me that there was a safety plan submitted for Gene's Supper Club, but could not tell me if it was approved or not. While speaking with Rose I did advise her that, in my opinion, the size of the building would not allow for 160 people to be inside and maintain social distancing. Also, I advised Rose that when I was at the location, at approximately 4:00P.M. on 11/04, the tables were not placed six feet from each other and the chairs at the bar did not appear to be six feet apart from each other. I did note that while I was there no patrons were at the location. Rose stated that they have received numerous complaints regarding COVID violations and that she would pass the information I gave to the inspector assigned to this location.

Lastly, I was asked to document that when I have spoke with the owner, James Robinson, in the past he has been cooperative and did provide me with security video from the night of the shooting.

On Thursday, November 19, 2020 at 1:00 PM, a meeting was scheduled at Police District 7 (3626 W Fond Du Lac Av) with the owner of Gene's Supper Club Identified as, James T. ROBINSON, b/m, 06/22/1974 and District 7 Captain of Police Jefferey SUNN, Sgt Radan and the Community Prosecution Unit (P.O. CARLONI). This meeting was held to address the recent shootings that have taken place in relation to the establishment and to develop resolutions to prevent future shootings.

During the meeting ROBINSON explained that one of the issues he recently observed with his business is the construction occurring on N 60th St, which was causing a back up of traffic when leaving the establishment and creating issues within the surrounding neighborhood. ROBINSON stated he also observed a change in his patrons since the pandemic started, ROBINSON stated people's attitudes of have changed.

ROBINSON stated he has several security outside and inside to maintain order at the establishment and strict security checks when coming into the bar. ROBINSON stated he does have security cameras on the inside and outside of the business with a sign near the entrance stating their is surveillance. ROBINSON stated he also has an ID scanner at the front entrance as well as a dress code for patrons.

ROBINSON stated he dosen't allow loitering at his establishment but they do allow people a few minutes to leave the parking lot after being told to leave. ROBINSON stated he received correspondence with Milwaukee Police Department District 7, CLO P.O. Bowie BUCHNER to submitted a safety plan for his business prior to his license review.

ROBINSON stated he is willing to work with Milwaukee Police to improve and submit a safety plan for his business to prevent any future incidents from occurring at his establishment or as a cause of his establishment.

On Tuesday, December 22nd, 2020 at 12:27 am, Squad 7369 was dispatched to a Battery call for service at Gene's Super Club (4323 N. 60th St), which is in the City and County of Milwaukee.

Upon arrival on scene, we spoke with Vincent T. HARDY (M/B, 11-07-87) who stated that a female was being very disorderly and threatening towards him and the customers. HARDY stated that the female was yelling at him to call the police because her vehicle had been stolen and he wasn't helping her at all. HARDY stated the female became more aggressive towards him and yelling at him. HARDY asked her to step away from the bar across the street due to her harassing himself and the other customers. It should be noted this female was never inside of the bar at any point. HARDY stated the female then threatened to spit on him and then got into a stance with her hands up making HARDY believe the female was going to strike him. HARDY stated the female subject then lunged at him and HARDY fearing for his safety pepper sprayed the female subject. HARDY stated the female subject then walked westbound out of the parking lot into a backyard.

We then were able to make contact with Sonya S. DANTZLER (F/B, 10-17-85) who began yelling at officers as well. DANTZLER stated someone had taken her car and then began yelling at officer's more and then immediately requested a supervisor to the location. Squad 7310 responded and as he was speaking with DANTZLER, DANTZLER started the spit at myself and PO MOORE. We stepped back a couple steps, and then DANTZLER leaned back and then lunged forward while spitting in an attempt to spit at officers. DANTZLER was then arrested without further incident.

On Wednesday, January 6th, 2021 at approximately 2:08 a.m. Squad 7369 (P.O. Charles WORTHINGTON and myself in full duty uniform, operating marked Milwaukee Police Squad 031 and equipped with body worn cameras) responded to a Shooting call for service at the address of 4323 N. 60th St. (Gene's Supper Club) in the City and County of Milwaukee.

We arrived to the location from northbound on N. 60th St. We turned westbound onto W. Marion St. to enter the parking lot of the dispatched address. We observed a light colored sedan exit the parking lot and travel southbound onto N. 60th St. Responding squad followed the vehicle which was on the phone with dispatch. The vehicle was transporting a shooting victim to St. Josephs Hospital.

We entered the parking lot and observed a silver, 2001 Cadillac Deville bearing Wisconsin Auto Plate 297-VBZ parked in the lot. The drivers side door of the vehicle was ajar and we checked the vehicle to make sure no injured parties were in the vehicle. The vehicle had minor accident damage and several bullet strikes to it. Furthermore the Cadillac was surrounded by spent casings. The preliminary amount of casings was 25 spent casings of different weapon calibers. There were no shooting victims on scene.

While on scene we spoke with Michael MILLER a M/B, 11/28/89 who identified himself as Security for Gene's. MILLER provided the phone number for the owner of Gene's Supper Club who was identified as James ROBINSON Jr. a M/B, 06/22/74. P.O. WORTHINGTON called and left a voice mail for ROBINSON. MILLER further stated that the surveillance cameras could not be accessed at the time.

## Shooting Victims

Preliminary witness statements indicated that a vehicle accident occurred in the parking lot, a argument ensued between the occupants of the vehicles which escalated into a shooting.

A female shooting victim was conveyed to St. Josephs Hospital and later Froedtert Hospital. The shooting victim was identified as Zhane T. MCPIKE a F/B, 06/07/94. MCPIKE was shot in her back subsequently hitting her spine. A result of the shooting has caused paralysis to MCPIKE.

A male victim was located at 6227 W. Medford Ave. which is in close proximity to Gene's Supper Club. The second shooting victim was identified as Lavell M. GARRETT a M/B, 12/03/71 and was transported to Froedtert Hospital with a gun shot wound to his left leg. GARRETT was subsequently arrested for shooting MCPIKE.

Both MCPIKE and GARRETT informed Milwaukee Police detectives that they were patrons of Gene's Supper club that morning. The suspect Dagree Daniels was also identified as being a customer. This information was verified by the card reader and cameras of the establishment which was provided by the business.
