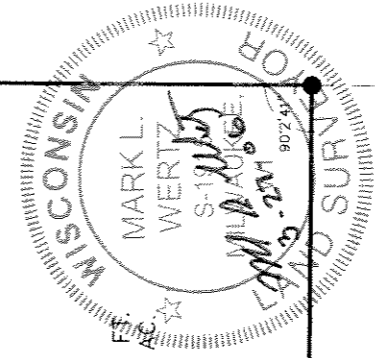

THAT I HAVE SURVEYED, DIVIDED AND MAPPED LOT 16, AND PART OF LOTS 17 AND 18 IN BLOCK 234 IN DAHLMAN AND KILIAN'S SUBDIVISION, BEING A SUBDIVISION OF A PART OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 18, TOWNSHIP 7 NORTH, RANGE 22 EAST, IN THE CITY OF MILWAUKEE, MILWAUKEE COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS:

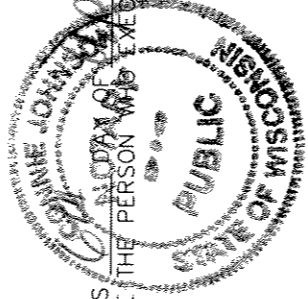

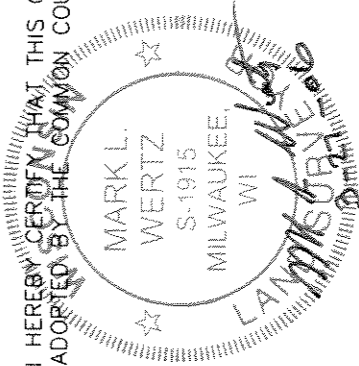
