1. Description of Grant Project/Program (Include Target Locations and Populations):

This grant award is intended to provide the City of Milwaukee Office of Domestic Violence funding for their participation in the Metro-Milwaukee DART Initiative: A Community Collaborative Effort Serving Survivors With Disabilities From Crisis to Healing, to be administered and led by IndependenceFirst with funds from the Office on Violence Against Women of the U.S. Department of Justice. Each of the partners involved in this project are committed to ending violence against women with disabilities and working together to improve services for women with disabilities in the Metro-Milwaukee area and collaborating on the development of the initial planning for this grant. This grant proposes to improve access and availability of services for victims with disabilities, from crisis to healing. Working in collaboration with IndependenceFirst, Task Force on Family Violence and the Department of Health and Human Services Disability Services Division.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

The MMDI Access grant will assist the Milwaukee Commission on Domestic Violence & Sexual Assault and its member agencies and organizations to fulfill the legislative mandate of the Common Council “to increase safety for victims of domestic violence...and for victims of sexual assault” by improving systems response and increasing access to services for victims of intimate partner violence and sexual assault who are disabled.
