

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

- 3. On 03/23/2019 at 12:51am officers were dispatched to 618 N. Water St for a Noise Nuisance complaint. The caller was a guest at Hilton Garden, 611 N. Broadway St. The caller stated the music was no longer loud and didn't wish to be a complainant. The officer went to ELMNT Lounge and spoke with the applicant. He stated the music was low all night and might have been coming from the studio next door. The officer stated the music was in fact being played at a low level.
- 4. On 04/04/2019 at 12:45am officers conducted a licensed premise check at ELMNT Lounge, 618 N. Water St. The officer spoke with the applicant, who was on scene. He showed the officers the licenses and a binder with all current bartender's licenses. The officer asked why there were traffic cones blocking the loading zone and the applicant stated that because of construction the city bus picks up in front of his business and he wanted to keep that area clear.
- 5. On 05/26/2019 at 8:30pm officers observed vehicle's blocking traffic in the 600 block of N. Water St. The officer stopped to get traffic flowing again and found the crowd was coming from 618 N. Water St. A fight broke out at the front entrance and the officers and ELMNT Lounge security broke it up. Another fight broke out and additional squad arrived to restore order. The applicant was on scene and stated he was throwing an afternoon party and closed at 8:00pm but would not be hosting this event again.
- 6. On 12/29/2019 at 2:12am officers observed a subject come out of 618 N. Water St. the female attempted to fight another patron and refused to leave the area. The female threw a rock at the business and yelled obscenities. The female was issued a Disorderly Conduct citation.

- 7. On 01/25/2020 at 1:41am officers on Code Red in the 600 block of N. Water St called for additional cars because of a large fight in the street. The responding officers observed 200-300 people exiting 618 N. Water St. The large group was pushing staff and security, who were trying to control the crowd. About 50 people began fighting outside. The patrons then entered their cars and began cruising in the area. Multiple additional squad were needed to control the crowd and stop the cruising. The officers spoke with the applicant, who stated there was no fight inside, the subjects began fighting once they got outside. the applicant stated he was not going to allow this promoter back in the club. On 01/26/2020 officers located videos on social media which showed a fight inside in the VIP area on 01/25/2020. On 01/30/2020 officers received an anonymous letter from a citizen about the 01/25/2020 incident and a copy of video from that night. Officers then went to the location and spoke with the applicant about obtaining video from that night. He stated his video system was malfunctioning and there was no video of the fight. On 02/01/2020 officers received an email from the applicant with a list of patrons from 01/25/2020 that was obtained by the ID scanner the business uses.
- 8. On 02/20/2020 officers, along with agents from the Wisconsin Department of Revenue, conducted a license premise check at 618 N. Water St. The officers located 44 bottles of contaminated alcohol, and a bottle that appeared to be refilled. The officers spoke with the applicant who stated he has repaired his video surveillance system that was broken on the last inspection.

On Sunday, December 29, 2019 while squad #1424 (PO SCHWEITZER and PO EMMONS) were assigned to the 600 block of N. Water St. in the City and County of Milwaukee for their Code Red assignment. At approximately 2:12 AM Sq#1424 observed a female who was later identified as OCONNOR, Breanna A. (W/F 12/27/1995) leave the above listed location and attempt to physically fight with another unidentified female that left the location. OCONNOR was asked multiple times to leave because the other female left and did not want to press charges regarding the fight. OCONNOR refused to leave and continued to yell obscenities, and at one point picked up a rock and her shoe and threw them in the direction of the tavern and where Police were standing. OCONNER was given Citation #61634532 for Disorderly Conduct with a future court date of 2/24/20 at 8:30 AM.

back up squad #1424 (PO EMMONS and SCHWEITZER-BROWN) at 618 N. Water St. who were calling for more squads regarding a large fight at ELMNT Lounge.

Upon arrival we observed approximately 200-300 people attempting to leave the front doors of the tavern. The group was pushing other patrons along with staff members who were trying to control the situation. As patrons began to spill into the street a large fight of about 50 people both male and female patrons from ELMNT Lounge broke out. Subjects were running in the street and around security and police officers trying to fight with each other. Traffic was barricaded off at N. Water and E. Wisconsin, and N. Water and E. Michigan with the attempt to keep people from cruising and stopping their vehicles in front of ELMNT Lounge. However, multiple cars disobeyed the barricades and went around them to partake and watch the large fight that was happening outside of the ELMNT Lounge.

At the time there were not enough Police Officers assigned to Code Red/District One that could leave their primary assigned locations/streets without causing those locations to possibly lose order. Due to being short on officers at the time no arrests were made but as more arrived on scene, and with the help of multiple Security Officers we were able to get the crowd to disburse into the city streets and stop the fighting. The crowd slowly made their way to their cars, but then continued to cruise back and forth in the area which caused traffic to back up. Officers had to utilize multiple squad cars with spot lights and air horns to get the traffic to move out of the parking lots and streets in the immediate area of ELMNT Lounge.

The following squads responded directly to ELMNT Lounge to help with the Crowd/Fight.

1424 - PO EMMONS and PO SCHWEITZER

1442 - PO PLUMLEY and PO NORTHWOOD

1421 - PO ZANIEWSKI and PO BACZEK

1490 - PO PETERSON and PO GARRIDO

1411 - SGT WOLLER

Squad #1332 (PO LAROQUE and PO ROECKER) and Squad #1360 (PO PITTMAN) responded to the parking lots and city streets in the immediate area of ELMNT Lounge after the fights were over to help move vehicular and pedestrian traffic. P.O. PITTMAN made one traffic stop from a subject coming from ELMNT and arrested her OWI (1st).

After the crowd was gone and things settled down I returned to 618 N. Water St. to speak with the Agent who is identified as MANJEE, Habib (I/M 7/16/1964) to try and figure out what the fight was about or why it started. Habib stated that the fight was about some baby mama drama between females, which caused the males to start fighting. Habib also informed us that there was no fighting inside of the his club but that the girls started to fight after security kicked them out. I asked Habib what his plan was to prevent things like this in future. Habib stated he was going to be a top 40 playlist bar so that it would attract a different crowd and he wouldn't have fights. Habib also stated that he would not allow this promoter to come back to his club.

ELMNT Lounge utilizes and identification scanner for each persons ID that comes into the tavern. I asked Habib if he would be able to give me a list of everyone that was in the club from his system so that we could conduct follow up and issue citations if we needed. Habib informed me that he could have is IT guy email it to me if that would be helpful. I provided him with my contact information and e-mail address so he could forward me the information.

On Sunday, January 26, 2020 I spoke with Officer Curtis PELCZYNSKI from our fusion department and asked him to try and find video on social media of the fights that took place the night before. PO PELCZYNSKI was able to burn me a disk from multiple social media accounts that showed video clips of a large group of men fighting in what appeared to be a "VIP" area of ELMNT Lounge. In the video you can hear the DJ making an announcement asking for security to respond to the VIP area. It does not appear that there is any security responding to the area or even in the background of the video. The video was placed on MPD Inventory #20004254.

On Thursday, January 30, 2020 Sgt Timothy GAUERKE gave me a letter and CD that were dropped off on his desk with an envelope from the East Town Association to the attention of Emily MCELWEE who is the Executive Director. Inside of the envelope was an anonymous letter from a Concerned Resident which states:

To Whom It May Concern:

I am writing this letter as a concerned Downtown resident. Over the weekend, I viewed several videos posted online from an even that took place at ELMNT Lounge (618 N. Water St.) on Saturday, January 25th, 2020. In the video, you can clearly see a patron of the establishment grab a bottle of liquor and use it as a weapon against another patron inside of the establishment. You can also see a fight ensue that lasts minutes with no security involvement. A more concerning point is that ELMNT's security appears to be outside of the venue while this altercation takes place escalating their own altercation instead of defusing it. While multiple security guards tend to a few patrons outside, several patrons inside are endangering the safety of hundreds.

It is well documented that this establishment and its management may be a nuisance to its neighborhood. However, after seeing this video, I believe it is beyond a conversation of nuisance and begs the question of overall safety. For ELMNT to be a venue that has been operational for years, there is no excusable reason as to why this incident happened or was allowed to happen for so long. There is no question, based upon these videos, that this incident could have easily and quickly turned fatal for one of several of ELMNT's patrons. Though I am thankful it did not. ELMNT's actions or lack thereof teeters on that of reckless abandonment.

As downtown Milwaukee continues to grow, we must allow for establishments like this to exist, but with ownership, leadership, and management that fit Milwaukee's ever changing landscape. With the Democratic National Convention quickly approaching, it is imperative that we shine the best possible light upon our city, entertainment venues and residents. As I stated earlier, we are beyond the objectionable argument of nuisance. The question now stands as to whether or not this establishment being open is safe for its customers, neighbors and the surrounding area. By the look of the videos I seen, the answer is an overwhelming, NO. It is my hope that by providing you with these videos, you will

be able to see for yourself how detrimental this establishment is. In my opinion, if ELMNT Lounge has not by this time learned how to effectively handle situations such as these, it is only a matter of time before a bigger and potentially fatal incident occurs. Which I for one do not want to see happen.

The letter and CD from the concerned resident was placed on MPD inventory #20003627. A copy of the letter is attached to this License Premise Report.

On Thursday, January 30, 2020 I returned to ELMNT Lounge to speak with Habib and asked to see his video surveillance from that night. Habib observed our squad car pull up in front of his business and came outside to meet with us. Habib had an uncooperative and argumentative attitude towards me and the questions I was asking for this investigation, I asked Habib to see his surveillance cameras. Habib stated he did not have any surveillance video of the fight because his camera system was burned up and he has ordered a new one. I asked Habib to show me which working cameras he had at the moment and Habib stated he did not want us interrupting his place of business for this and that we should call him to set up a time to review video. I informed Habib that I work at night and his business is also open at night. Habib then turned away and walked into the business as we followed. I observed working cameras on what appeared to be staff only areas, and behind the bar. Habib showed me an amazon order for a piece of equipment to fix his camera system. Habib stated he is just as upset about the fight that occurred at his business and he did not appreciate all of the bad press from social media that his Lounge was receiving. Habib also stated that he has received numerous calls from businesses in the area and Alderman who are upset with what occurred. I informed Habib that I would be filing this License Premise Report.

On Saturday, February 1,2020 I received an email from Habib with the list of patrons whos ID's were scanned into his system on Saturday, January 25, 2020 and early morning Sunday, January 26, 2020. Habib also attached a picture of all of his surveillance cameras operating and fixed.

Follow up is being conducted to identify and issue citations to the subjects involved.

A more concerning point is that Elmnt's security appears to be outside of the venue while this altercation takes place escalating their own altercation instead of defusing it. While multiple security guards tend to a few patrons outside, several patrons inside are endangering the safety of hundreds.

It is well documented that this establishment and its management may be a nuisance to its neighborhood. However, after seeing this video, I believe it is beyond a conversation of nuisance and begs the question of overall safety. For Elmnt to be a venue that has been operational for years, there is no excusable reason as to why this incident happened or was allowed to happen for so long. There is no question, based upon these videos, that this incident could have easily and quickly turned fatal for one or several of Elmnt's patrons. Though I am thankful it did not. Elmnt's actions or lack thereof teeters on that of reckless abandonment.

As downtown Milwaukee continues to grow, we must allow for establishments like this to exist, but with ownership, leadership and management that fit Milwaukee's everchanging landscape. With the Democratic National Convention quickly approaching, it is imperative that we shine the best possible light upon our city, entertainment venues and residents. As I stated earlier, we are beyond the objectionable argument of nuisance. The question now stands as to whether or not this establishment being open is safe for its customers, neighbors and the surrounding area. By the look of the videos I seen, the answer is an overwhelming, NO. It is my hope that by providing you with these videos, you will be able to see for yourself how detrimental this establishment is. In my opinion, if Elmnt Lounge has not by this time learned how to effectively handle situations such as these, it is only a matter of time before a bigger and potentially fatal incident occurs. Which I for one do not want to see happen.

This report is written by PO Molly PLUMLEY, assigned to District One, Late Power shift.

On Thursday, February 20, 2020 while assigned to squad #1442 with PO Eric NORTHWOOD we responded to 618 N. Water St. (ELMNT Lounge) to conduct a joint tavern investigation with Agent King (State of WI Alcohol and Tobacco Enforcement Unit) and Inspector Todd VANDRE (Department of Neighborhood Services).

During our investigation we were greeted by MURADO, Nicholas M. (W/M 8/18/1963) who is the Director of Operations for the tavern. MURADO showed us various areas that needed to be inspected within the tavern. During our investigation we located 44 bottles of liquor that were contaminated with debris, bugs, or other alcohol that were located behind the first floor bar, second floor bar, and liquor storage room. The bottles were emptied and destroyed by staff from ELMNT Lounge. MURADO was reminded of the fact that they can not marry bottles or fill empty alcohol bottles with other beverages. We located a bottle of Patron Tequila that was opened and contained more liquid than a brand new unopened bottle. MURADO informed us that he has a machine that you attach a Patron bottle to which takes the liquid out, chills it, then puts the liquid back into a Patron bottle. MURADO stated the machine was malfunctioning and not adding the correct amount of liquid back into the bottle.

I also spoke with MANJEE, Habib (W/M 7/16/1964) who is the owner of ELMNT Lounge. MANJEE just wanted to inform the Police Department that he has fixed his surveillance system which was broken during our last inspection. MANJEE also stated that he is now going to host a Salsa dance night at his Lounge to help have better behaved patrons.

Inspector VANDRE completed his inspection of the premises and found minor violations which he will file his own field report for.
