

We have received your claim in the amount of \$2,174.09 in relation to the damage to your door occurring on August 20, 2023 at 6548 North 93rd Street.

Our investigation determined a Milwaukee Police Department (MPD) squad was dispatched to your property at 6548 North 52rd Street on August 20, 2023, in response to a welfare check request. The welfare check came from your neighbors who were concerned for your safety. It was their belief that you may have been seriously injured while you were inside your home. MPD made several attempts to reach you, and getting no response, forced entry into the house finding no one inside.

It is our position that the police department acted within the scope of their responsibility, and the action taken in this matter was necessary and appropriate for the circumstances in this case. As such, the City of Milwaukee would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
