This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/26/22 at 9:25pm, Milwaukee Police were dispatched to 633 W. North Avenue for a battery complaint. Investigation revealed that two employees engaged in a physical fight, one of them left, and brought back a group of friends to re-fight the employee. The manager broke up the fight, the victim did not want to talk with police, and the police conveyed her to her residence.
- 2. On 10/05/22 at 6:20am, Milwaukee Police were dispatched to 633 W. North Avenue for a burglary complaint. Investigation revealed that a subject broke out a window to the door on the southside of the restaurant and entered the building. There was damage to the register, the place was ransacked, and the circuit breakers were switched off. Unknown what was taken.

3. On 7/11/23 at 11:57a.m., Milwaukee Police conducted follow up regarding a theft that occurred on 07/09/23 at 633 W. North Av. Investigation revealed a customer was in the drive-thru and was getting their change back, when a subject they had previously been arguing with, grabbed the change and fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 4. On 10/01/23 at 9:05p.m., Milwaukee Police were dispatched to a Fight at 633 W. North Ave. Investigation revealed two employees engaged in a physical altercation, however, it was broke up prior to police arrival. The business was cooperative.
- 5. On 11/03/23 at 10:21p.m., Milwaukee Police were dispatched to a Threat at 633 W. North Ave. Investigation revealed an employee made a comment to another employee, which was taken as a threat. The business was cooperative.
- 6. On 11/25/23 at 2:13p.m., Milwaukee Police were dispatched to a Threat at 633 W. North Ave. Investigation revealed a subject placed an online order and was upset over the wait for the order. An argument ensued and the subject made a threat to blow a head off. The subject was gone on police arrival.

This report was written by P.O. Terry BELL assigned to District Five Early Power shift, Squad 5290.

On Tuesday, July 11, 2023, at 11:57 AM, we arrived at the Wendy's restaurant at 633 W North Ave for the Follow Up investigation to a Theft incident that occurred on Sunday, July 9, 2023, at approximately 10:30 PM.

Upon our arrival, I was allowed into the managerial office of the restaurant by the manager, Deborah L YOUNG (F/B, 11-21-65) who had the authority and access to the surveillance cameras. I observed the recording of the incident which displayed a subject intentionally taking an object from the hand of the Wendy's drive thru attendant as the employee attempted to hand change over to a customer after a food order.

Prior to arriving at Wendy's, I spoke the caller who was the victim of the incident, Myka N CARTER (F/B, 10-29-00) who arrived at MPD District Five in person to report a property damage incident from July 10, 2023, at 1858 N Commerce Street. CARTER stated that she was involved in an altercation which led to the subjects approaching her while she was in the Wendy's drive thru line.

The manager of the restaurant, Deborah L YOUNG (F/B, 11-21-65) displayed the surveillance recording. YOUNG was not on duty during the time of the incident. YOUNG did not know why she was not notified of the incident and stated that she would conduct her own investigation into why she was not notified of the incident by the employee from whom the cash was originally taken. YOUNG was completely cooperative with the investigation.

I reviewed the surveillance video of Camera North 2 and the Outside North camera which affirmed the statement originally given by CARTER. I observed the subjects approach the vehicle of CARTER at 10:34 PM after they exited their vehicle which was parked on the west end of the Wendy's parking lot. I observed one of the subjects approach the driver's side of the vehicle, and after exchanging words with CARTER, took the cash CARTER was about to receive from the drive thru employee as the employee began to hand it to CARTER. I observed the subjects return to their vehicle. I observed the vehicle which CARTER was operating leave the premise as the subjects' vehicle followed her E/B on W North Ave.

I instructed YOUNG to email me a copy of the surveillance video.

RIZZO) were dispatched to a fight complaint at 633 W North Ave (Wendy's Food Restaurant), which is located in the City and County of Milwaukee.

#### SCENE DESCRIPTION:

Wendy's Food Restaurant is a brick building. The are two entrance doors to the premise, one being on the north side of the building and the other on the south side of the building. There is a drive through lane which starts on the west side of the building, an order menu with speaker on the east side of the building and the main window for receiving food from crew members on the north side of the building just east of the north entrance door. The parking lot of the location is on the west side of the premise.

#### **DISPATCH:**

Caller reported fighting at the location, two subjects, crew members for Wendy's.

#### **INITIAL INVESTIGATION:**

Upon arrival, I observed multiple standing inside the premise and did not observe an active fight.

Subject identified as Kyle SPEARS (M/B, DOB 01/20/2000) stated "we had a disagreement, we fought, and she broke us up". PO BURLO asked SPEARS if he needed medical attention and he responded "no". Officers were informed that SPEARS was engaged in a physical altercation with his cousin identified as Daylan WINTERS (M/B, DOB 01/12/2001) who also works at the location. SPEARS stated he did not want to press charges against WINTERS ad that WINTERS had left the location.

I asked SPEARS why he and WINTERS were fighting. SPEARS stated, "I walked away to use the bathroom", "he got made because I said, everybody that's on table, drop they own meat". "So, he got mad because I said every drop they own stuff". SPEARS stated, "he sitting there getting bold, I said bro stop playing with me before I bust you in your shit". SPEARS stated him and WINTERS began fighting and the manager told them to stop. SPEARS stated he attempted to stop and back away from his cousin, but WINTERS continued to charge at him and that he was not going to let WINTERS continue to strike him.

The manager of the location at the time of this incident was identified as Nicole HUBANKS (F/B, DOB 03/29/1997). HUBANKS stated she has been at this Wendy's location for approximately two weeks after coming from a Milwaukee south side location. HUBANKS stated she has never observed a physical altercation amongst employees before. HUBANKS closed the location down for the night due to incident and stood by for her boss to arrive to the location.

I was unable to view surveillance footage of this incident. The manager who has access to surveillance was not on scene at the time of this incident.

While on scene, I observed the licenses posted and they were up to date. I observed that the location was clean. The employees and managers met by officers regarding this incident were cooperative.

On Friday, November 3, 2023 at approximately 10:21 PM, PO XIONG and I were dispatched to 633 W North Av (Wendy's) for a Threat complaint, which is located in the City and County of Milwaukee.

Upon our arrival, I spoke to the caller, who verbally identified herself as Nicole L HUBANKS (B/F 3/29/1997), who stated he is a manager of the establishment "Wendy's" located at 633 W North Av. HUBANKS stated an employee, who she identified as Sabrina LONG (B/F 3/18/1985) made a threat her and her mother by making a statement "I'm going to pop you." HUBANKS stated she took that statement as a serious threat. HUBANKS stated she interpreted that statement as if LONG worked at a funeral home and that LONG would put her six feet under.

Officer observed customers in the drive thru line and one employee inside the store continuing to manage the business. Employees were very cooperative and answered all questions asked.

There were no other witness on scene at the time of the interview.

No video surveillance was available at the time of the interview.

While on scene, I observed the licenses (Card number A-9286 Sanitation Grade and Extended Hours license #0200205) posted in public view site near the front cash register. During my investigation, I did not observe any violations in the licensed premise.

This report is written by P.O. Terry BELL assigned to District Five Early Power, Squad 5290.

On Saturday, November 25th, 2023, at 2:13pm, I was dispatched to 633 W North Ave for a Threat complaint.

Upon our arrival, I observed business being conducted in the lobby of Wendy's Restaurant #02. The caller, who identified as the General Manager, Dave J AKINES (M/B, 02-24-69), was sitting in the patron's eating area of the restaurant.

AKINES, who called from the restaurant phone (414-263-7297) gave his account of the incident. AKINES stated that an unknown subject arrived in the restaurant and caused a disturbance. AKINES stated that the unknown subject was there to pick up an online food order. AKINES stated that the subject stated "You have me waiting again!?" AKINES stated that he recognized the subject from a previous incident at the restaurant.

AKINES stated that the subject was previously there on Wednesday, November 22nd, 2023. AKINES stated that the subject came to the restaurant drive thru line and skipped the line in his vehicle. AKINES stated that the subject then demanded his order and after being instructed to wait his turn in line, refused. AKINES stated that he explained the online order process but that the subject still refused to go the back of the line. AKINES stated that he called Uber Eats and filed a complaint against the subject. AKINES stated that he then threatened to call the police because the subject then threatened him. AKINES stated that he did not believe the subject's threats to be credible so he did not contact the police.

AKINES stated that during this current time, the subject told him in a bolsterous voice "You messing wit' my money!" AKINES stated that the subject was upset that he contacted Uber Eats which then banded the subject from deliveries. AKINES stated that the subject was now delivering food for Door Dash. AKINES stated that a verbal exchange ensued between he and the subject about the food order during which the subject made threats to "blow the head off". AKINES stated that the subject kept his hand in his pocket. AKINES stated that the subject then attempted to open to the door leading to the kitchen area, but was prevented from doing so because the door was locked. AKINES stated that he gave the subject the order yet the subject continued to behave in a disorderly manner. AKINES stated that he ignored the subject until the subject left the restaurant. AKINES stated that he contacted the corporate office who instructed him to contact the police.

AKINES described the subject as a B/M, 5-10-5-11, medium brown complexion, in his 20s, wearing a black hooded sweatshirt, black mask, black pants, and red shoes.

I reviewed the surveillance recording which displayed the described subject arriving at the business in a dark blue vehicle and entering the business at 12:44p. The subject then stands at the ordering counter walking back and forth. An exchange occurs between AKINES and the subject. I observed the subject then leave the business at 12:55p, enter his vehicle, and leave the scene. AKINES was given a contact card with information to email the video surveillance to P.O. Leon YOUNG. AKINES was also given restraining order information. AKINES stated that he was in the process of contacting Uber Eats and Door Dash to obtain the subject's information for the complaint and restraining order.

AKINES provided the business licensing information which were up to date. AKINES was cooperative with the investigation.

AKINES stated that he would contact P.O. YOUNG once he obtained the subjects information for further investigation.



Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
