The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/12/2015 the applicant was cited at 2526 West Hopkins Street in the city of Milwaukee for Sale of Cigarettes to Minor/Underage.

- 2. On 08/11/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2-pack Swisher Sweet cigar from the cashier at Freez Food Mart, 2526 W. Hopkins St. The clerk asked for an ID but made the sale anyways. The clerk was identified as Rami FARES, who admitted the sale. The applicant was mailed a MARTS enrollment package.
- 3. On 09/10/2018 officers, along with WI Department of Revenue agents, conducted a licensed premise check at Freez Food Mart, 2526 W. Hopkins St. The manager Rami FARES was on scene. The officers found tobacco items in inventory that he did not have documentation for and those items were seized. No other violations were observed.

4. On 04/10/2019 the officer was advised the applicant did enroll in the MARTS program regarding item #2 but failed a mystery shopper check on 10/15/2018 and 12/01/2018. The applicant was issued a citation for the original violation.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
