I will try to explain, to the best of my aprilly, the differentiations are fund of money.

On November 15, 2000 I went to the Water Department to get final readings on a house I was selling. I talked to Richard Gramza, the accounts supervisor, and was handed a reconciliation of my account. (enclosed with this letter). As you can see I had a credit of \$1,099.26. Mr. Gramza said the amount would be credited to my water or credited to my tax bill. At that time I told Mr. Gramza I was selling the house and a credit would be worthless to me since I didn't own any more property in Milwaukee. He suggested that I get a credit from the new buyers, but this was impractical since they were on a tight budget. I told him I would pay the entire water and tax bill at closing, which was November 29, 2000, (copy of closing statement enclosed also), and to issue the balance directly to me. He told me he would have to talk to the tax department in order to issue the refund and gave me the name of Rick Rhimus at the treasurer's office. I went to Mr. Rhimus and explained my situation. I was told that it would take about two months to get the paper work from the water department to refund the money. I called Mr. Rhimus February 15, 2001 and asked for my refund and was told that the Water Department made the check of \$1,099.26 to the treasurer and was credited to the tax bill. I then told Mr. Rhimus it was supposed to go to me, since the taxes were paid at closing and a credit given to the new buyers. He then told me to send a copy of the closing statement and a brief letter explaining the situation of why he was refunding the money. I faxed him the information and asked if I could pick up the check the next day.

I received a call from Mr. Rhimus February 16, 2001 stating that it would take a few days to take care of the paper work. On February 22, I called Mr. Rhimus to pick up my refund and was told that he could not give it to me because he was not authorized to do so. I then asked who is and was told to get a check from the Water Department.

I called Mr. Gramza and explained the situation and he told me the check was issued to the Treasurer as per my request. I told him that this is not what I requested and specifically instructed him to forward the money directly to me. We argued for awhile and then he blew me off.

I then called Mr. Rhimus again and he blew me off in a kinder fashion. Finally he told me the only way to get my money was to write a letter to the common council explaining the situation.

Why would I come to Milwaukee to rectify the water/tax problem if I intended to just get a credit. I was treated very rudely by Mr. Gramza because he wouldn't admit he made a mistake. I wouldn't be writing this letter if I was treated with some respect Common sense would have resolved this problem but Mr. Gramza must feel it's not his job to assist people. I made it clear from the start that the refund was to go to me. Why would I give the new buyers \$1,099.26 of my money.

I now have to jump hoops for someone else's mistake. I would appreciate a reply to my request as soon as possible and not be given the run around as to how to acquire my refund.

I am starting with the Common Council as per Mr. Rhimus. I just hope this is the last place to get reconciled.
