Dear Ms. Campbell:

This office is in receipt of your claim in the amount \$1,499.94, relating to damages sustained to your 1989 Buick on February 11, 2001 while the Milwaukee Police Department was trying to secure a stolen automobile that had a severely revving engine.

Our investigation reveals that the police action taken in this matter was necessary and appropriate. Since the police were not negligent but rather were acting within the sphere of their responsibility, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
