Repair Porch: Remove decking and damaged skirting. Add footings per City of Milwaukee Code, Replace Stairs, Risers and damaged/rotting skirting with cedarline. Replace Decking using 3/4" tongue groove decking.

Replace square and round columns, railings and spindles/baulisters to match existing:

6 - 8" round wood columns and bases
2 - 8" square wood fluted columns and bases
8 dropdown rails/goosneck connecting rail to columns
Spindles/baulsters to match existing (i.e., narrow taper)
Top and bottom rail

Repair gable peak trim to match existing
