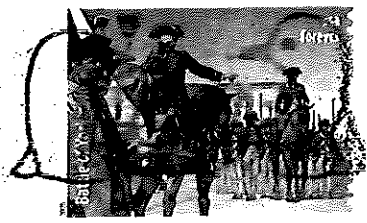

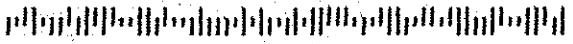

Dear Mr. Kruslin:

We are in receipt of claim regarding bodily injuries sustained on February 23, 2025, allegedly while in police custody.

This notice of claim was filed on November 3, 2025, Wis. Stat. § 893.80(1d)(a) requires that a notice of circumstances of the claim be served within 120 days after the happening of the event given rise to the claim. This service of notice is untimely. The city is not liable for medical bills while in custody.

Because the statutory timeframe for service of notice is unmet, your claim is being closed and will not be processed further.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

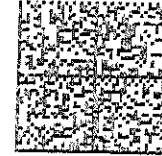

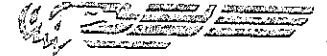
