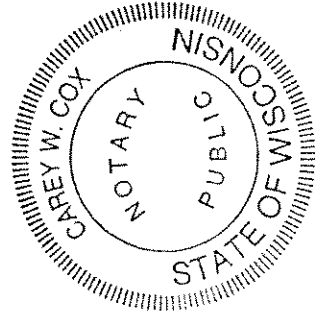

Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the September 26, 2006 meeting of the Milwaukee Common Council, the essence of which is as follows:

Substitute ordinance relating to the change in zoning from Industrial Heavy to General Planned Development on land located on the South Side of West Silver Spring Drive and West of North 27th Street, in the 1st Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-907(2)(a).0027. The zoning map is amended for the area bounded and described as follows:

The zoning line within West Silver Spring Drive, the zoning line within North 27th Street, a line 620 feet North and parallel to the north line of West Custer Avenue, a line 703 feet West and parallel to the west line of North 27th Street, a line 633 feet North and parallel to the north line of West Custer Avenue, and the east line of the Railroad right-of-way, from Industrial Heavy (IH) to General Planned Development (GPD).

Notice is hereby further given that the foregoing matter will be given a public hearing by the Committee on Zoning, Neighborhoods and Development in Room 304B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin, on Wednesday, November 8, 2006 at 9:00 A.M., pursuant to the provision of Sub-Section (7)(d) of Section 62.23 of the Revised Statutes of the State of Wisconsin.

PLEASE NOTE: a) Members of the Common Council, and members of its Standing Committees who are not members of this Committee, may attend this meeting to participate or to gather information. Therefore, notice is given that this meeting may constitute a meeting of the Common Council or any of its Standing Committees, and must be noticed as such, although they will not take any formal action at this meeting.

b) If you have difficulty with the English language, you may bring an interpreter with you, at your own expense, so that you can answer questions and participate in the hearing.

c) Upon reasonable notice, efforts will be made to accommodate the needs of disabled individuals through sign language, interpreters or other auxiliary aids.
