DEAR ELECTED OFFICIAL,

As a resident of Freeport Illinois, myself, husband, and two children, enjoy seeing concerts, and events, at The Rave.

Some of our best family memories, are at The Rave.

Every event, we have attended, has been worth the drive.

I am opposed to the proposed Live Nation / FPC Live venues in the Deer District.

Live Nation is a monopoly that controls ticketing (they own Ticketmaster), booking and music venues. There is no room in their business model for the vibrant and unique, independent and historic music venues in Milwaukee like Turner Hall, Pabst Theater, The Eagles Club and the publicly owned Miller Highlife Theater. You have a clear choice with this vote - either Live Nation or our historic venues. There is not enough business for both. The experience in Madison and other cities has proven that.

In addition, the public safety issues surrounding the Deer District are earning Milwaukee's downtown a dangerous reputation. In addition to 21 people being shot in one night because of inadequate security, the north end of downtown is regularly the site of violent crime. The Milwaukee Bucks long ago promised a security plan for the neighborhood. They have produced nothing, yet they propose to partner with Live Nation and invite an additional half a million people annually to an already overwhelmed area.

The City Plan Commission has asked for a comprehensive security plan before you act. Such a plan should include input from area businesses, residents, religious and educational institutions, as well as the MPD and MFD. An independent market analysis of the effect of the new venues on existing venues, specifically Miller High Life Theater, should also be requested by the Common Council.

Please do not act until a comprehensive security plan and market analysis are presented to the Common Council. Voting to approve this venue before having such a plan is poor planning and could put lives, and historic buildings, at risk.

# **STOP Live Nation/Ticketmaster, FPC Live Plan to Build a Music Venue in the Deer District!**

Concerned Downtown Neighbors started this petition to City of Milwaukee Common Council and 3 others

Milwaukee's downtown is a blend of local historic structures with new residential, retail, office & entertainment spaces. Recently, large crowds have tested the ability to enjoy our neighborhood in peace and safety. Shootings, over-capacities, and lack of provided sanitary facilities have brought unwanted and unanticipated trouble to our homes and businesses.

Live Nation/Ticketmaster fronted by Frank Productions (FPC Live) now has plans to build a new music venue in the Deer District. The 108,000 sq. ft. structure consists of two General Admission venues (capacity of 4,000 and 800) that will hold 135 events over the course of a year. All 135 events will be shows that would otherwise have played at The Riverside Theater, The Rave/Eagles Club, The Pabst Theater, Turner Hall, The Milwaukee Theater, The BMO Harris Pavilion, Shank Hall, Cactus Club destroying the viability of Milwaukee's current vibrant music scene. The venue location lies on the Bradley Center land.

We do not have an adequate security plan in place for our neighborhood for the current activity, let alone a huge new event space. What is Live Nation/Ticketmaster's reaction? The local CEO says "Do we have guns attempting to come into our venues? Absolutely we do...It is not uncommon for people to attempt to bring guns in." Now in an area plagued by shootings, Live Nation/Ticketmaster wants to bring thousands of gun-toting people to our downtown once every three nights and they will be in lines all day!

In addition, recent overcapacity events have hurt our hospitality industry. The lack of facilities in the Deer District has resulted in thousands of people overflowing into our bars and restaurants on Third Street and Water Street. Our businesses are unprepared to accommodate large crowds of non-patrons. Live Nation/Ticketmaster will now increase this activity for 135 days and nights a year.

We believe the Live Nation/Ticketmaster/FPC Live proposed development will negatively affect downtown Milwaukee.
