Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including grafifit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.



This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/25/17, the applicant was charged with OWI in Sheboygan County. On 02/14/18, he was convicted and his license was revoked for 6 months.

2. On 03/01/24 at 2:28a.m., Milwaukee Police were dispatched to a Shots Fired, later determined to be a Shooting at 2537 W. National Ave. On arrival officers located 7 spent casings and a blood trail in the rear of the business. The officers interviewed two victims at the hospital, one was a security guard and the other was a 20-year-old, who had been drinking inside the bar. The security guard stated an altercation began inside resulting in the subjects being removed. The fight became physical outside. Security attempted to break it up and was subsequently shot as well as the other victim. Officers attempted to interview the agent and employees, however, a female opened the door and stated they would get their boss, locked the door and no one ever returned despite multiple officers attempt to get them to unlock the door.

On 03/18/24, Milwaukee Police, an ADA and the Alderperson, met with the business regarding the incident. An employee stated the incident began inside the bar with a subject attempting to strike the bartender. The subject was removed and returned later with the underage victim/armed suspect, who was treated at the hospital. Video surveillance depicts a group of people arguing outside the tavern and a subject with a "security" sweatshirt, attempting to disarm the armed suspect, at which time the

gun goes off and a subject sustained a gunshot wound to their leg. The "security" then obtains control of the firearm and fires multiple rounds striking the premise, the sidewalk and the suspect. The officers requested interior video surveillance, however, the employee stated it was set up incorrectly and therefore did not begin recording until 03/02/24. The business had no explanation as to why no one called police during the incident. The business denied the underage suspect drinking inside the bar. The business stated the subject wearing the "security" sweatshirt is not an employee of theirs and is security at another business. It was determined there was no licensed bartender on scene during the incident. The business was advised they could not serve any alcohol until an employee obtained their license. It was further discussed one of the employees should obtain a B Manager License. The agent stated they reside in Sheboygan, however, use an employee address due to personal matters. Officers were further advised they business hired an additional 5-armed security guards and fixed the video surveillance. No employees were fired or reprimanded due to the incident.

3. On 05/13/24 at 1:34a.m., Milwaukee Police were dispatched to a Shots Fired at 2600 W. National Ave. On arrival officers observed a large group gathered in the alley of 2537 W. National Ave. The crowd began to disperse. No one remained to speak to officers and the caller did not answer the phone on callback. Officers attempted to speak to security at the bar, however, found the bar to be closed. The officers contacted the manager who stated a large crowd gathered due to security removing people from the bar and had no knowledge of any shots fired. The manager denied having access to allow officers to view video surveillance, however, stated officers could obtain it in the future.

4. On 06/08/24, an Officer obtained video from a local Alderman that were captured on Facebook of a large fight that occurred in front of 2537 W. National Ave., at approximately 12:54a.m. The video depicts the fight lasts for approximately 2 minutes between several patrons, causing a crowd of at least 50 patrons gathering, causing traffic issues and a disturbance. It appeared a patron was pepper sprayed by an unknown subject. Plain clothes security is observed attempting to break up the fight and the lone uniformed security officer only appears after the crowd has dispersed. The business did provide video of the incident; however, it was in a format that was not viewable and could not be attached to the officer's report. It should be noted no one from the business called the police.

5. On 06/15/24 at 1:30a.m., Milwaukee Police were dispatched to a Fight at 2537 W. National Ave. On arrival officers were advised there was no fight and they were attempting to get patrons to leave the area. Officers were advised the bar manager observed a subject outside, they believe to have a current restraining order on, waving at the manager. It was determined the subject lives next door to the bar. The business is a designated nuisance premise and is in billing status or has submitted an abatement plan.

6. On 07/27/24, Milwaukee Police conducted an Underage Tavern Enforcement Initiative utilizing a plain clothes officer and an underage Police Aide. At approximately 9:45p.m., they attempted to enter 2537 W. National Ave., however, were denied entry due to the Police Aide not providing an ID.

7. On 08/02/24 at 8:22p.m., Milwaukee Police conducted a License Premise Check at 2537 W. National Ave. No violations were found.

8. On 09/11/24 at 12:44a.m., Milwaukee Police were dispatched to a Shooting at S. 17th St., and W. National Ave. The victim was shot to the leg and transported to a hospital. The victim stated they were at 2537 W. National Ave., and were ejected by security, along with another subject. As they were walking the other subject yelled something at a passing car, who slowed down and fired shots, striking the victim in the leg. The business was cooperative allowing officers to access the ID Scanner to determine who the victim was with.

9. On 10/16/24 at 3:30p.m., Milwaukee Police conducted a License Premise Check at 2537 W. National Ave. Assisting in this assignment was an Agent from Wisconsin Department of Revenue Alcohol and Tobacco. 4 Liquor bottles with contaminates were discarded. The only other violation was Hookah boxes on display that contained tobacco. The manager was advised they do not have a tobacco license and therefore, cannot sell tobacco products. The Agent seized 27 boxes of tobacco containers.

10. On 11/15/24 at 7:38p.m., Milwaukee Police conducted a License Premise Check at 2537 W. National Ave. This was in regards to information received the business was promoting flyers on social media. The manager was advised they were not in compliance by promoting on social media and agreed to take the posts down.

11. On 12/06/24 at 11:00p.m., Milwaukee Police conducted a License Premise Check at 2537 W. National Ave. Hookah smokers were observed on the tables. Additional squads responded at 11:38p.m., to conduct further follow-up regarding the hookahs. Officers observed patrons smoking Hookah, however, after checking samples provided by the business it was determined it did not contain tobacco. The officers observed that security used a counter for the patrons and although the number reflected on the counter seemed low the officers did not believe the business was over capacity.

On Friday, March 1st, 2024, at approximately 2:28AM, I was dispatched to the address of S 26th St and W National Ave for a shots fired complaint. It should be noted it was later determined this was a shooting investigation at the address of 2537 W National Ave, located in the City and County of Milwaukee.

Upon our arrival, Officers located 7 spent casings and a blood trail in the rear of the 2537 W National Ave. This location is a bar/nightclub called, "La Cueva." It was later determined this was a shooting due to having two victims arrive at St Luke's Hospital. It should be noted both victims stated this incident all started inside the bar. One of the victims of the shooting was later identified as Ivan J RAMIREZ (w/m 4/19/1997) who was the security guard for the bar. RAMIREZ stated that an altercation occurred inside the bar (La Cueva), RAMIREZ removed the subjects outside of the bar, and the argument continued outside of the bar. RAMIREZ went outside to further deescalate the situation and was subsequently shot.

The second victim was later identified as Fabian M ESTRADA (w/m 5/10/2003) and stated he was drinking inside the bar "La Cueva," prior to being shot. It should be noted ESTRADA is 20 years old.

I attempted to make contact with the business "La Cueva" and knocked on the side door. A Hispanic female opened the door, when asked if she heard gunshots she stated, "not at all, I'm not sure let me call my boss because I was inside working the whole time." She then asked if she could close the door. Officers stood by for approximately 10 minutes waiting with no return from the employee. Officers knocked on the business multiple times and did not receive an answer from the business.

Other squads later on attempted to knock as well and did not get an answer.

It should be noted there were 12 squads total that responded to investigate this incident (5 Patrol Squads, 2 Sergeant Squads, and 5 Detective Squads)

I spoke to the caller, Francisco LIMON (414-418-9606). LIMON stated that he only heard 7 gunshots coming from the area of s 26th St and W National Ave. LIMON stated he did not see anything or hear anything else, he also wished to not provide further information.

I spoke to a witness who wish to remain anonymous. This witness stated that the night club opened up about two weeks ago, but he has not had any issues like this. Today he observed multiple drunk people come outside from the bar and begin to argue. The witness observed the security guard come out trying to stop the fight that was taking place just outside the bar. Witness stated he heard 5 shots, and observed multiple subjects get into a silver SUV which took off south bound on S 26th St.

I was not able to speak to the licensed premise owner due to them not coming out to speak with Officers. No one from the business called Police. The business was uncooperative with the investigation when requesting to speak with the owner, and employee not willing to come out.

Cameras were located outside of the business facing the scene that could capture this incident.

Matthew DIENER, and I), Alderwoman Jocasta Zamarripa, ADA Ann LOPEZ met with representatives from La Cueva (2537 W National Av), Antonio LAYTON (licensee), Kurt PETERSON (kitchen manager), Joe GOMEZ (kitchen manager), and their attorney Vincent BOBOT at District Two regarding this incident.

The meeting began with introductions and a summary of how the business understood how the incident had occurred. PETERSON stated that a female patron (Deisy GODOY-BARRIOS f/w 01/1/97) had been inside of the premises, had gotten into a verbal argument with a bartender, Bianca Alejandra REYES (F/W 03/08/97), had struck or attempted to strike REYES, and had been ejected by the security guard, Anna Marie SANCHEZ (F/W 03/09/70). PETERSON stated that he was told the patron had left and retuned later with a male subject (suspect Fabian ESTRADA m/w 05/10/03) and this is when the shooting had occurred. PETERSON stated that both he and GOMEZ had left the business prior to the shooting. PETERSON estimated that there were 25 patrons, one security guard (SANCHEZ), and two bartenders (REYES and Laura CARDONA f/w 03/15/94) at the bar that night. Video surveillance was provided to MPD that depicted the shooting. The video depicts a group of subjects outside of the tavern arguing, one of which is armed (ESTRADA) and displaying a handgun and another is wearing a "security" sweatshirt (CORONADO). The subject with the "security" sweatshirt attempts to disarm the subject with a second male (Ivan RAMIREZ) coming to assist. While disarming the subject, the second male sustains a gunshot to his leg. The male with the "security" sweatshirt disarms the subject and gains control of the firearm, discharges the firearm numerous times, striking the premises, the sidewalk, and the now disarmed male. PETERSON supplied information regarding the identity of the suspects to detectives.

Regarding video surveillance from the interior of the premises, PETERSON showed officers an app on his phone. There was no video from the grand opening of the business until March 2, 2024, the day after the shooting. PETERSON stated that he had set up the video recording incorrectly and no video surveillance was captured inside the premise until he corrected the settings on March 2, 2024.

Regarding the 20 year old underage shooting suspect/victim; Peterson stated that he had heard that although the subject made a statement to investigating officers that he was inside of the bar drinking for several hours, Peterson stated he had heard that the subject was not in the bar and was picked up by GODOY-BARRIOS. Peterson acknowledged that interior video surveillance, had it existed, would have clarified this.

Regarding the staff at the premises the night of the shooting; Peterson stated the subjects were working Laura CARDONA (bartender), Bianca REYES (bartender), and Anna SANCHEZ (security employed by the premises). PETERSON and LAYTON stated that they had no explanation why no one from the premises had called for police at any point and stated that this was the first time they had heard that a female employee had answered the door at the tavern (LAYTON stated no one resides in the apartment above the tavern) and had never returned to the door to speak with officers during the hours that officers remained outside. PETERSON stated he believed that REYES held a bartender's license, but in another jurisdiction. A check of department records revealed that REYES had applied for a City of Milwaukee bartender's license on 3/12/24.

Regarding RAMIREZ and CORONADO; Peterson stated that although CORONADO was wearing a "security" sweatshirt and PETERSON has known CORONADO for years, he was not and is not employed by the La Cueva but is a security guard for El Jalepeno. PETERSON stated that although RAMIREZ stated that he was working as a security guard for La Cueva, RAMIREZ has not been hired by the premises, but had only expressed interest in being employed.

Regarding the management of the premises; LAYTON stated that he is the manager and he runs the bar. LAYTON stated that PETERSON and GOMEZ assist him with some of the day to day operations. Officers informed LAYTON that either one or both of PETERSON and GOMEZ should obtain a manager's license for the premises if they are going to continue their role in the premises. PETERSON stated that the premise was in the process of hiring a manager, "Stephanie", who would obtain a manager's license. Officers informed LAYTON that the premises cannot serve alcohol unless LAYTON or a licensed person is on the premise.

PETERSON stated that the premises has hired an additional 5 armed security guards and has fixed the settings on the video surveillance since the incident. PETERSON stated that none of the employees working during the incident had been reprimanded and were all still employed by La Cueva.

LAYTON stated that he resides in Sheboygan but had updated his address to that of PETERSON'S due to personal matters.

After the meeting had concluded, P.O. DIENER and I reviewed the exterior video surveillance obtained from Taqueria El Toro and observed that it depicts GOMEZ outside

of the business on W National Av, jumping a vehicle's battery after the business. GOMEZ witnesses GODOY-BARRIOS repeatedly running into a parked pick-up truck prior to the shooting but does not include this in his statement to Detective Ryan CASEY, did not mention seeing GODOY-BARRIOS strike the vehicle during the meeting, and did not place a call to the police non-emergency number or 911.

During this assignment my partner and I were in full Milwaukee Police Department issued duty uniform with our Axon body worn cameras on and activated.

On Monday, May 13th, 2024, at approximately 1:34 AM, we were dispatched to the address of 2600 W. National Ave, for a Shots fired complaint, which is located in the City and County of Milwaukee, WI.

Upon our arrival, we noticed a significant number of people gathered near the alley behind La Cueva bar. Exiting our squad car, we began evaluating the scene when a security officer from La Cueva, stated that the shots originated from the alley where the crowd had assembled.

As we approached the crowd, they started to scatter, and several vehicles sped off. Individuals were shouting and moving away from us. Given the urgency of the situation we were called to, we requested for additional squads to our location. A female subject in the crowd shouted that there was no incident, everyone was okay, and they were simply dispersing. Nobody was willing to remain on scene and talk to us.

We attempted to call to caller but there was no answer. It was noted in the CAD that the caller's name was Lucas ALAMO, Phone: 414-412-9679.

Officer Munoz spoke to the residence located at 900 S. 26th street. However, the resident declined to disclose their personal information. Initially, the resident claimed that the security officer at the bar had discharged a few rounds. However, after conducting a thorough investigation, the resident admitted that they did not witness the security officer firing the shots but presumed so due to the officer being armed.

No witnesses were found at the scene, and when we returned to the bar to speak with the security officer and person in charge, we discovered that the bar had already closed. P.O. HERRMANN and P.O. GIRGIS managed to contact Stephanie J. SOLIS (W/F, 09-14-96), the manager of La Cueva, who claimed to have no knowledge of any shots being fired. SOLIS mentioned that a large crowd had gathered due to security officers removing people from the bar as it was closing time.

We inquired about the security officers' names present during the incident, but SOLIS could not provide their details or the company they are employed by. When we requested to view the surveillance footage, SOLIS informed us that she does not have access to it, mentioning that only the bar owner can access the cameras. SOLIS did mention that she could allow us to review the footage during future follow-up visits.

Officers on scene did not observe any person or

vehicle to be struck, and no casings were located.

but lack a date/time stamp. I was able to obtain additional video from a nearby address that also captured the fight and has a date/time stamp of 6/08/2024 with the fight starting at approximately 00:54:50 (the time stamp is one hour behind that of the actual time). The same actors are observed in all of the videos. The fight lasts for approximately 2 minutes with several patrons involved in the fight and what appears to be at least 50 or more patrons acting as spectators and vehicles stopping in traffic because of the disturbance. It appears as though a patron is "pepper sprayed" by an unknown subject in the crowd. Plain clothed security for the premises are observed attempting to break up the fight and the lone uniformed security officer is only observed after the crowd has dispersed.

I did contact the licensee for video from the premises related to the fight and received a timely response; however, the video was in a format/platform that I was unable to view or attach to this report.

It should be noted that there were no calls for service generated by employees of La Cueva related to the fight.

Additional videos were uploaded to Evidence.com due to the sizes of the files.

On Saturday, July 27, 2024, Officers and Police Aides performed an underage tavern/alcohol vendor enforcement initiative. There was one team that was part of this initiative. Our team consisted of an MPD Police Aide, a Police Officer, both which were acting in a plainclothes capacity, with a marked patrol vehicle, containing three uniformed Police Officers, monitoring them from a short distance away. The Police Aide for our team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Victoria A PAGAN (PS#037189) and Police Officer Maritza REYES (PS#036320) were in plainclothes while I, along with Police Officer Jesus RODRIGUEZ JR(PS#029217), Police Officer Dellian MENDEZ-SANTIAGO(PS#028797), and Sergeant Jonathan MEJIA-RIVERA were all in full uniform.

Prior to attempting any checks of licensed establishments, the Police Aide and Police Officer were given instructions. Our plainclothes members of this initiative were advised they were not to produce any identification, to any of the establishments. If they were asked to produce identification, they would lie and say they forgot it, or didn't have one, attempting to still gain entry without verifying identification. It was explained that the Police Aide would order one alcoholic beverage or a 6 pack of beer, and the plainclothes Officer would order a soda or water. The plainclothes members would provide a detailed description of the seller, to the uniformed Officers, if they were able to obtain items or if they were unsuccessful. If they were successful in being served/sold alcohol, uniformed Officers would return to the establishment to confirm the identity of the person who sold the alcohol, to the Police Aide. The uniformed Officers would then notify the seller that they served an underage department member, who was acting in a plain clothes capacity and failed our investigation. The uniformed officer would then inform the seller that they would be receiving a citation, and a license premise report would be filed.

On Saturday, July 27, 2024, at approximately 9:45 PM, PO REYES and PA PAGAN arrived at 2537 W National Ave, (LA CUEVA) located in the City and County of Milwaukee, WI. While operating in an undercover capacity, attempting to purchase alcohol, while underage. PA PAGAN walked to the entry door, attempting to gain entry at 9:47 PM. PA PAGAN was stopped at the door by security, requesting she provide identification prior to entry. PA PAGAN stated that she forgot her ID and was refused entry. PA PAGAN and PO REYES left the establishment and provided uniformed officers with the information. No alcohol/no entry was obtained.

This summary report is written by P.O. Kevin VODICKA, assigned to District Two, Days, CPU. On Wednesday, September 11th, 2024, at approximately 12:44am Squad 2330 (PO Spencer JACKSON and PO Muhammad ISMAIL) was to the intersection of S 17th St and W National Ave to investigate a report of a "shooting".

Upon arrival, officers located the victim, later identified as Therris L. CAMPBELL (B/M, 03-30-00), laying on the grass with the pool of blood. Campbell sustained a single gunshot wound to his right leg. Officers applied a tourniquet and later rode with the victim to the hospital.

Investigating officers spoke to the victim's friend who arrived at the shooting scene an hour later after the incident took place. The friend was later identified as Donavan M. MARTIN (W/M, 03-10-04). MARTIN stated that, hour before the incident, he along with Campbell and some other friends were at the La Cueva bar located at the address of 2537 W. National Ave, which is located in the City and County of Milwaukee, WI. MARTIN stated that, he didn't notice when CAMPBELL suddenly left the bar. MARTIN stated that a female subject who he was dancing with at the bar told him that there someone was shot and then heard from friends that Campbell was shot and he rushed to the scene. MARTIN stated that CAMPBELL might have gotten into an argument with someone inside of the bar but was not able to provide any information about the subject.

The victim in this incident, Campbell, was later interviewed and stated the following; He and some friends were at another bar before going to La CUEVA where they met other friends. Campbell stated that security ejected one of the subjects after that person made a joke about the group taking too long to arrive at the bar and that he was ejected as well. Campbell that he was walking eastbound on W National Av. With this subject when the subject yelled at a passing car, the vehicle slowed, and someone from the vehicle discharged a firearm striking him in the leg.

Campbell stated that he did not know the name of the subject or where this person lived. Campbell stated that he walked Eastbound on W. National Ave. with this person. Campbell stated that this person yelled "Slow down!" at a gold Nissan that was driving Eastbound on W. National Ave. Campbell stated that the driver of the gold Nissan opened the driver door, and he heard a "Pow". Campbell stated that he never saw the driver, never saw a gun, and he did not see the person who fired the shot. Campbell denies being involved in an altercation at La Cueva. Campbell denies having problems with anyone. Campbell denies owning a firearm and denies that he was armed during this incident.

Officers were able to access the ID scanner for La Cueva to determine who Campbell had arrived with. The investigation remains open

Officers observed four (4) liquor bottles spoiled with contaminants (fruit flies) that were later discarded. SCHNERING inspected the alcohol purchase records for the premises and found them to be in order and from licensed wholesalers.

During the course of the investigation officers observed a second bar adjacent to the dance/dining area that had hookah on display in glass doored cabinets. The hookah boxes advertised that they contained tobacco and officers were aware that the premises does not hold a cigarettes/tobacco license with the City of Milwaukee. Solis was advised that the premises is not licensed to sell tobacco products and a citation was not issued due to the premises not being open.

SCHNERING seized a total of twenty-seven (27) tobacco containers from the premises. The Field Report is attached.
