Dear Ms. Ward-Wilson:

We have received your claim in the amount of \$208.52, relating to damage allegedly sustained to your vehicle on April 15, 2008 when it collided with a pothole along North Green Bay Avenue, between West Courtland Avenue and West Villard Avenue.

Our investigation reveals that the Infrastructure Services Division reviewed their records and the DPW Call Center records and found that prior to April 15, 2008, the City had no notice of this hazard in the roadway and because of this lack of notice the City would not be liable. Therefore we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
