6. On 07/09/22 at 12:41a.m., Milwaukee Police were dispatched to a ShotSpotter, which was later updated to a shooting at 3551 N. Teutonia Av. Officers located a victim with multiple gunshot wounds laying in the parking lot of the gas station. The employee was very cooperative and allowed officers to view video surveillance which depicted a vehicle pull into

the lot, a subject get out and shove the victim, then fire 3 shots.

7. On 09/11/22 at 2:12p.m., officers were dispatched to 3551 N. Teutonia Av., for a Subject with Gun. The employee stated a subject was inside the store loitering and was asked to leave, when they displayed a firearm and pointed it at the employees making threats and causing them to fear for their safety. The employees locked the subject in the store, however, the subject was no longer on scene on police arrival. The employees were cooperative and allowed officers to view video surveillance of the incident.

8. On 11/11/22 at 11:00a.m., officers were dispatched to 3551 N. Teutonia Av., for a Threat complaint. Officers were advised a subject was inside the store shoplifting at which time an employee locked the suspect in the store. On police arrival the suspect was no longer on scene.

9. On 07/18/23 at 4:13a.m., Milwaukee Police were dispatched to an Entry at 3551 N. Teutonia Av. Investigation revealed a suspect entered the locked business by prying open a window. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 10. On 08/01/23 at 1:00a.m., Milwaukee Police were flagged down for a Shoplifter at 3551 N. Teutonia Av. Officers were advised the clerk observed a subject attempt to conceal Red Bulls in their back pack and locked the door. The subject then tipped over a rack inside the business. The subject denied attempting to steal; admitting they tipped over the rack, however, stated it was due to the accusation. The subject was issued a citation on scene. The business was cooperative.

Teutonia Ave. Investigation revealed a clerk had shorted a customer their change and a verbal argument ensued. After viewing video surveillance, the clerk rectified the situation. Teutonia Ave. On arrival officers located the victim lying outside of the business with no signs of exterior trauma and a clear substance on their face. MFD arrived on scene and performed life-saving measures, however, the victim was pronounced deceased. The caller stated they thought they saw the victim drive by earlier and state they were going to the gas station to pick up their brother. The employee was interviewed and stated if the victim was who everyone stated it was, they were a known pan-handler in the area. The video surveillance did not cover the area where the victim was located.

On Tuesday, July 18th, 2023, at approximately 4:13 AM, my partner PO Melissa GRAMS and I, were dispatched to the address of 3551 N Teutonia Avenue, located in the City and County of Milwaukee (WI), for an Entry complaint.

Upon arrival, PO GRAMS and I spoke with the complainant Timmy A OLUB (B/M 10-18-95), who stated

that someone had entered the Citgo Gas Station, but then fled on food shortly afterwards. OLUB stated that a male subject entered through a window, by prying the window open with a crowbar. PO GRAMS and I observed a window missing, and laying on the sidewalk. The window was not damaged, however I did notice damage to the frame. The phone number that OLUB called from was (414) 763-6734. OLUB stated in the CAD that someone broke into the gas station and ran when he rushed towards him. OLUB stated in the CAD that he did not have a description of the male subject, and that the male subject ran south on N. Teutonia Avenue, towards W. Keefe Avenue.

There was one other employee at the gas station, identified as Amreek SINGH (W/M 01-10-00), however I was unable to get a statement from SINGH, due to a major language barrier. There were no other witnesses on scene during the time of this incident.

OLUB contacted the owner of the gas station, identified as Simarjit SINGH, via telephone. S. SINGH was not on scene during this incident, but was made aware of the incident. The employees on scene were very cooperative and provided surveillance footage, and OLUB was informed to upload the surveillance footage through an Evidence.Com link. There were no security personnel on scene at the time of this incident.

OLUB was able to provide me with surveillance footage on scene, on the computer monitor. I observed a male subject enter the gas station, through the opening that was provided, when the male subject pried the window out. The male subject had dark clothing on, with a gray/red hat, and neon green gloves. The male subject began walking around behind the counter, and OLUB began walking towards the counter when he noticed the male subject. The male subject exited through the opening from where the window was, and that concluded the surveillance footage.

On Tuesday, August 1st, 2023, at 1:00pm while on routine bicycle patrol in the 3500 block of N Teutonia Ave we were flagged down for a shoplifter complaint at Citgo, located at 3551 N Teutonia Ave. Upon arriving in the lot, a clerk exited Citgo and indicated that they had a shoplifter inside the location. A black male then exited the store and identified himself to me and PO STASZEWSKI as Shawn KAROL (b/m 9-8-85). KAROL indicated that he was involved in a verbal altercation with the clerk of the location who had stated that KAROL was attempting to steal Red Bull from the station. KAROL stated that after becoming upset with the clerk he then tipped over a large metal rack which contained various small food items. KAROL stated that we then arrived on scene immediately after he had tipped over the rack.

I then went inside the location at which time the clerk who was on scene gave me a cellular telephone and indicated that the owner of the store was present. I was unable to interview the clerk directly due to a language barrier. The owner of the location was identified as "Sunny" BENIPAL (w/m 12-28-79) ph: (414)763-6734. Sunny reported to me that his clerk had observed KAROL begin to conceal several small cans of Red Bull in his backpack at which time the clerk locked the front door to the gas station preventing KAROL from exiting. I was informed that upon KAROL then observing the front door had been locked then became upset at which time he grabbed a metal rack containing the foot items and threw it to the ground. We then arrived on scene shortly thereafter. I was informed that the metal rack was not damaged during this incident. I did observe several small snack food items as well as several cans of Red Bull on the floor of the location.

There were no additional witnesses on scene during this incident as several citizens who were inside the business when it was locked left the scene upon our arrival.

KAROL was later issued a City of Milwaukee municipal citation regarding this incident due to him disturbing normal business operations.

This concludes my report.

On Monday, September 11th, 2023, I was assigned to Squad 5340, I was operating a marked black and white MPD Squad Car (Car #502), which was equipped with the Axon in car camera system which was not activated during this investigation. My partner, P.O. Robert ROEMBKE (driver) and I (passenger) were in full MPD uniforms with badges and nameplates affixed to our outermost garments. P.O. ROEMBKE and I were equipped with body worn cameras which were activated during portions of this investigation. I was dispatched to 3551 N Teutonia Ave, located in the City and County of Milwaukee, Wisconsin regarding a Trouble with Subject Complaint.

Upon arrival we made contact with a subject identified as Laron LAWRENCE (B/M, 09-19-83) who stated the gas station attendants shorted him U.S. Currency upon purchasing items from the establishment located at (Citgo Gas Station) 3551 N Teutonia Ave in the City and County of Milwaukee, Wisconsin. We made contact with the cashier who was disputing that he gave LAWRENCE the correct change after purchasing fuel and goods from the establishment,

I reviewed video surveillance footage of the interaction between LAWRENCE and the cashier and observed that he was indeed shorted money from the cash register overhead surveillance footage. The cashier didn't have direct access to the security cameras and had to call the owner to get the password to access the cameras. This was obtained and the establishment assisted in providing footage so officers could resolve this complaint. The establishment corrected the money issue with LAWRENCE while officers were on scene and the call for service was

While on scene, I observed the licenses posted and they were up to date. During my investigation I did not observe any violations in the licensed premise.

On Monday, September 18, 2023, at approximately 5:06AM, (while in full duty uniform equipped with an Axon Body Worn Camera activated and in a marked black MPD Squad #501), Squad 5330 was dispatched to a Sick/Injured complaint at the Citgo gas station located at 3551 N Teutonia Avenue, in the city and county of Milwaukee.

PO TWYMAN and I observed the victim was an unidentified B/M, dark complexion, tall, heavy set, approximately 45-50 years of age wearing a white t-shirt, black vest and tan jeans with horizontal zippers on the legs. The victim was laying on the EAST side of the gas station on N Teutonia just SOUTH of W Keefe Ave. There were no signs of exterior trauma on the victim and there appeared to be a clear-like substance/liquid on his face. No drug paraphernalia near the victim.

Upon arrival, the Milwaukee Fire Department arrive shortly after to perform life saving measures on the victim. At this time, we did not have any means of identification for the victim. After several minutes of working on the victim, the victim was pronounced deceased at 5:34AM by Doc#198,

MFD INFO: Engine 30, Med 7, Blue Shift, commanded by Lieutenant FLICK.

# Interview of Original Caller:

I called the original caller from this incident who identified himself as Larry JONES (B/M 8-8-1973). JONES stated he was at the gas station at approximately 4:40AM and when he left, he walked south a few blocks towards W Capitol Drive. JONES stated he did not observe the victim when he left. JONES stated he was walking south and noticed a large dark colored SUV with large rims leaving the gas station stating they were going to return. JONES described the driver as a B/M who appeared to look like the victim and JONES stated the driver stated he was going to return to "pick up his brother". JONES stated he left the gas station for no longer than 20 minutes. JONES stated he came back to the gas station to use the restroom and charge his phone when he walked near the black gate and saw the victim laying on the ground face down. JONES stated he flipped the victim over, attempted to feel a pulse and gave the victim two (2) sternum rubs while on the phone with Dispatch.

I also spoke with the clerk of the gas station, verbally identified as Timmy OLUB (B/M 10-18-1995).

### Interview of OLUB:

I spoke with OLUB regarding this incident. OLUB did not see or hear anything out of the ordinary this morning. OLUB stated he works just about every single day, or when asked to work. OLUB stated he normally works his shift at 8:00pm-6:00am or 8:00pm-7:00am. OLUB stated he started at approximately 8:30pm on 9-17-23. It should be noted that many people at the gas station believed to know who the victim was but did not have his full name. OLUB stated that if the victim is who everyone believes it to be, he stated that he normally sees him panhandling outside of the gas station near the pumps and dumpsters. OLUB was willing to provide video footage of this incident but did not have the password to access it. OLUB gave a phone number of 815-701-1098 for the man who works on the camera, no known name.

\*\* It should be noted that the cameras on the gas station do not point in the direction that the



The hearing before the Licenses Committee will take place on 6/18/2024 at 9:45 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
