This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/23/20 at 2:26pm, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a trouble with subject complaint. Officers spoke to the manager who stated that two subject left the store without paying for merchandise. The manager further stated that the two suspects are also the same suspects in four different theft offenses from the store. Officers were provided with video footage showing the suspects and the suspect vehicle. Other police squads checked the area for the vehicle. A community contact card was given to the manager regarding the incident.
2. On 05/05/20 at 8:41am, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a theft complaint. Officers spoke with the assistant manager who stated that 4 subjects entered the store with empty bags. The 4 subjects then filled the bags with merchandise and left the store without paying for the items. One of the suspects threatened the assistant manager with force during the incident. The suspects then fled the area in an older white suv, traveling west from the location. Officers filed the report as an armed robbery due to the threat of force stated to the assistant manager at the time of the offense.

3. On 09/06/20 at 10:10am, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a theft complaint. Officers spoke with the cashier who stated that an unknown subject entered the store with an empty bag. The suspect then filled the bag with merchandise and left the store without paying for the items. The suspect was last seen walking west on foot away from the location. Officers were provided video footage of the incident.
4. On 09/28/20 at 5:17pm, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a subject with a gun complaint. Officers arrived at the location and did not locate any subjects at the location. Officers searched the area and could not locate any one matching the description provided. Officers spoke with staff at Walgreens who stated that they were content with the subjects being off the premise.
5. On 10/19/20 at 1:32pm, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a trouble with subject complaint. Officers arrived at the location and spoke with security who stated that the subject left the location prior to police arrival. Officers checked for the area for the subject but were unable to locate the individual.
6. On 10/25/20 at 11:38am, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a sick/injured person complaint. Officers spoke with security who stated that a female subject was bleeding in the bathroom. The subject stated that she was injured at another location and just wanted medical attention, and no crime occurred. Bell ambulance transported the female subject per her request for medical attention.
7. On 11/27/20 at 12:23pm, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a trouble with subject complaint. Officer spoke with a subject who stated that she wanted her prescription. The pharmacist on duty stated that the prescription was picked up six days prior. Officers attempted to view camera footage but staff did not know how to operate the video system. The business was cooperative during the incident.
8. On 12/12/20 at 3:00pm, Milwaukee Police were dispatched to Walgreens 2727 W. North Av for a theft complaint. Officers spoke with the security who stated that 3 suspects took merchandise from the store without paying for the items. The manger on scene stated to officers that a police report was not required. The manger was advised by officers if a report was needed to contact the officers regarding. Officers did check the surrounding area but did not locate the suspects of the theft.

Upon arrival we spoke to the caller/manager of Walgreens who verbally identified himself as Martin B HAZLETT (W/M 05/21/1986). HAZLETT stated the two subjects were no longer on scene and left the store without paying for the merchandise in the cart. HAZLETT stated the two subjects have taken items from the store without paying on at least four different occasions.

HAZLETT showed us the surveillance video of the incident today which show the two females enter the store at 2:19 PM. At 2:21 PM the two females walk out of the store with a cart full of diapers and enter the black 4 door Chevrolet HHR which was parked in front of the Walgreens. Subject 1 was leaving the store pushing the cart full of diapers while subject 2 followed carrying approximately 6 packages of baby wipes.

The surveillance video shows the following subjects:

Subject 1: B/F, early 30's, heavy set, short black hair, wearing a white t-shirt with red writing and blue sleeves, and blue shorts

Subject 2: B/F, early 30's, thin build, black braids, wearing a blue mask, royal blue spaghetti strap tank, and light blue jeans

HAZLETT provided a picture of the vehicle which was bearing license plate # SH5-B9V (unknown state). HAZLETT stated the females took approximately 16-18 packs of diapers (valued at \$10 each) and approximately 6 packs of baby wipes (valued at \$3.50 each).

Squad 3235 checked the surrounding area for the vehicle which not located.

A community contact card was issued to HAZLETT.

On Wednesday, August 5, 2020 at 8:41 a.m., my squad partner, P.O. Andres CABRAL and I, were dispatched to 2727 W. North Ave., (Walgreens), located in the City and County of Milwaukee, State of Wisconsin.

Upon our arrival, we were informed by the Assistant Manager, (Amanda M. WORLEY, w/f, 12/17/87), that while opening the store at 8:00 a.m., 4 subjects entered the store with empty bags.

Within ten minutes these four subjects went through the store in many different aisles and filled there bag. WORLEY was in close proximity of one of these individuals and stated, "Seriously," while looking at an older b/m, approximately 50 years of age, who was one of the subjects filling a large black garbage bag full of items from the shelves.

WORLEY stated that this subject then turned to her and responded, "Seriously, I'm going to knock you out if you get in our way."

The four subjects who have filled there bags, then left the last possible point of purchase with intent to permanently deprive the victim the sale of.

These subjects the entered an older white Suv and fled the location w/b from 2800 W. North Ave.

This incident was filed as a Strong Arm Robbery due to the threat of force the subject made to WORLEY.

This report was written by P.O. Matthew VANDRISSE, assigned to District Three, Day Shift.

On Sunday, September 6, 2020, at 10:10AM, squad 3190, P.O. Szidon MCNULTY and I were dispatched to 2727 W. North Ave. for a theft complaint. The location is a Walgreens store and located within the City and County of Milwaukee. All officers were in full uniform and equipped with body worn cameras.

Upon arrival, I was met by an employee/cashier identified as Ashley N. SEILS, W/F, 12-02-98. SEILS stated that she was working as a cashier when a subject walked in the store and began to place merchandise into a black plastic bag. The subject then walked out of the store with the stolen merchandise and walked off westbound on foot.

I then met the shift leader, identified as Candy S. PERKINS, B/F, 09-17-78. PERKINS was in the office looking at video surveillance of the incident.

After looking at the video surveillance, I was able to get a suspect description. Suspect description: B/M, 507-508, medium build, upper 20's or 30's, light complexion, blue hooded sweatshirt with neon yellow, dark blue jeans, and a blue David Grubber shirt wrapped around his head and face with only his eyes exposed.

The suspect entered the store at approximately 10:00AM and used the stores black garbage bags to place merchandise in. The suspect took four bottles of Purex (\$23.96), four canisters of Ajax (\$4.00), two bottles of Gain laundry detergent (\$13.98), two bottles of Arm & Hammer laundry detergent (\$11.98), two containers of Armorall cleaning wipes (\$14.98), three bottles of Dove body wash (\$35.97), two bottles of Oil of Olay body wash (\$13.98), five canisters of Dove mouse (\$37.45) and six boxes of New Port Cigarettes (\$52.20). The total value of the stolen merchandise was \$208.50. The cigarettes were taken from behind the cash register counter where SEILS was working. PERKINS told SEILS to go into the corner away from the suspect and the suspect said, "I'm not going to hurt her." During the incident, the suspect said several times, "I'm sorry." After the suspect took the cigarettes he walked out of the store past the point of sale at 10:06AM. The suspect's actions were done intentionally and without consent.

There were two other employees in the store but they did not have any information regarding the incident. They were identified as Dwayne Deshawn PITTMAN, B/M, 01-10-1999 and Daesha C. WINSTON, B/F, 03-31-2001.

Squad 3193, CSO Monica NASH responded and obtained latent fingerprints and took photos. CSO NASH was unable to obtain a copy of the video surveillance and would come back the following day regarding.



