This is to notify you that on Thursday, June 13, 2013 and Monday, June 24, 2013, the City's Licenses Committee voted to recommend to the City's Common Council that the Class "B" Tavern and Public Entertainment Premises licenses not be renewed, respectively, for the premises located at 4610 W. 
