There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines: Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Monreasl, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/19/2020 at 606am officers investigated a Sudden death call at Quality Inn, 4488 S 27th St. The victim was found dead in the bathtub of a room. The applicant was on scene, but would not call a shuttle van driver to move his van until 10:30am. The officers needed to reach the van owner because it was running and leaking a large amount of fluid in the parking lot. He also told the officers they could not view the surveillance video until 12:30pm.

2. On 07/17/20 at 1:00pm, Milwaukee Police had a meeting with the applicant at 4488 S. 27th Street regarding calls for service and safety for the establishment. Officers performed an onsite CPTED of the establishment with the owner and applicant who went over their safety protocol. The only concerns found were; a large vacant lot on the southeast side of the building which is out of view of security camera's, garbage and vehicles with flat tires in the rear of the lot, no dumpster at location, and the building could use some exterior updates. The owner and applicant were very receptive to the meeting.

3. On 08/08/20 at 2:59am, Milwaukee Police were dispatched to 4488 S. 27th Street for an overdose complaint. Investigation revealed that the subject was outside the hotel and it was for medical only.

4. On 11/27/20 at 3:30pm, Milwaukee Police were dispatched to 4488 S. 27th Street for a trouble with subject complaint. The caller/employee stated that a subject who was staying at the hotel next door, checked out, and refused to leave their location. The subject left before police.

Investigation revealed that a subject was refused her security deposit because the room smelled of marijuana and a window was unscrewed so she could open it. 8. On 03/09/21 at 10:32am, Milwaukee Police were dispatched to 4488 S. 27th Street for a trouble with subject complaint. Upon arrival, officers interviewed the applicant who wanted subjects removed from the lobby for disruptive behavior. The subjects were removed by police without incident.
9. On 06/12/21 at 10:34pm, Milwaukee Police were dispatched to 4488 S. 27th Street for a trouble with subject complaint. Upon arrival, officers found nobody who needed police service.

10. On 07/18/21 at 4:50am, Milwaukee Police were dispatched to 4488 S. 27th Street for an entry to auto complaint. Investigation revealed that an unknown subject entered the callers vehicle with his keys which he left in a public restroom and took property.
11. On 09/06/21 at 5:53am, Milwaukee Police were dispatched to 4488 S. 27th Street for a call for police complaint. Investigation revealed that a subject staying in one of the rooms caused damage to that room and the employee wanted a citation issued. The subject in the room who caused the damage was issued a citation for property damage.

The officers were able to get the subject to leave by providing a ride to the District lobby.
20. On 05/01/23 at 1:46a.m., Milwaukee Police assisted Greenfield Police in the arrest of a subject with a gun that fled into a room at 4488 S. 27th St. The employees were cooperative with the officers and the investigation.
21. On 05/09/23 at 4:52p.m., Milwaukee Police were dispatched to a Theft at 4488 S. 27th St. Investigation revealed a guest placed their watch under a pillow in the room and left. When the guest returned to the room, the watch was gone. On police arrival, they were approached by a manager who assisted police in locating the watch on the housekeeper cart with the guest's room number on it. The manager stated the housekeepers are supposed to place items in a lost and found bin and log it, however, this was not done. The employees were cooperative with police but uncooperative with the guest.

On Sunday, August 5th, 2023, at 4:20pm, Officer Thomas KRESA and I, squad 6240, were dispatched to 4488 S 27th St in the City of Milwaukee to take a lost/or stolen complaint.

Upon arrival, I spoke to the caller, Sharron M. BUIE, b/m, 01-10-67. Sharron is from Madison conducting business in Milwaukee. Sharron stated he could not find his wallet and believes someone took it without his consent. He stated he left the hotel at 9:00am and went to Walmart to do some shopping. He stated he took his wallet with him and returned at 10:00am where he noticed it missing. He stated he checked all over his hotel room but could not find it.

Sharron described his wallet as a coach brand, tan in color and has a zippered area for coins. inside where several credit/debit cards and various pieces of identifications.

Sharron stated he went to his bank to cancel the credit cards. The bank informed him that someone used the credit card (US Bank Debit Card) at Mcdonald (27th and ColdSpring) at 9:02am, AutoZone (3700blk S 27th St) at 9:45am; and Walmart (3500blk S 27th St) at 9:45am. These stores are near the hotel with Mcdonalds being the closest. This timeline would mean Sharron lost his wallet sometime before he left to go shopping.

Sharron stated the bank was able to cancel his other credit cards and with this case incident report, reimburse him for his loss.

The hotel has functional surveillance video but no were situated where Sharron parked his vehicle. A check of the lot showed no suspicious activity on the property. No other violations were observed at this time.

There have been no other calls for service found since the beginning of the year for this location.

Officers supplied Sharron with a Crime Victim's resource Notice (PV-17).

Officers then went to the above locations to check for video. Autozone and McDonalds had no video surveillance. The Walmart store is still pending.

This case remains open.

Upon arrival, at the listed location at 10:32 PM, P.O. TONER and I were met by caller/later identified as victim/hotel employee; Lakshmana S. PASUPULETI (A/M, 01-26-1997) who stated on today's date (01-30-2024) at 10:10 PM, while working at the front desk an unknown suspect demanded money and his cell phone while armed, PASUPULETI gave the following description for the Suspect 1:

- B/M, 5'00, SLIM BUILD, WEARING A BLACK IN COLOR PUFF WINTER JACKET WITH HOODED SWEATSHIRT UNDERNEATH - HOOD UP AROUND FACE, GREY SKI MASK COVERING NOSE AND MOUTH, BLACK PANTS, BLACK AND WHITE GLOVES, ARMED WITH A BLACK HANDGUN.

Suspect 1 walks into the business, speaks to PASUPULETI for several minutes. PASUPULETI can be seen giving Suspect 1 money from the register. Suspect 1 can be seen continuing to speak to PASUPULETI. PASUPULETI is observed unplugging the computer monitors then handling Suspect 1 his cell phone. Suspect 1 exits the business at approximately 10:10PM then reenters briefly. Suspect 1 exits again and drops a business card from Quality Inn, which he was holding. Suspect 1 is seen dropping a black item near his passenger side front tire. Suspect 1 is then seen picking up the item before driving away.

While on scene, I observed the licenses posted and they were up to date.
