The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/23/2002 the applicant was arrested by Milwaukee Police Department for Battery -Domestic Violence. No Further Information Available

2. On 01/01/2005 at 12:55 AM officers responded to the licensed premises at 1339 W Greenfield Av. La Carreta Vieja regarding a Battery Complaint. Investigation revealed that a patron, who was intoxicated, punched a security guard who had escorted the patron out of the tavern. The patron was still on the scene and causing a disturbance. The patron was cited for Battery and

Disorderly Conduct. Incident Report Filed.

- 3. On 05/27/06 at 2:27 am, Milwaukee Police were dispatched to a shooting at 1339 W Greenfield. Investigation revealed that three tavern patrons were shot outside of the bar and were lying on the sidewalk. Once officers secured the scene and located witnesses, officers attempted to gain entry into the tavern and found the doors locked and unable to locate the owner/bartenders of the tavern. Officers eventually found the owner, Abel Santos, who was uncooperative and refused to let officers inside the tavern. A few hours after the shooting, Santos agreed to open the door for officers. The shooting resulted in four people shot with one homicide. On 05-28-06, Milwaukee Police conducted follow up regarding this shooting and spoke with Abel Santos. Santos allowed officers to view surveillance video regarding the homicide, which showed the suspects were patrons in the tavern and that the homicide occurred while the patrons were leaving the tavern. When asked why Santos took so long to make contact with police, he stated he wasn't aware that a shooting took place outside his tavern due to the "walls surrounding the building."
- 4. On 12/13/06 the applicant was cited in the City of Milwaukee for a Building Code Violation at 1325 W. Greenfield Ave.

- 5. On 10/27/07 at 2:42am, officers were dispatched to 14th and Greenfield and interviewed a man who stated he was at the bar at 1339 W. Greenfield. While in the bar he was approached by a woman Theresa Northern, who asked him if he would pay her for sex or a blowjob. When he declined an argument ensued, and the woman struck him in the mouth. The woman was cited for Assault and Battery and Soliciting.
- 6. On 01/14/08 at 10:15pm, officers were dispatched to a fight at 14th and Greenfield. According to the CAD, the caller stated one of his security guards was at the bar and requesting emergency back up for a fight. Officers went into the bar at 1339 W. Greenfield and spoke with the bartender who stated there was no fight. Officers located two patrons who are security guards for the bar, but were off duty. One of the security guards indicated a phone call he made to his boss moments earlier may have been miscommunication that they were involved in a fight. The security guard stated that he called his boss on his cell phone and made a joke that he and another co-worker were going to La Carreta Vieja and that they would need some backup because of the fights that occur at the bar. Officers found no evidence of a fight.
- 7. On 01/20/08 at 2:17am, officers were dispatched regarding at tavern violation at 1339 W. Greenfield Ave. The complaint was that there were juveniles entering the bar and drug dealing going on in the bathroom. Officers found no violations. Officers spoke with the applicant (Santos) who was on scene. Santos stated that he denied entry to a person and believes that that person called the police.

8. On 01/25/08 at 11:39pm, officers were dispatched to a subject with a gun inside the bar at 1339 W. Greenfield Ave. The named subject Juan J. Cerda, also had a valid warrant for Homicide. The business was checked and Cerda was not there. No tavern violations were found.

- 9. On 10/19/08 at 2:06 am, Milwaukee police were dispatched to 1339 W Greenfield Avenue for a Subject With Weapon complaint. Upon arrival, officers were met by the caller and her mother who told police that the owner of La Carreta tavern, Abel Santos, had pepper sprayed them while they were inside the tavern. The victim admitted a fight had started in the tavern right before this occurred, but that they were not involved. Officers then entered the tavern and spoke to security officer Ronelle Schuster who stated a fight did break out in the dance floor with security attempting to break up the fight. Schuster admitted to using pepper spray one of the subjects involved. Police spoke to Abel Santos regarding the incident. Officers also spoke to Santos regarding patrons illegally parking their cars due to road construction. Santos said he was aware of the parking and told his customers to legally park but that they refused to. When asked why he didn't call police regarding, Santos was more concerned about a police report being filed regarding the parking troubles. As officers were leaving the tavern, they were approached by several subjects who wished to remain anonymous but told officers that every Friday and Saturday night the tavern allows underage people into the tavern, for a fee, through the back door.
- 10. On 12/13/08 at 11:13 pm, Milwaukee police were dispatched to 1339 W Greenfield for an Entry to An Auto complaint. Investigation found an intoxicated subject was refusing to leave the tavern. He was removed by security earlier in the night but the subject kept returning. The subject then entered an auto that did not belong to him. Police were called and removed the subject with no citations being issued.
- 11. On 01/31/09 at 8:25 pm, Milwaukee police were dispatched to 1339 W Greenfield Avenue for a Trouble With Subjects complaint. Investigation revealed two subjects tried to enter the tavern but were denied entry. The actors got made and began causing damage to autos that were parked on the street. The owner of one of the autos damaged confronted these subjects who then began hitting and punching the victim. Security officer Daniel Vasquez observed the beating and used pepper spray on both suspects. Police were called and while attempting to gain information as to what occurred, one suspect made threats "to get" the victim. Citations were issued for Disorderly Conduct, Assault & Battery and Vandalism. Another citation for Consumption of Alcohol by a Minor was issued after one of the suspects admitted to drinking a bottle of Tequila with his friends earlier that night. No tavern violations were found.
- 12. On 02/28/09 at 1:10 am, Milwaukee police were dispatched to 1339 W Greenfield for a Property Damage complaint. Officers spoke security officer Rebbecca Schroeder who stated she escorted three patrons from the bar earlier in the night for being disorderly. She stated they later returned and broke out the windows on her personal vehicle. These subjects were later arrested and issued citations for vandalism. No tavern violations were observed.

13. On 12/14/09 at 12:40 am, Milwaukee police were dispatched to 14th and Greenfield for a Shots Fired complaint. Investigation revealed some patrons from La Carreta Vieja were fighting and someone broke a beer bottle in the tavern. The call of shots fired was made baseless and the call was advised.

14. On 03/13/11 at 6:28 pm, Milwaukee police were dispatched to 13th and Greenfield for a Fight complaint. Police spoke to a victim who stated he was assaulted in the bar. Police observed the victim to have a laceration above his right eye. The victim was conveyed to a nearby hospital by ambulance where he received 11 stitches to close the wound. Police identified the bartender as Norma Gamez-Gutierrez and found that the bar does have video but that it did not face the area of where the fight took place. The suspect was later found and arrested for substantial battery.

- 15. On 10/29/12 at 1:50 am, Milwaukee police were dispatched to 1339 W Greenfield for a Reckless Endangering Safety. Police spoke to Bryan Shepard who is head of security for La Carreta Vieja. Shepard told police that two patrons who were inside the bar became disorderly and were escorted out of the bar. Shepard further stated that the patrons became aggressive towards the owner and Shepard because they were removed from the bar. Shepard stated that at one point, one subject appeared to "square off" with him and that he felt threatened and deployed his pepper spray on both subjects. One of the subjects then ran to his car and retrieved a golf club and made threats towards Shepard and other members of security, but that both subjects returned to the auto and left only to return shortly after and threaten security again. Shepard stated he then called for police. Both subjects were later located and found to be highly intoxicated. They were arrested and conveyed to the police district where they were cited and released.
- 16. On 12/08/12 at 1:23 am, Milwaukee police investigated a Battery complaint that occurred at 1339 W Greenfield. Officers spoke with the victim who stated he had injured his ankle during an incident while inside the bar. The victim was treated at a nearby hospital for a fractured fibula to his left ankle. Officers spoke to Bryan Shepard who was head of security and who stated he was aware of the incident that involved the victim and one of his security guards. Officers spoke with the security guard who was involved and identified him as Rafael Chaidez. Chaidez stated that the victim was harassing a female patron and that the female patron pushed the victim away from her, which caused the victim to fall into Chaidez. Chaidez stated he guided the victim away from him and this upset the victim. Chaidez stated that the victim then raised a glass beer bottle to him and that he physically took the victim down to the ground. The victim then was removed from the bar. Chaidez stated he did not know how the victim sustained an injury during the incident. Police attempted to view the incident on surveillance but found it did not capture it.

17. On 05/27/2013 at 12:45am Officers were flagged down by security at LaCarreta Vieja at 1339 W. Greenfield Av for a trouble with subject. The investigation revealed that security had recovered a white powder substance from in the bathroom on top of the urinal. The security was unable to determine who had placed the substance there. The powder did test positive for cocaine. The cocaine was recovered and inventoried.

- 18. On 06/01/2014 Milwaukee police conducted a licensed premise check at 1339 West Greenfield Avenue (La Carreta Vieja). During this check, the officer observed the emergency exit was locked and blocked by a table. The applicant was told he could not lock nor block the exit.
- 19. On 11/22/2014 Milwaukee police responded to a battery complaint at South 14th Street and West Greenfield Avenue. The victim, Adrian Ramirez, told officers that he had been at La Carreta Vieja bar when a fight broke out. Mr. Ramirez said he was not a part of the fight, but was hit in the back of the head with a bottle and then escorted out by security. The applicant was co-operative with officers during the investigation. Milwaukee police incident report #143260009 filed.
- 20. On 01/04/2015 Milwaukee police responded to a battery complaint at 1339 West Greenfield Avenue (La Carreta Vieja). Investigation revealed security for the business used pepper spray to de-escalate a fight inside the business between two patrons. Milwaukee police incident report #150040011 filed.
- 21. On 01/17/2015 Milwaukee police spoke to the applicant about obtaining video evidence regarding a shooting that occurred at a separate location. The victim of that incident had walked to the business after being injured. The applicant was co-operative and provided officers with a copy of video relevant to the incident. Milwaukee police incident report #150170020 filed.
- 22. On 01/20/2015 Milwaukee police responded to a battery complaint at 1339 West Greenfield Avenue (La Carreta Vieja). Investigation revealed the victim of this offense, Jose Carrasquillo, works as security for the business. Carrasquillo told officers that a patron pepper sprayed him as he was being escorted out of the bar for creating a disturbance. Milwaukee police incident report #150210141 filed.
- 23. On 01/23/2015 Milwaukee police responded to an injured/sick person complaint at 1339 West Greenfield Avenue (La Carreta Vieja). A security guard for the business, Shawn Folck, told officers there had been a fight inside the business around 12:50am. In an attempt to deescalate the situation, Mr. Folck deployed pepper spray. Milwaukee police incident report #150230009 filed.
- 24. On 01/27/2015 the applicant met with Milwaukee police regarding the number of calls for service and aldermanic complaints at 1339 West Greenfield Avenue (La Carreta Vieja). Officers explained that the property was eligible to receive nuisance status based on a review of the calls for service. The applicant told officers he did not recall two of the incidents officers discussed, but he was aware of several incidents in which security used pepper spray to disperse patrons and break up fights. The applicant indicated he had met with his staff and told them not to use pepper spray so frequently to deal with disorderly patrons and that he would be submitting a written course of action. The applicant was told that he would be receiving a Notice of Mandatory Retail Establishment Security Measures Letter in the mail.
- 25. On 02/17/2015 the applicant, along with his attorney Vincent Bobot, met with Milwaukee police officers and Assistant City Attorney DeSiato to discuss the abatement plan for the property at 1339 West Greenfield Avenue (La Carreta Vieja). Each point of the abatement plan was discussed and the applicant was advised that all points of the abatement plan had to be implemented within 45 days. Additionally, the applicant was advised that if problems at the bar continued, a new abatement plan would be required. The applicant was advised to contact members of the Milwaukee police Community Prosecution Unit with any questions.

- 26. On 06/14/2015 Milwaukee police responded to a battery complaint at 1339 West Greenfield Avenue. Investigation revealed a patron of the bar pushed a security guard down some stairs as the security guard was escorting the patron out of the business. The patron was cited for disorderly conduct.
- 27. On 12/03/2015 Milwaukee police responded to a shooting at the intersection of South 14th Street and West Greenfield Avenue. The incident occurred at 1339 West Greenfield Avenue (La Carreta Vieja). The applicant told officers that several people were fighting and arguing inside the tavern. As he attempted to help security officers escort them out, a subject punched the applicant in the face. Once outside, the group of people was so out of control, that the applicant used pepper spray. Officers did not discover a shooting victim and no weapons were recovered. The subject that punched the applicant was cited for assault and battery.
- 28. On 02/26/2016 at 12:56am officers were dispatched to S. 11th St and W. Burnham St for a shooting complaint. The officers found the victim and found there was not a shooting but a battery complaint. The victim was uncooperative but did state he was at La Carreta Vieja Bar, 1339 W. Greenfield Av, with his sister who got into a fight. The victim attempted to intervene and was battered by unknown actors. The officers attempted to go to the bar to investigate but it was closed. The officers went back at 8:13pm and spoke with the applicant. He stated the subject was in the bar and was highly intoxicated. He had security escorted him out and the subject fell down the stairs. The applicant went to help and the subject punched him. He reacted and punched him back causing the subject to fall to the ground. When security attempted to help him up he became combative. The applicant advised security to leave the subject alone for their safety. The applicant showed the officer the security footage which confirmed his story. Milwaukee Police Department IR#16-057-0008 filed.
- 29. On 09/05/2016 at 1:06am an officer was dispatched to a trouble with subject call at 1339 W. Greenfield Av. The officer spoke with security who stated a subject had been in the business causing a disturbance and began yelling profanities outside. The subject had left in a car prior to the officer's arrival. The applicant was on scene and cooperative.
- 30. On 02/03/2017 at 8:17pm an officer conducted a business check on La Carreta Vieja Bar, 1339 W. Greenfield Av. No violations were observed.

- 31. On 04/23/2017 at 11:45pm officers were dispatched to 1339 W. Greenfield Av for a battery complaint. A security guard stated he was attempting to kick out a subject who took a boxing stance causing another guard to "pepper spray" the subject. The subject then made threats to come back and shoot up the establishment. The officer cited the subject and took him home.
- 32.On 05/22/2017 at 12:05am officers were dispatched to 1339 W. Greenfield Av for a battery complaint. The security guard stated there was a fight inside the bar and while he was breaking it up one of the patrons punched him in the nose. The subject was kicked out and left without further incident. The bar was cooperative with the investigation.
- 33. On 08/05/2017 at 2:15am officers were dispatched to 1339 W. Greenfield Av for a battery complaint. The applicant was on scene and stated security detained a subject who battered another patron. The subject had been released prior to the officers arrival. The officers could not locate the victim or suspect.

34. On 08/17/2017 officers were dispatched to St Luke's hospital to investigate a shooting. The investigation revealed the two victims had been patrons of La Carreta Vieja, 1339 W. Greenfield Av from 08/16/2017 through closing time. After they left they were travelling in a car Eastbound on W. Greenfield Av when the occupants of another car shot at least 19 rounds into the victim's car. Both victims were struck and required medical attention. Both victims are 20 years of age. The applicant was interviewed on 08/17/2018 and admitted the victims were in the bar prior to the shooting and left without incident. He was cooperative with the investigation and provided video surveillance. The applicant was cited for Allow Underage on Premise.

- 35. On 02/02/2018 at 2:10am officers were dispatched to St Luke's Hospital to investigate a battery complaint that occurred at 1339 W. Greenfield Av. The victim had been pepper sprayed but was too intoxicated to make a statement. Officers went to La Carreta Vieja, 1339 W. Greenfield Av, but the bar was closed. On 02/02/2018 at 8:30pm officers went to the bar to follow up. They spoke with the applicant who stated there was a group of four people in the bar breaking bottles and causing a disturbance. When the lone security guard attempted to kick out the subjects one of the party lunged at guard causing him to use his OC spray. The subjects then left the scene. The applicant was cooperative with the investigation stating he did not call the police because the subjects left.
- 36. On 02/19/2018 at 9:23pm officers were dispatched to 1339 W. Greenfield Av for a battery complaint. The security guard was attempting to kick out an intoxicated subject who punched him and then the subject left the scene. The security guard stated if the subject is identified he would like to prosecute. On 02/21/2018 officers conducted a tavern check at La Carreta Vieja regarding the battery. The applicant was on scene and cooperative.

- 37. On 03/23/2018 officer, along with agents from the WI Department of Revenue, conducted a licensed premise check at La Carreta Vieja, 1339 W. Greenfield Av. The agent seized 9 bottles of alcohol purchased from a store and not at a distributor. The applicant was advised to keep his invoices on site for 2 years.
- 38. On 04/02/2018 at 1:58am officers observed MFD treating an injured person in front of 1339 W. Greenfield Av. The investigation revealed the subject was intoxicated and fell down the stairs when he was leaving the establishment. The subject was conveyed to the hospital for observation. No violations were observed in the tavern.
- 39. On 08/25/2018 at 12:43am officers investigated a subject with gun complaint at 1339 W. Greenfield Av. The caller, Nenette DAVILA, told the officer that she observed a subject get a gun out of his trunk and place it in his waistband. The subject then threatened to shoot everyone. The subject was on scene and resisted the officers when they attempted to arrest him.

- 40. On 01/25/2019 at 11:15pm officers were dispatched to a battery complaint at La Carreta Vieja, 1339 W. Greenfield Av. The caller was security guard, Ninette DAVILA, who stated there was a subject that was inside the bar intoxicated and they were asking her to leave when the subject dropped to the floor. As staff attempted to get her out she kicked the bartender in the leg. The subject also caused an injury to DAVILA'S hand. The subject was conveyed to the station and cited for the incident.
- 41. On 03/17/2019 at 10:34pm officers were dispatched to a battery complaint at La Carreta Vieja, 1339 W. Greenfield Av. Security stated there was an intoxicated subject they were escorting out that started to fight with them. The subject attempted to bite one of the security guards but he stated he was not injured. The applicant was on scene and cooperative, no tavern violations observed.
- 42. On 04/01/2019 at 1:44am officers were dispatched to a subject with gun complaint at La Carreta Vieja, 1339 W. Greenfield Av. Security stated there was a disorderly patron inside that they kicked out. While outside the subject pulled a gun out of her backpack and pointed it at the applicant threatening to shoot him. The subject was arrested and the gun was found to be a BB gun. The applicant was on scene and cooperative. No tavern violations were observed.

- 43. On 05/07/2019 a meeting was held at District 2 regarding La Carreta Vieja, 1339 W. Greenfield Av. The applicant stated that the problem patrons have been coming to his bar after already being intoxicated. He stated he has security at all entrances and would only keep one entrance open after Midnight to prevent intoxicated patrons from entering. He also stated he would have additional training for his bartenders to prevent over serving patrons. On 05/13/2019 officers went to the location and performed a CPTED. The applicant stated he has 70 cameras covering the interior and exterior. The officers advised to have the cameras cover the dance floor in order to see who the trouble patron are. The applicant stated he would reposition cameras to cover that area.
- 44. On 11/24/2019 at 2:55am officers were dispatched to 1339 W. Greenfield Av for an accident. The officer interviewed a security guard who stated a subject, who was kicked out of the bar for being intoxicated, attempted to run her down with his car. The subject missed the security guard but struck the building. The subject was arrested for OWI and RES.
- 45. On 01/21/2020 at 10:47am officers were dispatched to a Subject with Gun complaint at 1339 W. Greenfield Av. The security guard stated a subject came in the bar, produced a firearm and threatened him. The applicant was on scene and provided video of the incident. The video showed the subject approached security and turn around when he observed security conducting pat downs. The subject went out to his car and returned and was patted down. The subject entered and met up with his friends. The applicant stated at no time did he see a gun and was not threatened.
- 46. On 03/01/2020 at 8:25pm officers were dispatched to 1339 W. Greenfield Av for a Subject with Gun complaint. The investigation revealed there was a verbal altercation inside that went outside in front of the business. One of the parties got in a car and pulled up and fired a shot at a group of people outside. The auto then drove off. No victim was located. The officers spoke with the applicant who stated he was playing pool inside. He was aware of the altercation outside and heard one gun shot. On Tuesday, May 7, 2019 at 9:00 a.m., Captain Alexander Ramirez. A.C.A Heather HOUGH, Sergeant Chad RADEN, P.O. Oscar ESPITIA and I met with the licensee of La Carreta Vieja, located at 1339 W Greenfield Av, Abel SANTOS and his attorney at District Two to discuss previous incidents that had occurred at the premises.

The meeting began with a summary of events that occurred at the premises. On 4/1/2019 officers went to a subject with gun call at the above location and on 1/25/19 officers went to a battery complaint.

SANTOS stated that those incidents occurred after the subjects were already intoxicated. SANTOS stated that those subjects had started the problem once already in his place of business at the time of entry they did not seem to be under the influence of alcohol.

Captain RAMIREZ explained that the police department is obligated to respond to complaints made by citizens, and he (Captain RAMIREZ) wants to see businesses succeed in the district but that they must be run in a responsible manner.

It was explained to SANTOS that most people are out at different locations, might already have a few drinks in their system and get over served at his locations to the point that may cause a disturbance at his place of business.

SANTOS stated that he has security at both the front and side door entrances and also at the second floor entry. SANTOS stated that people who come to his place of business are already intoxicated and start problems at his business. SANTOS also stated that he has over 70 cameras around his place of business and has worked with police in the past by giving video recording of incidents that had occurred in the area.

SANTOS explained that he's aware of the possibilities of people being at the line of being intoxicated and stated that he will make sure his staff goes through extra training on when not to over serve the patrons. SANTOS stated that he will also have one main entrance after midnight to help control the patrons that come in and out of his business.

On Monday, May 13, 2019 at 12:55 p.m., Squad 2468, (P.O. Oscar PICENO) and I met with SANTOS at 1339 W Greenfield Av for a CEPTED/Investigation.

Upon arrival I spoke with SANTOS who showed both PICENO and I were his cameras were located inside and outside the premise. SANTOS stated that after midnight he was going to have only one entrance and exit from the premise to help control the crowd that goes in and out his place of business. SANTOS showed up the upper area of the premise.

At the time I asked SANTOS if he had camera surveillance to oversee the dance floor. I explained to SANTOS that if a fight or any other trouble with person happened to occur on the dance floor, he would be able to see who his trouble person(s) are.

SANTOS stated that he did not think about having a camera facing the dance floor, but was willing to move a camera that pointed to a corner to point to the dance floor to make sure he secure that area

Upon arrival I was met by the security guard identified as Roberto C. ROLEN-OTERO W/M 08/06/1996. ROLEN-OTERO stated that a Hispanic male came into the bar with a gun. ROLEN-OTERO stated that the subject showed him the gun. ROLEN-OTERO stated that he made threats to the bar owner and other patrons inside the bar.

I then spoke with the bar owner who was identified as Abel SANTOS W/M 07/30/1968. SANTOS stated that he never saw a gun and never had any threats made to him. SANTOS showed us security footage of the incident.

Footage of the incident showed that the subject entered the bar to get patted down. Everyone who enters the bar after 10 P.M. gets patted down. The subject was about to get patted down when he looked at his friend. The subject then grabbed car keys and headed out to his vehicle. The subject shortly returned and got patted down by security. Security did not find anything on the subject and the subject entered the bar. The subject and his friend made contact with two people at the bar but was not arguing with them. The subject and the individuals at the bar in fact did a cheers with each other. Shortly after that the subject left the bar with his friend and did not return. It appeared like no gun was over shown and no threats were ever made. Security guard stated that he patted down the subject and saw and felt a gun in the subjects back waist band. Footage showed the security guard not patting down the subject. The subject left to his vehicle and came back. Subject with a gun was found to be baseless and all parties were advised.

After the investigation we did a license premises check which revealed the occupancy license and class B license was not publicly displayed. The licenses were behind the waitress station in the rear of the establishment. SANTOS stated that he would hang them up immediately.

On Sunday, March 1st, 2020 at 8:25 PM while assigned to Squad 2565, PO Carissa SANCHEZ and I, were dispatched to La Carreta Vieja, 1339 W. Greenfield Ave, for a subject with gun complaint to assist the investigating squad 2224, PO Zachary BURCZYK and PO Jordan FRYER.

PO FRYER located three subjects involved in a verbal altercation leading to an unknown female subject discharging a firearm into a crowd of citizens outside of La Carreta Veija. The patrons were identified as Miguel A. ROBLES (W/M, 08-27-1980) and Michelle L. SENDEJO (W/F, 10-09-1983). The armed security guard, identified as Luis DELMORAL-RIVERA (W/M, 02-10-1971), was interviewed by PO FRYER who stated an unknown female and two unknown males came into the business and got into an altercation with the victim ROBLES, and his girlfriend SENDEJO. DELMORAL-RIVERA stated the altercation escalated and went out onto the sidewalk in front of the business. DELMORAL-RIVERA stated the unknown female and males got into a Blue Toyota Corolla bearing WI license plate 47073DS. DELMORAL-RIVERA stated as the car was pulling away the driver rolled down the passenger side window, intentionally and without consent displayed a firearm and fired one shot towards a group of people standing outside of the listed business. DEMORAL-RIVERA stated the listed car then fled westbound on W Greenfield Av. DELMORAL-RIVERA stated he did not see anyone of anyone get hit by the shot that was fired. No casing was discovered on scene. DEMORAL-RIVERA stated the driver of the vehicle was the unknown female.

PO John PARLIER watched the video, and obtained a copy of the video. I was advised that the video showed an argument outside of the tavern between ROBLES, SENDEJO, and two unknown subjects. The

video showed the two unknown subjects get into the blue Toyota Corolla, and stop next to ROBLES, SENDEJO, and DELMORAL-RIVERA who were standing on the south east corner of 1400 W. DELMORAL-RIVERA did draw his firearm on video, but never appeared to discharge his weapon. PARLIER placed a copy of the video onto MPD Inventory #20007544.

I spoke with the owner of the tavern, identified as Abel SANTOS (W/M, 07-30-1968), who was on scene and cooperative with our investigation. SANTOS stated he was playing pool when the altercation occurred. SANTOS stated he was made aware of the altercation outside, and heard a single gun shot from outside. SANTOS had no further information to provide.

I spoke with the bartender and caller for this incident, identified as Karyme GAMEZ-VERDUGO (W/F, 05-26-1999), who stated she was in the back portion of the bar serving. GAMEZ-VERDUGO stated she did not see the altercation, but heard a single gun shot from outside, and called the Police. GAMEZ-VERDUGO had no further information to provide.

I spoke with a witness on scene, identified as Guillermo RODRIGUEZ (W/M, 12-22-1989), who stated he was inside eating. RODRIGUEZ stated he saw a verbal altercation between the above listed subjects. RODRIGUEZ stated he observed ROBLES reach into his vehicle for what RODRIGUEZ believed was a firearm, but he never observed a firearm. RODRIGUEZ stated that he then observed a blue four door sedan approach the victims to the incident, and he heard a single gunshot. RODRIGUEZ stated that he then saw the vehicle fleeing westbound on W. Greenfield Ave. RODRIGUEZ had no further information to provide.

A consent search was conducted on ROBLES' vehicle by PO BURCZYK and no evidence of firearms was located.

No tavern violations were observed.
