Angie,

We do not regulate the painting of previously painted surfaces. Overall we regulate changes to the exterior of the property which includes landscaping and windows, amongst other things. The concrete work will need to be approved, but is likely to be approved quickly as long as you are not changing the alignment and width of what is existing. You can even switch to permeable pavers if you wish.

I have attached some informational brochures and the application form to this message. Please also note that if you are not in an exceptional hurry on repairing this property, expenses over \$50,000 on the building (including mechanicals and infrastructure, but not landscaping and paving) are eligible for significant tax credits from the State of Wisconsin if the work is approved by them in advance.
