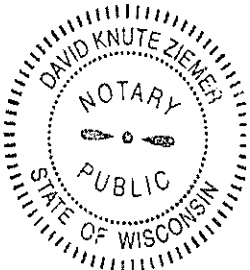

**090216...** A substitute ordinance relating to a change in zoning from General Planned Development to a Detailed Planned Development known as Shiloh Manor, for a 45-unit housing development for seniors, on land located

East of North Dr. Martin Luther King Jr. Drive and South of West Keefe Avenue, in the 6th Aldermanic District.

**090428...** A substitute ordinance relating to vacant building registration and requirements.

**090445...** A substitute ordinance to further amend the 2009 rates of pay of offices and positions in the City Service.
