Good morning,

I hope your Friday is going well! My name is _____ a recent visitor to your lovely city who is in town for a brief period for a wedding. When I arrived, I hailed a cab and attempted to discuss a payment agreement for getting to Thiensville from the airport. He brushed me aside a bit in terms of the specifics and waved things away, I'll be honest with you I have been up since 5:00 in the morning and was extremely tired at that point from traveling all day. The gist of the conversation was that he would match a ride share price to get there. At the time, that was between 50 to \$60. I tried to be more specific but he sort of waved it away and said he would turn on his meter later. Which in hindsight should have been a blazing red flag.

He was perfectly nice on the drive there, But when we arrived, everything went really bad really fast. He said let me go ahead and check what the Uber price is, and I did the same on my phone to confirm. However, while I pulled up an Uber price, he opened his gallery on his phone and pulled up a screenshot that he had had there for a while (I would be astounded if it was within the same day) quoting a premium Uber price for a black or XL of over \$110.

Clearly a big issue here, at this point I'm pretty sick deprived and right by the wedding group so I don't want to cause a huge hassle. I talk him down to \$85 eventually much to his protest, and go along with my evening joining the wedding party.

The next day, I go through my statements to realize that I had been charged at least \$20 over what I had agreed to. At this point I had a good amount of sleep under my belt and was able to put together the events of the previous day and realized that I not only was defrauded in terms of the actual charge to my card, the entire situation was extremely shady at best.

I would like to file a complaint against this driver. Well I have filed a dispute on my credit card for the 20 or so dollars of difference between what I agreed to and what was charged, I want to see if there's any other rectification that can be had with this driver, since I was charged well over what any reasonable person would have agreed to. I feel taken advantage of and since I was only in town for a couple days he thought I was an easy mark. His name is Mohammad, he drives for Royal taxi (or, at least, that is the name of the entity that charged my card). Unfortunately, I did not have the wherewithal to take a picture of a license plate number, city license number or anything else of the like. However, he asked me to text him his The address that I had requested. His phone number is 414-600-3444.
