You are hereby notified that the Milwaukee Common Council will hold a hearing on Tuesday, February 6, 2024 commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider whether to renew, renew with a suspension between 10 and 90 days, or not renew your Class B Tavern, Public Entertainment Premises and Food Dealer licenses for the premises located at 3535 W Villard Av. ("Uptown Bar and Grill").


