COMMITMENT TO COMMUNITY

I have assisted the Milwaukee community for years in numerous civic endeavors. Currently, I serve on the board of the Westtown Association and as the chairperson of its Community & Economic Development Committee. In that role, I have been a leader in Westtown's successful efforts to create design guidelines that will help to promote high quality new construction and redevelopment projects downtown west of the Milwaukee River. This process has been a painstaking effort over the course of nearly four years; but along the way we have developed a strong consensus among developers, property owners and managers, architects, planners, builders, retailers and residents---creating a broad acceptance of the final product.

From 1997 to 2006, I was an active board member, committee chairperson, Vice President and later President of the Milwaukee Christian Center, Inc. I still serve as volunteer legal counsel to MCC today. MCC provides day care services, after school programs for children and teens, fellowship, nutritious lunches and basic health maintenance for the elderly, programs to help immigrants work their way into the American mainstream, emergency food and crisis management services for families in need, graffiti removal for businesses and residents, and home improvement services to allow disabled and elderly residents to maintain their independence at home.

As a board member of Walkers Point Development Corporation from 1987 to 1998 (and as its President for over five of those years), I worked on a daily basis with a dedicated staff that made WPDC one of the most effective organizations in the City in restoring and reselling residential and commercial buildings and assisting working class families to achieve their dream of home ownership. During the same period of time, I also served on the board (and as President for over six years) of the grass roots, all volunteer, Jackson Park Neighborhood Association. JPNA serves as a united voice for residents' concerns regarding traffic, zoning, crime and other issues and sponsors quality of life projects such as an annual nighttime trick-or-treating event, Easter egg hunt, and holiday tree lighting ceremony.
