Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is being typed by Police Officer Jonathan CRUZ assigned to District Three Community Partnership Unit.

On Tuesday August 27th, 2024, at approximately 9:30am, While on Squad 3274, I assisted DNS Inspector Jenrich on a DNS inspection for 3443 W. Wells the business One Stop Only.

During the inspections DNS inspector JENRICH had a couple minor DNS violations and would be placing orders.

Upon my inspection of the business, I located a tray of single individual cigarettes near the cashier stand. There was 3 trays of Wrigley's Double mint with 18 loose cigarettes.

I asked the cashier identified as Mohamad KABU NISEM (W/M 05-21-03) who stated that he has been employed at the location for 5 years. NISEM stated he sells single cigarettes and that is how it had been. I educated NISEM that you cannot sell individual "Loosey" cigarettes, and he discarded the cigarettes. I notified NISEM that I would be contacting the owner, and a citation may be mailed regarding the selling of loose cigarette.

The owner of the business identified as Haitham M. ABUNIJEM (I/M 01-08-77) stopped into the district and showed the district front desk my community contact card. (PER LIRA NOT THE AGENT OF THIS BUSINESS)

P.O. KING and I spoke to ABUNIJEM regarding the DNS inspection and the loose cigarette. ABUNIJEM wanted it to be known that the location does not sell any beer or alcohol. ABUNIJEM stated that he occasionally sells the loose cigarette to older people or individuals that try to fight about buying a whole package. I notified ABUNIJEM that he cannot do that and that may also be the reason why there are panhandlers and loiters because the can buy cheap things at the location.

I notified ABUNIJEM that since I did not see a sale and the cashier was honest and discarded the loose cigarettes, I would give him a warning regarding and I would do random business check regarding. ABUNIJEM stated that there would no longer be the sale of any loose cigarette at the location.

This location is not a designated nuisance premise

On Monday December 16, 2024, at approximately 10:40am, Squad 3245 (PO Isaac KING and I) were dispatched to a robbery at the address of 3443 W. Wells St which is located in the City and County of Milwaukee, Wisconsin.

### Scene Description

Upon arriving on the scene, I observed the store on the south side of W. Wells St with the address of above listed address posted above the door to enter the store. I observed multiple subjects exiting the store. I did not observe any vehicles parked outside the store upon arrival.

Upon arriving on scene, I spoke with the victim identified as Davion T. WILLIAMS (B/M, 7/13/2001). WILLIAMS stated on Monday December 16, 2024, at approximately 10:16am he was battered by suspects listed below while they attempted to take his clothing and belongings.

Suspect 1: B/F, 28-29 years old, wearing a pink clothing, and a hair wrap.

Suspect 2: B/M, approximately 5'8-5'9, 28-29 years old, wearing a brown flannel coat and brown pants.

Suspect 3: B/M, approximately 6'0, with dreads, wearing all black

Suspect 4: Hispanic Male, approximately 5'8, wearing a white t-shirt

WILLIAMS stated Suspect 1 approached him and demanded all his clothing and belongings. WILLIAMS stated after he refused, Suspects 1-4 battered him intentionally and without consent causing pain and injury. I observed a large contusion on WILLIAMS's forehead. WILLIAMS stated all suspects were unable to steal his clothing or belongings. WILLIAMS stated suspects fled in an unknown direction once they observed the police were being called.

WILLIAMS stated this incident occurred due to an altercation that occurred in September of 2023 when he observed a fight between suspect 1 and WILLIAM's brother later identified as Daylin NASH (B/M, 1/1/2006). It should be noted WILLIAMS stated Suspect 1 is a relative of NASH, but he only knows her as "Princess". WILLIAMS stated suspect one is upset with him due to him not giving her NASH'S name and location. I asked WILLIAMS was he involved in any prior altercations with suspects that would cause retaliation. WILLIAMS stated he has been living in Chicago the past year and only returned to take care of his mother who resides in the area at 533 N 33rd street in the City and County of Milwaukee.

I spoke with acting Lt. Sgt. FREDRICKS who informed me that CIB will not be responding.

#### Witness Interview

I interviewed the witness and employee at the store identified as Haitham M. ABUNIJEM (W/M, 1/8/1977) who was able to provide surveillance video of the incident. ABUNIJEM stated 3 suspects were attacking and beating up on WILLIAMS. ABUNIJEM stated he tried to break up the fight between WILLIAMS and the 3 suspects. After breaking up the fight, ABUNIJEM stated he then called police to report the incident.

#### **Surveillance Video Observations**

In this video, I observed the victim inside the store when Suspect 1 and Suspect 2 entered the store and got into a verbal altercation with WILLIAMS. I observed Suspect 1 then strike WILLIAMS. During this verbal altercation, WILLIAMS attempts to leave the store, but it stopped and kept inside the store by the two suspects and another two suspects enter the store. Three of the four suspects then attacked WILLIAMS attempting to take his clothing and belongings while punching and kicking WILLIAMS. The suspects were not able to take WILLIAMS clothing and belongings. ABUNIJEM is seen going to break up the fight. The incident ends when the suspects fled the scene eastbound on Wells St in a white KIA Sportage SUV. This video has been sent in via community request and uploaded to evidence.com.

## Miscellaneous

P. O King took 9 photos of WILLIAMS injuries and the scene. P.O KING and I changed locations to the 2300 block of West State Street to locate the suspects but was unsuccessful. Follow up will be conducted to speak with NASH to locate suspects information to conduct a photo array with WILLIAMS.



Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
