Dear Ms. Wallace:

We have received your claim in the amount of \$1,093.14, relating to damage to your vehicle from a loss on May 5, 2017.

The Fleet Division of DPW investigated and determined that the City truck signaled and pulled over to the left lane, in a work zone, with warning lights flashing. It began to back up. You pulled into the work zone, then began to pass the truck on the right and made contact with it. The liability for this accident is upon you. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
