We have received your claim for the amount of \$350.00 in relation to the property damage you sustained on May 20, 2017 at 2414 North 46th Street.

Our investigation determined the Milwaukee Police Department was in pursuit of a hit and run suspect for an accident that occurred near 2325 North 45th Street. The suspect fled on foot through neighboring yards, including your residence on North 46th Street. The suspect was then apprehended in the 4600 block of West Meinecke Avenue.

The damage to your property was caused while police were attempting to subdue a suspect who resisted being taken into custody. Since the police were not negligent and were acting within the sphere of their responsibility, the City of Milwaukee would not be liable. Accordingly, we are denying your claim.
