Dear Mr. Bishop:

We have received your claim in the amount of \$1,150.00, relating to damage to your driveway that allegedly occurred in 1995 when sidewalk blocks near your home at 1824 West Courtland Avenue were replaced by the City of Milwaukee.

Our investigation reveals that this claim was filed on July 13, 2007. Wisconsin Statute §893.80 (1) (a) requires that a claim must be filed within 120 days after the happening of the event given rise to the claim, as such this claim was not filed timely. In addition, the alleged damages occurred in 1995 and due to the passage of time there is no way to properly investigate this situation. Since there is no proof to support your belief the City caused your loss, it cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
