
This office is in receipt of your claim on behalf of your client in the amount of \$50,000.00, relating to injuries and property damage sustained by your client on November 8, 2001 when a City truck allegedly collided with her vehicle at West North Avenue and North 33rd Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report and the Fleet Accident Report completed as a result of this accident note that the City truck was making a right turn and that your client attempted to squeeze in between the curb and the right side of the truck and also make a right turn and made contact with the City truck. The liability for this accident is upon your client. As such, the City cannot accept liability for the loss. Accordingly, we are denying your client's claim.
