..Title

Substitute motion relating to the locations of various Milwaukee County Transit System bus stops.

..Analysis

This motion eliminates existing Milwaukee County Transit System bus stops at various locations throughout the city. It also authorizes the Milwaukee County Transit System to establish new bus stops at various locations throughout the city.

..Body

It is moved, By the Common Council of the City of Milwaukee, that the Milwaukee County Transit System bus stops at the following locations are eliminated:

1. On the west side of North 6<sup>th</sup> Street at West Wisconsin Avenue (northwest corner of intersection).
2. On the west side of North Old World Third Street at West State Street (northwest corner of intersection).
3. On the north side of West Greenfield Avenue at South 22<sup>nd</sup> Street (northeast corner of intersection).
4. On the east side of South 60<sup>th</sup> Street approximately 550 feet south of the south right-of-way line of West Oklahoma Avenue.
5. On the west side of South 60<sup>th</sup> Street approximately 600 feet south of the south right-of-way line of West Oklahoma Avenue.
6. On the north side of West Wisconsin Avenue at North 46<sup>th</sup> Street (northeast corner of intersection).
7. On the north side of West Vliet Street at North 60<sup>th</sup> Street (northeast corner of intersection).
8. On the north side of West Vliet Street at North Hawley Road (northeast corner of intersection).
9. On the south side of West Vliet Street at North 54<sup>th</sup> Street (southwest corner of intersection).

10. On the north side of West Vliet Street at North 50<sup>th</sup> Place (northwest corner of intersection).
11. On the south side of West Vliet Street at North 43<sup>rd</sup> Street (southwest corner of intersection).
12. On the east side of North Sherman Boulevard approximately 130 feet north of the north right-of-way line of West Roosevelt Drive.
13. On the east side of North 91<sup>st</sup> Street at 7036 North 91<sup>st</sup> Street.
14. On the west side of North Halyard Street at West Garfield Avenue (northwest corner of intersection).

; and

It is further moved, that the Milwaukee County Transit System is authorized to establish new bus stops at the following locations:

1. On the west side of North 6<sup>th</sup> Street, starting approximately 170 feet north of the north right-of-way line of West Wisconsin Avenue and just north of the southerly east-west alley in the block bounded by West Wells Street, West Wisconsin Avenue, North 6<sup>th</sup> Street and North James Lovell Street, and extending northward approximately 80 feet.
2. On the west side of North Old World Third Street, starting at the south right-of-way line of West State Street and extending southward approximately 80 feet.
3. On the east side of North James Lovell Street, starting at the south right-of-way line of West State Street and extending southward approximately 80 feet.
4. On the south side of West State Street, starting at the west right-of-way line of North James Lovell Street and extending westward approximately 80 feet.
5. On the west side of South 76<sup>th</sup> Street at the intersection of the north right-of-way line of West Honey Creek Drive (extended) and the west right-of-way line of South 76<sup>th</sup> Street and extending northward approximately 80 feet.
6. On the south side of West Vliet Street at the intersection of the east right-of-way line of North 54<sup>th</sup> Street and extending eastward approximately 80 feet.
7. On the north side of West Vliet Street at the intersection of the west right-of-way line of North 50<sup>th</sup> Place and extending westward approximately 80 feet.
8. On the south side of West Vliet Street at the intersection of the east right-of-way line of North 43<sup>rd</sup> Street and extending eastward approximately 80 feet.

9. On the east side of North Sherman Boulevard, starting approximately 140 feet north of the north right-of-way line of West Roosevelt Drive and extending northward approximately 80 feet.

10. On the east side of North 91<sup>st</sup> Street at the intersection of the south right-of-way line of West Rochelle Avenue and extending southward approximately 80 feet.

11. On the west side of North Halyard Street at the intersection of the south right-of-way line of West Garfield Avenue and extending southward approximately 80 feet.
