Upon completion of the City's staff review, this request will be scheduled before the Street Naming Committee. All owners/residents along this street affected by the proposed honorary street name will be notified of the meeting and this is their opportunity to indicate their support or opposition to the honorary street name request. The committee will then make its recommendation to the Public Works Committee (PW). A deposit to cover the City's cost to install and/or fabricate the honorary street signs must be made before this request can be scheduled before the PW Committee. The PW Committee will make their recommendation to the Common Council. The applicant will be notified of the Common Council's action.

Dr. Joe L. Hughes was married to the love of his life, the late Dr. Lucy B. Hughes for 59 years. 56 of those years were spent in ministry where they have served the body of Christ and the City of Milwaukee. At the age of 78 years young, Dr. Joe L. Hughes is determined to continue the legacy of bettering the lives of people however he can.



When he first started Pastoral ship there were several young men who came to the fellowship without a natural father in their home life as a role model so he became a role model for them. He showed them how to obtain and keep a job, respect for authority, the proper dress, , how to carry themselves and take care of their families. A lot of them had dropped out of school but he encouraged them to finish with some going on to college. With a wife and six children he would often tell them "follow me as I follow Christ". Many of those men today hold respectful positions in the community and others have dedicated their lives to serving people locally and abroad.

He also is a great supporter of woman pushing them to achieve spiritual & business goals and educational dreams of becoming anything they set their mind to. Dr. Janie Washington, one of the most prominent doctors in the City of Milwaukee, is a 'daughter' of Dr's. Joe & Lucy Hughes. They encouraged her to follow her dream of becoming a doctor at a very early age. She credits a great deal of her success to their continued support and encouragement.
