Subject: Common Council Resolution File Number 021701

Dear Honorable Members:

The subject resolution authorizing and directing the City Clerk to issue a special privilege permit to Richard Kopeschka of This Week! Publications to install and maintain ten (10) newspaper vending boxes within the City of Milwaukee has been reviewed by the Department of Public Works.

The requested locations are as follows:

1. Southwest corner of South 84th Street and West Oklahoma Avenue
2. Southeast corner of South 92nd Street and West Howard Avenue
3. Southwest corner of South 76th Street and West Morgan Avenue
4. Southwest corner of South 20th Street and West Layton Avenue
5. Corner of South 31st Street and West Grange Avenue
6. Southeast corner of South 35th Street and West Oklahoma Avenue
7. Southeast corner of South 13th Street and West Harrison Avenue
8. Zillman Park 2172 South Kinnickinnic Avenue
9. Triangle at East Lincoln Avenue and South Kinnickinnic Avenue
10. Southwest corner of West Loomis Road and Point Road

The Department of Public Works reviewed the requested locations and has the following comments.

Location No. 1, southwest corner of South 84th Street and West Oklahoma Avenue is in the 11th Aldermanic District. Alderman Dudzik has expressed concern over the abundance of newspaper boxes dispensing free papers in his district, therefore, this request is not recommended for approval.

Location No. 2, the southeast corner of South 92nd Street and West Howard Avenue is located in the City of Greenfield and is, therefore, denied.

Location No. 6, southeast corner of South 35th Street and West Oklahoma Avenue is in the 11th Aldermanic District. Alderman Dudzik has expressed concern over the abundance of newspaper boxes dispensing free papers, therefore, this request is not recommended for approval.

Location No. 5, corner of South 31st Street and West Grange Avenue is located in the City of Greenfield and is, therefore, denied;

Location No. 8, Zillman Park 2172 South Kinnickinnic Avenue, located in the 14th Aldermanic District is opposed by Alderwoman Suzanne Breier and is, therefore, not recommended for approval.

Location No. 9, triangle in the intersection of East Lincoln Avenue at South Kinnickinnic Avenue, located in the 14th Aldermanic District is opposed by Alderwoman Suzanne Breier and is, therefore, not recommended for approval.

Location No. 10, southwest corner of West Loomis Road and Point Road is in the 11th Aldermanic District. Alderman Dudzik has expressed concern over the abundance of newspaper boxes dispensing free papers, therefore, this request is not recommended for approval.

The Department of Public Works has no objection to the placement of boxes at locations identified as No. 4 and No. 7 above.
