PLEASE NOTE: This hearing relates to the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet of the subject site.

PERSON OF INTEREST:

The Common Council has referred File No. 250522 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Industrial Light, IL2, to Industrial Mixed, IM, to allow a multi-family residential development on the property located at 1435 South 1st Street, on the northwest corner of South 1st Street and West Orchard Street, in the 12th Aldermanic District.

This currently vacant site is owned by Rockwell Automation. Bear Development intends to purchase the site and has requested to change the zoning to Industrial Mixed (IM) to allow the construction of a 5-story, 69-unit residential building with indoor vehicle and bicycle parking. While specific development plans are not part of this file, the building design and placement will be required to comply with the IM zoning design standards. **Please refer to the reverse side of this notice for map details.**
